**CONDITIONS OF BOND**

That, \_\_\_\_\_, as principal being bound to the State of Texas by Conditions contained in the aforementioned bond, and to relinquish all fees and expenses that may be incurred in the event the following Conditions of Bond are violated:

The defendant shall serve his/her present Bond on Electronic Leg Monitoring in compliance with Article 17.43 and/or 17.44 of the Texas Code of Criminal Procedure.

- ( A ) Beginning \_\_\_\_\_ and until released by the court, participate in the BOND/ELM program and as participant therein, remain at the monitored residence at all times except during approved work/school hours or at other times approved in advance by the Court and/or the Supervision Officer. Report in person weekly, or as directed to the Supervision Officer. Comply with all rules and regulations of BOND/ELM Program.
- ( B ) Pay a per day fee to cover all equipment rental costs. Payments are to be made directly to the contract monitoring company.
- ( C ) Defendant shall be held in jail and released only to proceed directly to the BOND/ELM office on the day he/she is to attend orientation and be connected to the Electronic Monitoring Equipment (orientation begins promptly at 12:30 pm Monday thru Friday).
- ( D ) \_\_\_\_\_ Consume **NO** alcohol. Submit to deep lung breath analysis thru a home Alcohol Breath Device to determine the use of Alcohol. Pay the total cost for such deep lung breath analysis directly to the contract monitoring company.
- ( E ) \_\_\_\_\_ Ingest **NO** illicit drugs. Submit a non-diluted random urine sample, at the request of the Supervising Officer, within one business day of the request, to determine the use of illicit drugs. Pay the total costs of such urinalysis directly to a testing facility approved by the court.
- ( F ) \_\_\_\_\_ Do **NOT** have any form of contact, be it in person, by mail, telephone, or any other form of communication with \_\_\_\_\_ directly or indirectly, for the duration of the Supervision Term.
