
#### Grant Summary

Dallas County is committed to receiving grant funds to expand and improve departments' programs to serve residents within the county. From the Sheriff's department to our Health & Human Services, departments utilize grants to provide a solution to a need for our community. In addition, Dallas County disburse funds to nonprofits and other entities to provide needed services. For FY2023, Dallas County has received a total of \$ 336,402,640 from grants to create a thriving community.

From the FY2023 grant total, Dallas County has used \$7,868,083 for cash match. A cash match is the direct project expense that Dallas County provide to projects. Dallas County uses cash match as a contribution to projects and program supported by grans.


Dallas County has also been intentional in providing economic support through federal funds provided through the American Rescue Plan provided by the Biden Administration through the pandemic. Dallas County American Rescue Plan grant funding totaled \$511 million. The county received \$255 million in May 2021 and spent \$111 million on mental health services for residents, \$35 million on infrastructure, \$20 million on efforts to mitigate negative economic impacts of COVID-19 and \$110 million on community programs like nonprofit investments, rehabilitation homes and programs to mitigate homelessness in Dallas County. The remaining \$255 million was delivered in May 2022. All \$511 million will need to be spent by 2024. Approved use of the funding includes response to public health emergencies, recovering from economic impacts of COVID-19, governmental use to recover from revenue loss, helping essential workers and infrastructure.

Dallas County has been able to create a number of program centered around emergency business assistance, non-profit assistance, and rental assistance for residents located throughout the County. Recognizing the impact of a suffering economy through the pandemic, Dallas County also invested in employees by providing a retention bonus for all full-time and part-time employees.
