

# Dallas Area Partnership to End and Prevent Homelessness Meeting Minutes April 6, 2023

**To retain outside counsel** – observation has been made that there are individual attorneys representing Dallas County and City of Dallas, but this partnership does not have legal representation. Ms. Lucky provided a recommendation to Councilmember Casey Thomas II. Dr. Cerise asked what the issues are requiring legal counsel. Commissioner Dr. Theresa Daniel stated that one of the items is exploring changes in the bylaws.

   Ashley Marshall stated that information that will be missing is the number of students that are coded as homeless because the homeless definition is different from HUD's.

- Public Education and Housing Availability Kin Oldham stated this committee is still viable.
