Dallas County Behavioral Health Leadership Team Meeting Notes Thursday, July 14, 2016

Welcome and Call to Order

The meeting was called to order by Commissioner John Wiley Price at 9:34 AM.

Review/Approval of Minutes

The minutes from the BHLT meeting held on June 14, 2016 were included in the meeting packet. Commissioner Price announced that Dr. Burruss sent a name (Steven A. Cohen) change to be made on page 6. Doug Denton also stated that he did not comment on the next round table and that the announcement was made by Vickie Rice. The committee approved the minutes with the modifications.

Introductions and Absent BHLT Members:

Commissioner Price welcomed the team and announced that Chief Seals and Janie Metzinger were attending the funeral of one of the fallen officers. Tom Collins and Larry Locklear were also not in attendance; however, Mr. Locklear sent his information about STAR Kids.

NTBHA Indigent Services Plan and Updates:

Ron Stretcher stated that the NTBHA team will not be in attendance as they are out working on RFPs. Mr. Stretcher also stated that they have received contract proposals back for outpatient treatment for mental health and in/out patient substance abuse services. Commissioner Price asked if they received robust number submissions. Mr. Stretcher stated that the submissions were robust and they have covered everything we have going except for opiate treatment and will need to do a separate procurement for those services. There needs to be more discussions regarding the Medically Assisted Treatment (MAT) and the opioid treatment programs (OTPs) which combine behavioral therapy and medications to treat substance abuse. All core partners (services) contracts have been submitted for Metrocare, Lakes Regional MHMR Ctr., Child and Family Guidance and Centro de Mi Salud.

Commissioner Price stated that he and Commissioner Daniel have been vetting Parkland's budget and wanted to know how many providers are being impacted by 340B. The purpose of the 340B program is to reduce the price of outpatient prescriptions and over the counter drugs to covered entities including federally qualified health centers and disproportionate share hospitals. Parkland is being impacted by the pharmacy about \$40 million in increase and by 340B about \$12 million. Commissioner Price would like for the providers to look at the 340B to see how it is impacting them. Commissioner Price stated that 340B program is currently used to offset the jail medications. Mr. Stretcher stated that 340B is a huge issue for NTBHA because a few of the things that they need to do such as manage the Indigent Pharmacy, secure a Pharmacy Benefit Manager (PBM) and reach out to the Managed Care Organizations (MCO's). John Quattrin, CCO/CFO of Beacon Health Options advised that VO/Beacon Health transitioned away from it because the process flow penetration was not sufficient. They also found that the prescriptions were being filled outside of the program. Beacon Health transitioned away from 340B in August of 2014 and in January 2015 they looked at a pricing model. Mr. Quattrin suggested we look at a pricing model first that incorporate, PBMs so that pharmacy spends remain constant. During the NTHBA board meeting, the Pharmaceutical Sponsored Patient Assistance program (PAP) was discussed. PAP relies on pharmaceutical manufacturers to help serve indigent populations. PAP is sponsored by pharmaceutical manufacturers who

provide eligible patients with brand name prescription medications at a low cost based on income qualifications. Mr. Quatrine stated that they have not pursued it as of today. Initially they were trying to increase access to provider clinics and other pharmacists such as Kroger and Wal-Mart throughout the NorthSTAR area.

Stepping Up Initiative Update/Caruth Grant:

Mr. Stretcher stated that The Caruth staff was not in attendance due to the team working on their application. Commissioner Price presented Resolution (07-2016) to the BHLT committee for approval. Mr. Stretcher moved the resolution and Doug Denton seconded. This resolution shows the support and participation with Meadows Mental Health Policy Institute (MMHPI) from the Commissioner Court in the Caruth Smart Justice Implementation Grant to include providing coordination, resources, and a letter of support for the grant application.

Behavioral Health Housing Work Group (BHHWG) Update:

Commissioner Dr. Theresa Daniel stated the work group continues to look at housing possibilities. The BHHWG has a few things going on and are continuing to try to build partnerships in the community. Commissioner Daniel alerted the committee that the City of Dallas along with the Housing Committee is almost ready to approve a housing plan. Commissioner Daniel stated BHHWG will be sending a letter of support on which18 different individuals has signed their endorsement. BHHWG continues to work on educating the community on housing and how it affects our community and the jail population. Also, the City of Dallas was awarded \$2.6 million dollars for the Healthy Communities Collaborative Grant from the state and is partnering with local agencies to spend the funding. The city has 12 months to spend the funding; however, the biggest challenge for agencies is securing a private cash match.

Commissioner Price asked that BHHWG bring back to the committee the number of Forcible Entry and Detainer (FEDs) filed. A FED is an action that a landlord, or new property owner can take if the existing occupant refuses to leave after appropriate notice. Mr. Stretcher and Commissioner Daniel stated that they would be willing to take on that work. Commissioner Price stated that evictions stay on a resident's record and, from that point, they are unable to secure future housing. He also has reached out to the courts and the Dallas County Constables Office because residents are being pushed out of housing and the numbers continue to grow. Mr. Stretcher stated he is aware of this issue and believes the Justice of the Peace Office can help determine the number of FEDs filled. Commissioner Price stated we have reinstated (reentry from incarceration) citizens that can't get housing and can't live with anyone receiving housing assistance. After some additional discussion on the matter, Commissioner Daniel stated that she has been in discussion with Maryann Russ, President and CEO of the Dallas Housing Authority. Her concern is the number of people they lose or evaporate from the DHA system.

- Cottages: Commissioner Daniel stated that they have taken a tour and things seem to be moving along. Mr. Stretcher stated that they are really close and the delay in the opening of the Cottages will be worth the wait. The staff is currently working on client engagements and is close to being fully staffed. Commissioner Daniel asked if they have been able to keep up and identify individuals from the homeless camps. Mr. Stretcher advised that we have a pretty fluid group that is moving in and out of the jail however, they have a handle on it.
- Mayor's Commission on Homelessness: Mr. Stretcher advised that the Commission did not have
 their full meeting, due to the memorial service. The Commission did hold a work session which is
 organized around different workgroups. Mr. Stretcher stated that he chairs the Homeless
 Prevention and Discharge Planning subcommittee and Jay Dunn, President and CEO of the Bridge,
 chairs the Shelters and Related Services subcommittee.

1115 Waiver Crisis Services Project (CSP) Update:

Charlene Randolph stated that the monthly reports had been provided to the committee and was located on pages 13-19. CSP continues to meet its monthly service goals and they served 508 unique consumers during the month of May, which exceeds its monthly service goal of 450. There was a connection rate of 86% of the forensic clients being discharged from Terrell within 30 days. The next demonstration year (DY6) for 1115 Waiver projects begin Oct 1, 2016. Currently, HHSC is asking all projects to state their

intentions on continuing with their projects. Dallas County has already indicated to HHSC that it will continue its projects into DY6. For DY6, the 1115 Waiver projects will be valued at the DY5 level. The CSP project has a DY5 valuation of approximately \$6 million dollars when combining Category 1 and Category 3 matched funding. Moving forward projects will no longer need to report on the process metrics (i.e. bi-weekly meetings) as those metrics will go away. For DY6 the focus will be serving unique clients, reporting how many individuals served were low income and eligible for Medicaid, Category 3 outcome measures, and establishing a sustainable plan.

NorthSTAR Update

- NTBHA Update: There was no update given.
- ValueOptions NorthSTAR Update: John Quattrin, Beacon Value Options stated that throughout the rest of the year VO will continue to make themselves available to community providers. Value Options is in possession of their letter from the state which came in since the last meeting. This letter is documenting that the program is targeted to end at the end of this calendar year. VO has been asked to produce a run out plan which ends in 2017. Mr. Quattrin stated that he will continue to make himself available to DSHS and NTBHA. Commissioner Price and Commissioner Daniel thanked Mr. Quattrin for his due diligence and continued support.
- **State Advisory Committees:** There was no update given.

Funding Opportunities:

- **SAMSHA Grant Update**: Laura Edmonds reported that they continue to move forward and currently have 20 participants in the program and the goal is to send 36 women to Nexus.
- Community Courts Grant Update (Public Defender's Office): Lynn Richardson with the Public Defender's Office reported that they are moving forward with the grant and it has been briefed for the County Judge to sign. Commissioner Daniel asked what changes they expected to make with the grant. Mrs. Richardson stated that they expect to provide better services to persons needing mental health and substance abuse treatment. They also plan to get citizens more engaged with what is happening in their community. The Public Defender's Office have had local business owners step up and offer to hire their clients and the Community Courts program has also had continued support from law enforcement. Commissioner Price asked if there was a publication of best practices in regards to this court and has it been approved. Commissioner Price and Commissioner Daniel would like to know who has gone to the trainings and what the results are for the Specialty Courts. Commissioner Daniel also questioned if there was a regular reporting responsibility. Mrs. Richardson stated that there was not a reporting responsibility; however, the state is going to start auditing Specialty Courts, and programs who are found to not follow best practices will not continue to receive funding. After some continued discussion on Specialty Courts, Mr. Stretcher stated that Dr. Fabelo and Caruth will be working with CSCD to do a study on Specialty Court outcomes, cost benefit, and how the courts should be supported.

Public Comments:

Vickie Rice of the Public Defender's Office gave kudos to Dr. Burruss and Dallas Metrocare for the presentation on mental health diagnosis which was given on July 8th. The August round table will be centered on city programs (Skip's Court, South Dallas Drug Court, VA Court). There will be Opiate Epidemic Training on September 22, 2016 for a cost of \$25. Mrs. Rice stated she would send the flyer with the information to Nakish for distribution. Judge Wade acknowledged that the 530 fund committee approved funding slots for individuals to attend this training.

Carmen White, Asst. District Attorney, stated that they are 6 months in on the SET program and are doing well with the help of Mrs. Lynn Richardson, Judge Wade, and Mrs. Rice. They can now increase their number to 50 with the additional staff coming and hope to have a graduation in September.

Commissioner Daniel reported that she and Germaine White will be attending a NACO Conference in Los Angles, California and meeting with the LA County Director of Mental Health Services. Commissioner

Daniel reported that Los Angeles County has the largest mental health facility in the country which is also known as their county jail.

Dr. Celeste Johnson stated that the American Psychiatric Nurses Association was asked to develop an educational material on opiates for 3.4 million nurses across the US and it should be available in September. Commissioner Price asked if Parkland was still on divert and Dr. Johnson stated yes; however, patients are still being brought into the hospital.

Norma Westurn with Centro de Mi Salud stated that they were now accepting adult patients and not just adolescents.

Joe Powell announced the Big Texas Rally for Recovery on October 2, 2016.

Selena Hammon with Dallas Behavioral Hospital announced that they will having an open house on August 12 and she will send the information to Nakish for distribution.

Community Stakeholder Project Status Update - August 2016

The Caruth Smart Justice Planning Grant Phase II Proposal was submitted to the W.W. Caruth, Jr. Foundation at the Communities Foundation of Texas on July 15, 2016, with a presentation to the Caruth board scheduled for September 2016. Notification of acceptance and funding will follow the presentation to the W. W. Caruth, Jr. Foundation at the Communities Foundation of Texas' Board.

Should funding be awarded, the Meadows Mental Health Policy Institute (MMHPI) and its partners will begin implementation in January 2017 to align with and support the North Texas Behavioral Health Authority (NTBHA) transition. We continue to engage local and state philanthropists, including the Arnold Foundation and other agencies, to seek funding matches to help support the Caruth Smart Justice implementation efforts. Additionally, we continue to seek the support of local hospital providers to help bridge the gap between the public behavioral health, criminal justice, and private health care systems.

Intercept 1 (Law Enforcement)

In July 2016, key Intercept I stakeholders met to begin creating a timeline for implementation. MMHPI staff plans to provide technical assistance for the process while stakeholders with Dallas Fire and Rescue and the Dallas Police Department will work on programming and logistical challenges.

Intercept 2 (Initial Detention/Initial Court Hearings), Intercept 3 (Jails/Courts), and Intercept 4 (Re-Entry)

The Dallas County Criminal Justice work groups reconvened July 18, 2016. In this meeting, the groups were able to share their combined progress towards Intercept 2-4 goals and create a plan to move forward.

Intercept 5 (Community Corrections and Services)

In late June 2016, MMHPI hosted a meeting for Intercept 5 stakeholders and partners to share ideas on programming and implementation. A workgroup of stakeholders will be formed in late August to continue this work.

Minutes of the Behavioral Health Steering Committee (BHSC) Meeting Friday, June 17. 2016

Call to order and Introductions

The meeting was called to order by Judge Wade at 8:40 am. Attendee's names are contained on the attached meeting sign-up sheet.

Minutes review and approval

The minutes from the last BHSC meeting of July 21, 2016 were reviewed. A motion was made by Alyssa Aldrich, and seconded for them to be accepted as read. Motion passed and minutes approved.

Data and reports for BHSC – Judge Wade

The program and outcome data, updates, and reports were presented and accepted for SAMHSA Grant, 530 Subcommittee, BHLT/CSP, Public Defenders, District Attorneys, Jail reports, Provider's reports (The Bridge, Metrocare, and IPS), and Problem Solving and Specialty Courts (see packet for details).

Laura Edmonds advised that the 530 Subcommittee balance is \$142,315. The subcommittee approved \$4440 to DIVERT Court for additional inpatient treatment. Additionally, the subcommittee approved funding of registration/mileage for 50 training slots to the Challenge Tarrant County on 9/22/16 in Hurst, Texas covering the opiate epidemic and MAT treatments. 6 staff has registered so far with a 7/30 deadline. A motion for BHSC approval of both of these actions was made by John Carlough, and seconded. The motion passed unanimously.

All other department and agency data reports and program updates were accepted as read, and can be reviewed in the mtg. packet.

Announcements

Judge Wade asked for announcements from the departments/agencies.

Enrique Morris of IPS advised they completed CMBHS re-integration in June. They are also piloting the HRS model through an external party. Additionally, due to the coming changes with NTHBA, they have completed the conversion of IPS to a 501 c3 non-profit. Staff changes: Michael Noss, M.D. has joined IPS and Transicare as medical director which will include overseeing medication management and interventions. Additionally, John Henry and Ashley Trudell have left the agency. Replacements are being hired and trained.

Metrocare advises that the Pathways Clinic is now closed, and all those patients have been relocated, mostly to Riverbend.

Judge Wade advised the Courts are now developing and will soon have expanded access to new cognitive BH programs like Thinking for a Change, as well as, Medication Assisted Treatment and Anger Management.

Kelly Kane of The Bridge advised that Jay Meaders is no longer the agency contact. She is the new contact and can be reached at 214-670-1507 and kkane@bridgenorthtexas.org

Judge Mays advised in the aftermath of the recent Dallas Police Shootings that MHA is reaching out and trying to provide assistance and collaboration to make trauma training/resources available. Commissioner Daniels and Rep. Toni Rose held a recent forum and discussed access to trauma informed training, resources and

assistance. Alyssa Aldrich advised that all ACS staff are trauma-informed trained and available on their crisis line.

Lynn Richardson advised that she has been selected to be on faculty for NADCP training coming up in Reno, NV to train prosecutors and defense attorneys. She also advised that all UNT law school sites have trauma training and services available.

Lastly, **Judge Mays** (<u>Specialty Courts</u>) will provide a summary and any resource documents for the recent Texas and National Drug Court Conferences.

Adjournment: The meeting was adjourned at 930 am. The next meeting will be held on Thursday, August 18th at 8:30 am.
