DALLAS COUNTY, TEXAS Minutes of the Behavioral Health Leadership Team Meeting Thursday, September 14th, 2023

Welcome and Call to Order

Commissioner John Wiley Price called the Behavioral Health Leadership Team (BHLT) meeting to order at 9:32 AM. Commissioner Price welcomed everyone and announced that the meeting was being recorded and those who continued in attendance were consenting to being recorded as a part of the open records.

The Commissioners present were Commissioners John Wiley Price and Dr. Theresa Daniel. Commissioner Price entertained a motion for opening the meeting. A motion was made by Commissioner Dr. Theresa Daniel and seconded by another participant. The motion was unanimously passed by the committee members.

Review/Approval of Minutes

The minutes of the BHLT meeting held on Thursday August 10, 2023, were included in the meeting packet. Commissioner Price offered an opportunity for the minutes to be reviewed and approved. The minutes were approved as submitted.

Introductions

Commissioner Price welcomed everyone to the meeting and asked first-time attendees to introduce themselves: First time attendees were:

Presentation: Dallas Housing Authority

Presenter: Troy Broussard, President & Chief Executive Officer, provided an organizational overview and presentation on Dallas Housing Authority. Mr. Broussard provided background on the performance of DHA over the past six years including annual awards from independent auditors and federal sponsoring agencies for "Financial Stewardship & Governance" and "Program Compliance and Performance". DHA currently serves 55,700 individuals. Of these individuals, 34% are seniors or persons with disabilities, 83% are female head of household, 87% are African American, with an average income of \$14,364 and average age of forty-nine. Mr. Broussard discussed access to the DHA's Public Housing and Housing Choice Voucher Programs, through a

fully electronic application process at www.dhantx.com, preapplications may be submitted 24/7, once complete, the applicant is placed on the waitlist of any of the 32 public properties they select. Based on vacancies and funding, DHA initiates a random lottery pull of applicants on that specific site. An applicant can either make an offer on a unit or is issued a voucher and families pay rent based on income, at 30% of adjusted income. DHA has operational jurisdiction in six other counties surrounding Dallas (Collin, Denton, Ellis, Kaufman, Rockwall, Tarrant) and applicants can choose housing units in these counties. An operational issue includes the increased per unit cost, with Dallas County ranking highest in percentage increase over the past five years causing fewer families being served with the funding provided. Mr. Broussard discussed DHAs Public Housing Lease Enforcement process which includes an applicants requirement to report change in income within 10 days of change, if rent is delinquent 30 days, a termination notice is sent to the applicant, the tenant then has the right to request a hearing and dispute rental amount based on changes in income and if eligible, may be granted repayment options if not, the landlord may follow normal court filing process for eviction. Mr. Broussard also provided an overview of DHA's newest facility in District 4, with 260 units for seniors, a healthcare clinic ran by Los Barrios will also be available on site, full occupancy is expected by early 2024. Lastly, Mr. Broussard discussed DHA's Opportunity Rising Scholarship Foundation (opportunityrisingfoundation.org/donate), that helps, "scholars living in DHA supported housing pursue their collegiate goals and attend the colleges of their choice providing scholarships, financial assistance, mentorship and other valuable opportunities to encourage lifelong learning."

North Texas Behavioral Health Authority (NTBHA) Update

Carol Lucky, Chief Executive Officer, NTBHA provided the update. Carol stated that Commissioner Dr. Elba Garcia is the new NTBHA Chair and Janis Burdett is now Vice-Chair. Ryan Brown remains the Treasurer and Sherry Sheffield is Secretary. Carol states that the state has committed by email regarding the state hospital contracts and NTBHA will be negotiating the details of that contract after the board votes on an emergency requisition. The state is giving \$14.6 million dollars a year (\$29 million biennium) to move individuals found incompetent to stand trial out of the jail and into private hospital with certain limitations. Carol states NTBHA also received \$248,000 a year for four years for a rural diversion program. NTBHA has also received an LMHA contract at \$139 million with a \$13 million match required, the SB 292 renewal for two years at \$3.4 million, and a \$3.4 million match required coming from the Dallas County, a substance use disorder contract for recovery and peer support services at \$400,000 with a \$20,000 match requirement, a Medication Assisted Treatment contract at \$24 million with no match required, an OSAR contract at \$358,000, a substance use treatment for women services at \$3.4 million and an MST contract at \$675,000 and no match required. NTBHA has approved their budget at \$134 million for FY24 compared to NTBHAs full year of operation in FY18 which was \$84 million showing tremendous growth and support. Carol and Vickie Rice (Public Defenders Office) provided an update on the mass release from jail last month. The Public Defender's Office and the District Attorney's Office worked together to provide appropriate dismissals of misdemeanor charges for those found incompetent to stand trial. NTBHA created individualized exit plans and worked with Transicare to release and pick up about 40 individuals from custody. Upon release, these individuals were provided care packages which included bus passes, gift cards, clothing, water, and snacks. These individuals were also provided transportation and connected to appropriate housing including shelters and boarding homes.

Meadows Mental Health Policy Institution (MMHPI)

Ron Stretcher, MMHPI, briefly stated there were no concerns at this time.

Doug Denton, Homeward Bound, provided an update on the Deflection Center and referred to the Deflection Center report in the supplemental packet. Doug states, last month, the Deflection Center had 44 admissions which set the record for the past year. Doug states the team recently presented information on the program to Carrollton Police Department and plan to reach out to Richardson, Garland and Mesquite Police Departments in the next month.

Dallas County Behavioral Health Housing Workgroup (BHHWG)

Commissioner Dr. Theresa Daniel provided the update. Dr. Daniel states the Housing Work Group is discussing transportation issues in the metroplex. Dr. Daniel states that the housing occupancy rate has increased by 2.4% which is about 2,448 additional individuals housed.

Dallas County Mental Health Advisory Committee Update

Yordanos Melake, Program Manager, Criminal Justice Department briefly reported that there are no issues currently and will provide additional updates in the October meeting.

Legislative Update

Janie Metzinger, Legislative Coordinator, NTBHA, provided the update via Teams and referred to the Legislative Updates in the meeting packet. Janie adds that the 87th Legislature added the Texas Child Mental Health Care Consortium which broadens the types of services that are available to families with children. Janie also highlights the increase in funding for state hospital construction from \$24 million in the 84th legislature to \$2.3 billion in the 88th. Lastly, Janie updated the committee on the passing of Emma Glen, President of NAMI Kaufman County and encouraged the committee to give condolences to the family.

BHLT Voting Membership Review Committee Update

Charlene Randolph, Director, Criminal Justice Department, provided the update. Charlene stated that the committee will be presenting their recommendations in the October BHLT meeting.

Funding Opportunities Updates

• Cottages Update

Charlene Randolph, Director, Criminal Justice Department, provided the update. Charlene referred to the Cottages report in the BHLT packet. Charlene highlights that case management services have resumed.

• SAMHSA Residential Treatment Grant Update

Marcus Turner, SAMHSA Grant Coordinator, Criminal Justice Department, provided the update. Marcus reports that SAMHSA has awarded Dallas County funding for the next five years.

• Community Courts Grant Update-Public Defender's Office (PD)

Vickie Rice, Public Defenders Office provided the update. Vickie referred to the BHLT packet for statistics on the Problem-Solving Courts.

• Restorative Justice Division-District Attorney's Office (RJD)

Julie Turnbull, Chief, Restorative Justice Division, District Attorney's Office, referred to the report in the BHLT packet and will provide further updates at next month's BHLT meeting.

Mission Statement: The Dallas County Behavioral Health Housing Work Group (DCBHWG), with diverse representation, will formulate recommendations on the creation of housing and housing related support services designed to safely divert members of special populations in crisis away from frequent utilization of expensive and sometimes unnecessary inpatient stays, emergency department visits and incarceration.

Success will be measured in placement of consumers in housing and the decreased utilization of higher levels of care (hospitals and emergency care visits) and reduced incarceration in the Dallas County Jail. The DCBHWG is committed to a data driven decision-making process with a focus on data supported outcomes.

Dr. Daniel opened the meeting and attendees introduced themselves. Dr. Daniel asked the new attendees representing Judge Demetria Denson and D.C. County Court of Law # 1 also known as the Backlog Court to give a brief explanation about the types of cases heard and handled within that court. It was explained that the court handles overflow cases from the Justice of the Peace Courts and they mainly hear eviction cases.

CALL TO ORDER: The minutes were approved with no changes.

GOVERNANCE

<u>Dallas Area Partnership to End and Prevent Homelessness:</u>

The Partnership is currently looking at the relationship between the City of Dallas and the county in the housing arena and the roles each entity plays within the partnership. On the side of Dallas County, there are currently 15 housing projects that ARPA funding has been invested in and are in process for approval by the County Commissioners. Currently 12 of the 15 different projects have been approved. Sustainability is also being explored and integrated into the projects as well.

Dallas County Homeless Advisory Committee:

Homeless Advisory committee met and there was discussion regarding the new Covid strain and Mpox and their effects on the homeless population. There was also a comprehensive update of the Health and Human Services department's Eviction Diversion Program (EDP) and where is stands with Covid funding and distribution. To date, \$1.7 million dollars has been obligated with 806 pre-eviction diversion interventions and 281 are approved/eligible for funding. There has been a total of 32,000 eviction cases filed and 1,800 diversions completed. Total funds obligated for both programs were \$13,392,000 and all funds have been obligated. This past August was the third highest month for eviction filings falling behind December 2022 and April 2023. There is also another Community First project in development in Ellis County which brings the total to three projects that are in process.

Federal and State Legislative Update: Janie Metzinger, NTBHA

Janie Metzinger stated in her reporting that she went back to the last five legislatures to track the behavioral health expenditures across state agencies and departments. In doing so, this created transparency of what is being spent on behavioral health. There have been some increases in funding for substance abuse services. With the success of different community based behavioral health programs, more grant funding has become available for communities to continue those projects to address behavioral health needs.

RESOURCES

<u>Shelter Discussions:</u> Daniel Roby, Austin Street Shelter

Daniel Roby was unavailable for the meeting and a report will be provided at the next meeting.

NTBHA: Eric McCarty, NTBHA

Eric McCarty was unavailable for the meeting and a report will be provided at the next meeting.

Housing Navigator: Kimberly Rawls, Dallas County

Kimberly Rawls stated the report is in the packet and the FUSE partners are working to reconstruct the program with a new program model and budget. They are about 95% complete with both the budget and model for any future funding opportunities. The number of clients served has decreased due to shelters being filled with decreased availability. The St. Jude project has one vacancy that they are working to get filled. The team is also working on the deliverables for the Bureau of Justice Assistance (BJA) to move forward with the procurement process for bidding. The goal is to begin the bidding process within the next couple of months. The Connector is running well on their end.

Homeless Jail Dashboard: Kimberly Rawls, Dallas County

Kimberly Rawls reported the jail data is available in the packet. The categories remain consistent from July to August for the unsheltered primary offenses. The criminal trespass category did see a decrease in 24 people and that may be attributed to the work being done at the Deflection Center. Laura Edmonds stated that there are some conversations regarding expanding the time the Deflection Center is operational and research is being conducted to determine if that option is viable.

Housing Authority Report: Thomas Lewis, Dallas County HHS

Thomas Lewis reported that as of today, they have met the contractual agreement with HUD and have issued the 124 emergency housing vouchers allocated with 119 housed and 5 searching. They are hopeful that within the next few months HUD will reallocate more housing vouchers to the department from other agencies that were not able to meet the requirements. A new venture is underway, and the housing authority is in partnership with Housing Forward to allocate 100 homeless vouchers beginning shortly and more information will come with that in the next couple of months.

CARES Act/ARPA Funds: Commissioner Daniel, Dallas County

Commissioner Daniel reported that all ARPA funds have been allocated, but not yet spent. Commissioner is questioning if funds that are not spent, will be they re-allocated, and is there a chance that the next few applications will be funded. A review and follow up is occurring regarding that.

PROJECTS AND INDUSTRY UPDATES

Housing Forward updates: David Gruber, Housing Forward

David Gruber reported that they finally received the Youth Homeless Demonstration Program Grant to help fight youth homelessness from HUD. They were awarded the highest amount of \$9.3 million which is 15% of the entire national award. This was due in huge part to the community investment in infrastructure and the system transformation. The Real Time Rehousing numbers show that through the end of September, over 2600 people have been housed with the goal being 2700 by the end of September. The numbers are proof that if the right systems are in place, the money is invested, and the work is put it, we can be successful.

Pretrial Diversion and Mental Health Screening: Laura Edmonds, Dallas County

Laura Edmonds reported that the Criminal Justice department is continuing to work with jail releases to help decrease the jail population. They have the first-time non-violent felony offender pre-trial diversion program and are doing assessments to identify what type of treatment is needed and to determine which jail diversion program is best suited for them. They were also awarded a \$1.3 million dollar grant over three years from the BJA to continue funding three of their existing staff and possibly adding one more assessor to keep up with the volume of assessments.

<u>Dallas Connector:</u> Daniel Roby, Austin Street

Daniel Roby was unavailable for the meeting and a report will be given at the next meeting.

Homeward Bound: Doug Denton, Homeward Bound

Doug Denton provided the year end report for the Deflection Center. In their crisis residential center, they have eighteen beds and have serviced a total of 310 clients for the year with NTHBA bringing in 57 clients and the Dallas Police Department being the largest referral source to date. Baylor Hospital Police and SMU police are the latest departments to bring clients to be serviced. There has been an increase in the amount of people they are having to refer to other resources due to them not being appropriate for their level of care. Overall, the program is continuing to grow fulfilling an important need in the county.

Youth Housing: Josh Cogan, A Way Home America

Josh Cogan was unavailable for the meeting and a report will be provided for the next meeting. David Gruber reported that Housing Forward received the Youth Homeless Demonstration Program grant and he spoke about the use of a Youth Action Board. He stated that having these boards are fundamental in helping homeless youth by listening to their input and experience. Their voices lend to the direction and integration the organization should be taking as it deals with youth homelessness.

Family Housing: Ellen Magnis, Family Gateway

Ellen Magnis was unavailable for the meeting. A report will be given at the next meeting.

Mattingly Report: Jim Mattingly, Lumacorp

Jim Mattingly reported that housing is still expensive even though prices within the Dallas/Fort Worth metroplex are coming down. Median home prices in the area are \$460,000. This price is a bargain in other places, and they are having to become creative and innovative with affordable housing. He reported that many factors contribute to the cost of housing including regulatory restrictions, geographic restrictions, and physical restrictions. Cities with vibrant economies have more expensive housing and a higher demand for housing due to the growth and influx of people moving into the city. We have the luxury of having more land and are able to build outward and are not as restricted as other places.

The meeting was adjourned with words of motivation by staying engaged and informed by Dr. Daniel.

118th US Congress

Bills Related to Behavioral Health

Status as of September 30, 2023

U.S. House of Representatives

HR 467-Griffith-Halt All Lethal Trafficking of Fentanyl Act. HALT Fentanyl Act. Amends Controlled Substances Act:

- Section 202(c) to classify fentanyl-related substances on Schedule I.
- Section 303 to add an alternative registration process for Schedule I research.
- Section 401(b)(1) to include fentanyl offense penalties.
- Directs the Attorney General to issue rules within six months of enactment.
- The HALT Fentanyl Act becomes effective on the date of enactment.

Current Status: Passed House 5-25-23. Sent to Senate, referred to Senate Judiciary Committee.

HR 472-Joyce-Fighting PTSD Act.

- Enumerates findings of Congress related to mental health needs of public safety officers, police officers, firefighters, emergency medical technicians and 911 dispatchers.
- Defines "Public Safety Officers" and "Public Safety Telecommunicators".
- Includes Tribal public safety officers.
- Requires the Director of the Office of Community Oriented Policing Services at the US Department of Justice to submit a report to Congress on:
 - o Programs to make state-of-the-art treatments or preventive care available to public safety officers and public safety telecommunicators for job-related PTSD or acute stress disorder.
 - o Access to evidence-based trauma-informed care, peer support, counseling services, family supports.
 - o Draft grant conditions to ensure confidentiality and efficiency.
 - o Estimates of annual appropriations needed for the proposed program.
 - o Consultation with relevant stakeholders.

<u>Current Status</u>: <u>HR 472</u>-Joyce-Referred to House Judiciary Committee 1-24-23.

<u>Companion</u>: <u>S 645</u>-Grassley-Passed Senate 3-2-23. Sent to House 3-7-23.

<u>HR 498</u>-Obernolte-The 9-8-8 Cybersecurity Responsibility Act. Would amend Public Health Service Act, Title V to secure the 9-8-8 suicide prevention lifeline from cybersecurity attacks.

<u>Current Status</u>: Reported favorably with amendment by E&C Committee 5-11-23.

Companion: S 1493-Sinema. Referred to Senate HELP.

HR 2577-Thompson-DHS Suicide Prevention and Resiliency for Law Enforcement Act.

Establishes the Law Enforcement Mental Health and Wellness Program within the US Department of Homeland Security for DHS agents.

<u>Current Status</u>: Referred to House Homeland Security Committee.

<u>Companion</u>: <u>S 1137</u>-Peters-Senate Committee Substitute favorably reported from Committee on Homeland Security and Governmental Affairs 5-17-23.

Title I-Public Health

- Section 101-Amends Public Health Service Act to delete reference to "surveillance" of infections associated with illicit drug use and other risk factors, and inserts the word "monitoring" instead. Extends the statute to 2028.
- Section 102-Amends Public Health Service Act to add evidence-based prevention grants that address the fentanyl crisis. Increases funding to \$505,579,000 per fiscal years 2024-2028.
- Section 103-Amends Public Health Service Act to raise funding for residential treatment programs for pregnant and postpartum women to \$38,931,000 per fiscal years 2024-2028.
- Section 104-Amends Public Health Service Act to increase funding for first responder training to \$56,000,000 per fiscal years 2024-2028.
- Section 105-Amends Public Health Service Act to increase funding for the Building Communities of Recovery Program to \$16,000,000 per fiscal years 2024-2028.
- Section 106-Amends Public Health Services Act to increase funding for the National Peer-Run Training and Technical Assistance Center for Addiction Recovery Support to \$2,000,000 per fiscal years 2024-2028.
- Section 107-Amends Public Health Service Act to reauthorize Comprehensive Opioid Recovery Centers through 2028.
 - Requires documentation for evidence of capacity to carry out required activities through a letter of intent or other relevant documentation from partner agencies whose primary purpose is the delivery of mental health or substance use disorder treatment services with which the applicant coordinates the full continuum of treatment services that the applicant is unable to deliver onsite.
 - o Allows Comprehensive Opioid Recovery Centers to carry out activities through referral or contractual agreements with third parties.
 - o Directs the US Secretary of Health and Human Services (HHS) to issue guidance on best practices.
- Section 108-Amends Public Health Services Act to increase funding for grants to address the challenges of persons who experience violence-related stress to \$93,887,000 per fiscal years 2024-2028.
- Section 109-Amends Public Health Services Act to extend Mental and Behavioral Health Education and Training Grants through 2028.
- Section 110-Amends Public Health Service Act to increase funding to \$40,000,000 per fiscal year 2024-2028.
- Section 111-Amends the SUPPORT for Patients and Communities Act to extend the pilot program for public health laboratories to detect fentanyl and other synthetic opioids through 2028.
- Section 112-Amends the SUPPORT for Patients and Communities Act to increase funding for monitoring and reporting of child, youth, and adult trauma to \$9,000,000 per fiscal year 2024-2028.
- Section 113-Amends the SUPPORT for Patients and Communities Act to add additional reports.
- Section 114-Amends the SUPPORT for Patients and Communities Act regarding grants to support
 individuals in substance use disorder treatment and recovery to live independently and participate in the
 workforce.
 - o Priority shall be based on the following rates in a State for the previous five years:
 - The average rate of drug overdose deaths in the State above the national average.
 - The unemployment rate in a State above the national average.
 - The labor participation rate in a State below the national average.

HR 4531-Guthrie-continued

- Allows grant fund to be used to provide participants with transportation to or from work, vocational education, job training, treatment or recovery services.
- o Increases funding to \$12,000,000 per fiscal years 2024-2028.
- Section 115-Amends the 21st Century Cures Act to allow fentanyl or xylazine test strips in grant programs for State and Tribal response to opioid use disorders.
- Section 116-Requires HHS to include any opioid overdose reversal agent authorized for use by the FDA in regulations, guidance or other documents for grants addressing opioid misuse and use disorders.
- Section 117-Amends the 21st Century Cures Act to allow grant recipients to use grant funds for other
 concurrent substance use disorders in addition to opioid or stimulant use or misuse disorders including
 alcohol or poly-drug use.
- Section 118-Requires the Comptroller General of the United States to conduct a study and submit a report to Congress on the use of remote monitoring of individuals who are prescribed opioids.

Title II-Controlled Substances

- Section 201-Amends the Controlled Substances Act regarding delivery of Schedule III, IV, or V by a pharmacy to an administering practitioner.
- Section 202-Regarding products containing a combination of Buprenorphine and Naloxone.
 - O Directs HHS to review relevant data pertaining the scheduling of products containing a combination of buprenorphine and naloxone that have been approved by the FDA.
 - o Directs the Attorney General to initiate rulemaking and to revise schedules if appropriate.
- Section 203-Combatting Illicit Xylazine
 - o Defines "Xylazine".
 - o Places Xylazine on Schedule III under the Controlled Substances Act,
 - Requires the Attorney General, through the DEA, in coordination with the FDA to submit a report
 to Congress on the prevalence and illicit use of Xylazine within one year, which shall be updated
 after four years.
- Section 204-Technical Corrections

Title III-Medicaid

- Section 301-Amends Section 1905 of the Social Security Act to extend the requirement for State Medicaid Plans to provide coverage for Medication-Assisted Treatment (MAT) by striking the original ending date of September 30, 2025. Adds a conforming amendment to the SUPPORT for Patients and Communities Act.
- Section 302-Amends the SUPPORT for Patients and Communities Act to expand required reports on T-MSIS Substance Use Disorder Data to include mental health condition data.
 - o Changes name from Substance Use Disorder Data Book to Behavioral Health Data Book.
 - o Changes SUD language to behavioral health language in statute.
- Section 303-Amends the Social Security Act Section 1902 to include in monitoring the prescribing of antipsychotic medications, individuals who are:
 - Over 18 years of age.
 - o Receiving home and community-based services.
 - Residing in institutional care settings, including nursing facilities and intermediate care facilities for individuals with intellectual disabilities.

Current Status: Favorably reported unanimously (49-0) by the House E&C Committee 7-19-23.

S 645-Grassley-Fighting PTSD Act.

- Enumerates findings of Congress related to mental health needs of public safety officers, police officers, firefighters, emergency medical technicians and 911 dispatchers.
- Defines Public Safety Officers and Public Safety Telecommunicator.
- Includes Tribal public safety officers.
- Requires the Director of the Office of Community Oriented Policing Services at the US Department of Justice to submit a report to Congress on:
 - o Programs to make state-of-the-art treatments or preventive care available to public safety officers and public safety telecommunicators for job-related PTSD or acute stress disorder.
 - o Access to evidence-based trauma-informed care, peer support, counseling services and family supports.
 - o Draft grant conditions to ensure confidentiality and efficiency.
 - o Estimates of annual appropriations needed for the proposed program.
 - o Consultation with relevant stakeholders.

Current Status: Passed Senate 3-2-23. Sent to House 3-7-23.

Companion: HR 472-Joyce-Referred to House Judiciary Committee 1-24-23.

S 1137-Peters-DHS Suicide Prevention and Resiliency for Law Enforcement Act.

Would establish the Law Enforcement Mental Health and Wellness Program within the US Department of Homeland Security for DHS agents.

<u>Current Status</u>: Senate Committee Substitute favorably reported from Committee on Homeland Security and Governmental Affairs 5-17-23.

<u>Companion</u>: <u>HR 2577</u>-Thompson-Referred to House Homeland Security Committee-Subcommittee on Oversight, Investigations, and Accountability.

<u>S 1493</u>-Sinema. 9-8-8 Cybersecurity Responsibility Act. Amends Public Health Service Act, Title V to secure the 9-8-8 suicide prevention lifeline from cybersecurity attacks.

Current Status: Referred to Senate HELP.

Companion: HR 498-Obernolte-Reported favorably with amendment by E&C 5-11-23.
