DALLAS COUNTY, TEXAS Minutes of the Behavioral Health Steering Committee (BHSC) Meeting Thursday, October 20, 2016

Call to order and Introductions

The meeting was called to order by Lynn Richardson at 8:35 am. 18 staff and providers in attendee with names available on the meeting sign-in sheet.

Minutes review and approval

The minutes from the last BHSC meeting of October 20, 2016 were reviewed. No discussion or corrections. A motion was made and seconded for them to be accepted as read. Motion passed and minutes approved without objection.

Caruth Grant: Mike Laughlin presented a Caruth Smart Justice Grant update and summary report. The 5-year, \$7 million Implementation Grant proposal submitted by MMHPI to the Caruth Foundation in July has been awarded 2 weeks ago. Mike provided a summary of the upcoming actions related to the award. Funding will happen sometime between now and January with the Court/Jail workgroups immediately beginning to break into smaller task implementation sub-teams to complete SOPs, forms, Court orders, space/staff preparations, modified resource allocations, training curriculums/plans, etc.

Data and reports for BHSC – Lynn Richardson

Program and Department Updates: The program and outcome data, updates, and reports were presented and accepted by relevant dept./agency staff for the SAMHSA Grant, 530 Subcommittee, BHLT/CSP, Public Defenders, District Attorneys, Jail reports, as well as the provider reports (The Bridge, Metrocare, and IPS), as well as Problem Solving and Specialty Courts (see packet for details).

Laura Edmonds presented a summary of current 530 Subcommittee expenses (see packet insert).

Additionally, reminder of new process and expenditures for drug testing and certification for some of the synthetic drugs continues to be available. However, a reminder was given that these are only to be available for Courts that are under the Specialty Courts grants from the Governor's office.

SAMHSA Grant updated by Laura Edmonds and despite delayed start we have done well to meet metrics, and are up to 10 referrals already in Year 2.

CSP stats and metrics were reviewed, and are exceeding year-to-date for outcomes with all other service goal metrics were met and DY 5 metrics will be reported to the State by end of this month. See packet pgs. 8-15 for details.

Charlene and CSP providers continue to communicate with NTHBA for Jan. 2017 transition planning since the care manager and Specialty Court Aftercare Engagement Package currently going through CSP to Value Options will change over to NTBHA. Process continues to go well.

Jail and hospital movement, pregnant defendants, and homeless data and reports were presented by Adbul Mohamed and Shenna Oraibure and are found in the meeting packet on pages 16-25. No further concerns or questions from the group on those items. Mike Laughlin provided monthly CCQ match for MH prevalence which remains around 25%. All other department and agency data reports and program updates were accepted as read, and can be reviewed in pages 27-42 of the meeting packet. Harry Ingram pointed out the 150 day Vernon State Hospital wait. Terrell is at 10 days currently. Lengthy discussion ensued regarding ongoing conversations between the Dallas County and DSHS about the overall need for quicker state hospital placements, part of which is being addressed by the upcoming Legislative Session.

Lynn Richardson provided **Public Defender** MH case data and reports (page 27 of packet) with no changes or further comments at this time.

Lee Pierson provided the **DA data updates and report from pages 28-33** with no further comments or discussion.

Provider Reports

Kelly Lane from The Bridge (pg. 34) advised that current census is remains high at the shelter. Also, they are now making greater linkage with the Metrocare Path Program.

IPS: will be provided by email since both staff normally in attendance were unable to be present today.

Metrocare: Marlene Buchanan advised that Probation census is down right now overall, but everyone else is running along with same average count.

Announcements

Lynn Richardson asked for announcements from the departments/agencies.

Shenna Oriabure gave a reminder for Judge Mays about the upcoming <u>2016 National Prison Summit on Mass</u> <u>Incarceration at Concord Baptist Church on Oct. 27th</u>. Also, Lynn advised there is a great prison and race documentary out right now on Netflix called: *The 13th*.

Adjournment: The motion to adjourn the meeting by Judge Skemp with second by Roger Lenox. Motion passed and meeting adjourned by Lynn Richardson at 925am. The next meeting is set for 11/17/16 at 830am in the same location.

530 Fund Sub-Committee

Review/Approval of Minutes

Laura Edmonds called the meeting to order at 9:31am and asked for a motion to approve the minutes. Judge Wade made a motion to approve the minutes. Judge Mays seconded the motion and the minutes were accepted by the group.

530 Fund Balance and Update

An update of the 530 Fund Balance was provided. Currently the balance for the Felony account (4020) is \$84,943.03; the Misdemeanor account (4031) is \$75, 166.15 for end of the 2016 fiscal year total of \$160,109.18. All TADCP expenses have been paid. Laura Edmonds presented the 530 Fund Monthly Expenses report for the period of October 2015-September 2016. Outstanding expenses for FY 2016 include STAC incentives, DIVERT incentive, DIVERT inpatient treatment, and opiate training mileage reimbursement. Laura solicited action points from the opiate training applicable to specialty courts. Judge Mays advised a company was moving to Dallas to do medication assisted treatment (MAT). Judge Wade cautioned attendees about treatment recommendations that may not translate the same with the criminal justice involved population. Judge Wade highlighted social economic status and criminogenic risk factors as variables that may affect treatment efficacy. Dr. Love recommended assessing to whom MAT will be most beneficial. Laura commented to be mindful of funding resources for MAT of the criminally involved indigent population. Following the format of the training material, Judge Wade recommended Dallas County produce a comprehensive pictograph, to provide quick information about all the specialty courts in a user friendly format.

Request for Funding

The Community Corrections Improvement Fund (CCIF) sent a letter to the committee requesting a \$1,000 donation. Group discussion determined the money cannot be a direct donation but rather a reimbursement to the organization for the purchase of incentives, with appropriate receipt(s). The request will be revisited next month. Lynn Richardson expects to receive policies regarding 530 fund usages from the Auditor's Office in the upcoming weeks.

Mental Health Jail Diversion submitted a formal written request for \$750 from the incentives line item for the Court's graduation/annual holiday party. Judge Wade disclosed the event does receive \$500 from CCIF and some other donations. Judge Mays moved to approve the request. Lynn Richardson seconded the motion. The subcommittee agreed to approve the request.

Policies and Procedures Review

Laura Edmonds presented draft copies of the 530 Fund Policies and Procedures. Judge Wade opined not to make the policies and procedures overly complicated or burdensome. Serena McNair suggested the policies and procedures should add information regarding procedures for attendance and voting. Members were asked to send suggestions regarding the draft to Laura Edmonds. Dr. Love would like to budget more training for the next fiscal year due to NADCP conference being held in Texas. Dr. Love requested consistency in training reimbursement across each entity (i.e. probation funded opiate training did not include mileage but the 530 funded opiate training included mileage).

<u>Update on Drug Testing Line Item</u>

Laura Edmonds reported \$172.55 has been invoiced for drug testing through the end of September. Shenna Oriabure encouraged more specialty courts to participate in the specialized drug testing opportunity. STAC and Competency are the only specialty courts currently utilizing the drug testing line item. Shenna reported 14 drug tests have been requested. Of the 14 requests, 7 specimens have been collected and are pending results, 2 pending collections, and 5 specimens collected with results. Of the 5 collected specimens with results, 3 positives and 2 negative. Positives include K2, alcohol, and GHB. Serena McNair commented about needing a smoother process. Ruth Kaiser advised the current process has worked well for STAC Court.

Announcements

Judge Mays advised of a prison ministry summit on October 27-29, 2016 at Concord Church. The summit will focus on criminal justice reform and mass incarceration. Several committee members commented about the success of the Texas Rally for Recovery. Kudos were given to Keta Dickerson for her efforts. Shenna Oriabure highlighted the 5 Star Kids program presented by the Betty Ford Center. 5 Star Kids is a three day program that provides prevention and education for children 7-12, who have a loved one with a problem with alcohol or drugs. Shenna will send a supplementary email with more information about the summit and the 5 Star Kids Program. Shenna spoke about 10 Key Component monthly training beginning in January 2017.
