d. evaluate overall performance to ensure the employee has an overall performance rating of at least  $\frac{2.75}{3.0}$  for satisfactory completion of the employment probationary period. An employee's failure to satisfactorily complete the initial employment probationary period will result in dismissal without right to appeal.
