- I. **Call to Order:** John Dornheim, Planning & Priorities Chair, opened the meeting at 9:00 a.m. and called the meeting to order at 9:23 a.m.
- II. **Certification of Quorum:** Quorum was established by John Dornheim and certified by Logane Brazile, RWPC Coordinator.
- III. **Introductions/Announcements:** John Dornheim, Planning & Priorities Chair, announced that on April 20, 2022, at 9 a.m., there will be a joint meeting with the Planning & Priorities Committee and the Consumer Council Committee to rank service categories based on the service needs of the Dallas EMA. Glenda Blackmon-Johnson, RWPC Office of Support, elaborated that the meeting will allow members to present questions and learn more about the service categories members will be considering during ranking.
- IV. **Approval of the February 23, 2022, Minutes:** Lori Davidson motioned to approve the minutes Korey Willis seconded. The motion passed.
- V. **2019 HIV Data Training:** Jasmine Sanders, RWPC Office of Support, overviewed the 2019 HIV/AIDS Data for the Dallas EMA. Due to the importance of making informed decisions regarding the PSRA process, members must have the most complete and up-to-date statistics regarding HIV/AIDS prevalence in the community. The following topics were reviewed:
  - # Of people living with HIV by race and gender identity*
  - # Of new diagnosis by race, ethnicity, age group*
  - # Of Dallas EMA specific people living with HIV*
  - Disparities of people living with HIV by race*
  - Most affecting age groups*
  - Male impact*Glenda Blackmon-Johnson, RWPC Office of Support, re-iterated that the data shown is from 2019. Although efforts have been made to collect the latest data pertinent to FY 2021-2022, due to COVID-19, there have been difficulties contacting the State to obtain this information. The Office of Support strives to update the committee with the latest, most complete information so that the committee always has an accurate representation of the Dallas EMA.
- VI. **New Business:** Glenda Blackmon-Johnson, RWPC Office of Support, stated that the PSRA Ballot would become available to members following the joint meeting on April 20, 2022. The timeline for completion will be between April 20, 2022- May 18, 2022. Members should expect an extended meeting.
- VII. **Adjournment:** John Dornheim called for a motion to adjourn. Lori Davidson made the motion. Korey Willis seconded the motion. The meeting was adjourned at 10:32 a.m.
