1. A hearing will be held in open court on Plaintiff's Unopposed and Verified Motion for Permanent Sealing Order to seal the unsigned, proposed order filed October 3, 2017 in the above styled and numbered cause.

2. Plaintiff sued Defendants alleging claims including requests for declaratory judgments and due process violations. Defendants denied Plaintiff's claims and material allegations. The Court granted Plaintiff filed a notice of nonsuit on October 4, 2017. On October 3, 2017, an incorrect version of a proposed order was filed containing a privileged attachment.
