

3. Consider review and approval of Bookkeeper's Reports, review of investments, approval of payment of bills and issuance of checks, and the taking of any appropriate action in connection therewith;
4. Consider review and approval of Tax Assessor-Collector Reports, approval of payment of related invoices, and discussion and appropriate action regarding delinquent tax accounts;
5. Consider review of draft District operating budget for fiscal year ending September 30, 2019, and taking of related action, including adoption of same;

9. Executive Session pursuant to Section 551.071, Texas Government Code, to consult with attorney, and/or Section 551.072, Texas Government Code, to deliberate regarding real property;
