Hospital Houston-Northwest, and Transitional Hospitals Corporation of Texas, Inc. d/b/a Kindred Hospital Tarrant County-Fort Worth Southwest (“Plaintiffs”) sued Defendants for misrepresentation and breach of contract claims arising out of Defendants’ alleged handling of certain claims for medical benefits submitted by Plaintiffs under various health benefit plans administered by Defendants.

2. Defendants are moving to compel arbitration of certain of those claims, and have included exhibits to their supplemental motion to compel arbitration that contain confidential and proprietary information, and potentially competitively sensitive information, of both the parties and third parties, as well as confidential personal information of non-parties to this lawsuit (but redacted as appropriate to protect health information), as described below.

3. As such Defendants filed a motion to seal the following: Defendants’ agreement with Beech Street Corporation, Defendants’ agreement with First Health Life & Health Insurance Company, certain membership eligibility records at issue, and certain network information produced by Plaintiffs and designated confidential under the Agreed Protective Order.

4. A hearing to determine whether the exhibits should be sealed permanently will be held in open court on **Thursday, March 15, 2018, at 10:30 a.m.**, before Associate Judge Sheryl McFarlin, at George L. Allen, Sr. Courts Building, 600 Commerce Street, 6th Floor West, Aux. Courtroom 6-C, Dallas, Texas 75202.

5. The hearing on the motion to seal will be held in open court.

6. Any person may intervene and be heard concerning the sealing of such exhibits.
