Method 3: When searching by party name, a business name or an attorney name, you may utilize a wildcard search. Wildcard searches are completed by entering a minimum of one character for first and last name or for business name, followed by an asterisk. For example for John Smith the user might enter, "Smith, J*" or "Sm*, J*".

Search By Method:

You may perform a quick under Search by options by entering Party name or Nickname, Attorney or Bar Number, Business, and Case number or Judicial Officer.

Name and Attorney Names require alpha characters.

Special character allowed include commas, periods, apostrophes, hyphens, ampersands and asterisks are allowed for name searches. Hyphens and asterisks are allowed for number searches, such as case number.
