Government Code, Chapter 551, that the Board of Directors of Texas Tri-Modal Municipal Utility District No. 2 will meet in **special** session, open to the public, at **12:00 p.m.**, on **Friday May 10, 2024, at 16000 North Dallas Parkway, Suite 350, Dallas, Texas 75248**, at which meeting the following items will be considered and acted on:

1. Hear from the public;
2. Consider approving minutes of meeting of April 8, 2024;
3. Hear Bookkeeper's Report and authorize payment of bills;
4. Hear Developer's Report;
5. Hear Engineer's Report and authorize any necessary action, including:
  - (a) authorize Engineer to proceed with the design of District facilities;
  - (b) approve plans and specifications of District facilities;
  - (c) authorize Engineer to advertise for bids for District projects;
  - (d) consider accepting property interests necessary to accommodate the construction of District facilities;
  - (e) approve of report, pay estimates and change orders for construction projects in progress in the District; and
6. Hear Financial Advisor's Report and authorize any necessary action;
7. Discussion regarding District insurance coverages;
8. Hear Attorney's Report and consider taking any action required, including:
  - (a) approval of an Order Canvassing and Declaring Election Results of Confirmation Election, Bond Election, and Maintenance Tax Election;
  - (b) approval of an Amended Notice to Sellers and Purchasers;
  - (c) approval of a Resolution Establishing District's Regular Meeting Date and Location; and
  - (d) ratify approval of Crossing Agreements related to District owned road right-of-way.

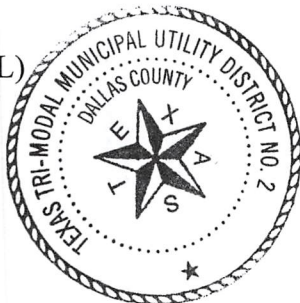
