UNFINISHED BUSINESS

#1 – The Board tabled the discussion and any possible action regarding a monthly report to the Dallas County Bail Bond Board from the Bond Desk as reported by the Dallas County District and County Clerks regarding those licensees and attorneys placed on the “cut-off” list until the January 9, 2014 meeting.
