DALLAS COUNTY BAIL BOND BOARD LEGAL NOTICE OF OFFICIAL ORDER

Notice is hereby given pursuant to the Texas Occupations Code, Chapter 1704.202 and 1704.305 that the following Official Orders were given by the Dallas County Bail Bond Board at a regular meeting of the DCBBB, held September 12, 2013.

UNFINISHED BUSINESS

#1 -The Board voted to close the complaint against Victor Montoya d/b/a Superior Bail Bonds, account number 645, license number 094, for failing to return certain jewelry which Superior Bail Bonds took as collateral (security) and was not returned to the principal after the conditions had been met and after the bond had been discharged.

#2-The Board voted to close the complaint against International Fidelity Insurance co., d/b/a "David's Bail Bonds II", Mark Toliver, agent, account number 1040, license number 210, for failure to return security that David's Bail Bonds took to secure a defendants release and was not returned when the defendant was subsequently transferred.
