DALLAS COUNTY BAIL BOND BOARD LEGAL NOTICE OF OFFICIAL ORDER

Notice is hereby given pursuant to the Texas Occupations Code, Chapter 1704.202 and 1704.305 that the following Official Orders were given by the Dallas County Bail Bond Board at a regular meeting of the DCBBB, held February 13, 2014.

UNFINISHED BUSINESS

#1-The Board approved the amended Local Rule B2 (a), (b), (c) as it is currently written to be added to the DCBBB Procedures and Rules Manual.

#2-No action taken

NEW BUSINESS

#1 –The Board approved a request to close and withdraw \$2,700.00 from attorney Anthony D. Randall, account number 870.

#2- The Board approved a request to close and withdraw \$1,000 from attorney Kenny Ray Kirby, account number 1043.

#3- The Board denied the request to withdraw \$25,000.00 from attorney Anthony Lyons, account number 1012.

#4- The Board tabled the request to withdraw \$15,000 from attorney Edward Spears, account number 871.

#5- The Board took no action regarding the current license application and I.D. card application forms.

#6- The Board, after a discussion, granted authority to the Board Staff, Investigator and Legal Counsel to investigate the titles to real property or properties in the name of the Board and report back to the Board with recommendations.
