DALLAS COUNTY BAIL BOND BOARD LEGAL NOTICE OF OFFICIAL ORDER

Notice is hereby given pursuant to the Texas Occupations Code, Chapter 1704.202 and 1704.305 that the following Official Orders were given by the Dallas County Bail Bond Board at a regular meeting of the DCBBB, held July 10, 2014.

UNFINISHED BUSINESS

#1- The Board approved the original license application of Allegheny Casualty Company, Donna Lynn Fletcher, agent, d/b/a "Taylor Bail Bonds".

NEW BUSINESS

#1 – The Board approved the original license application of International Fidelity Insurance Company, Marjorie A. Walstad, agent, d/b/a "Immediate Bail Bonds".

#2- The Board found reasonable cause to proceed with the investigation of Financial Casualty, and Surety, Inc., Lawrence McCurdy, agent, d/b/a "Maverick Bail Bonds", account number 1062, investigation cause number C14-011.

#3- The Board voted to adopt a rule which would set a deadline on 4:00 p.m. on the Wednesday of the week prior to the regular Board meeting for the submission of documents or materials for the Board to review.

#4- The Board authorized the Presiding Officer and Legal Counsel to prepare and send a letter to the attorneys who currently have bail bond accounts with Dallas County, Texas, to remind them to comply with the Occupations Code and the Local Rules. The Board also directed the Staff, Investigator, and Legal Counsel to draft a notice to be posted on the Bail Bond Board website also reminding attorneys to comply with the rules when writing bonds. The Board will review and approve the notice prior to posting.

#5- The Board authorized the Legal Counsel to represent the Board in the litigation of *Dallas County, et al vs. Lisa Wyrick, et al* (Dallas County Bail Bond Board), Cause No. TX-13-31584 but instructed Legal Counsel not to accept service on behalf of the Board.
