## **DALLAS COUNTY BAIL BOND BOARD LEGAL NOTICE OF OFFICIAL ORDERS**

**Notice is hereby given pursuant to the Texas Occupations Code, Chapter 1704.202 and 1704.305 that the following Official Orders were given by the Dallas County Bail Bond Board at a regular meeting of the Dallas County Bail Bond Board held June 12, 2014.**

### **UNFINISHED BUSINESS**

**#1- The Board voted to take no further action on the complaint against Financial Casualty and Surety Inc., Lawrence McCurdy, agent, d/b/a “Maverick Bail Bonds,” original license issued May 14, 2009, license number 217, account number 1062, investigation cause C14-005.**

### **NEW BUSINESS**
