DALLAS COUNTY BAIL BOND BOARD LEGAL NOTICE OF OFFICIAL ORDER

Notice is hereby given pursuant to the Texas Occupations Code, Chapter 1704.202 and 1704.305 that the following Official Orders were given by the Dallas County Bail Bond Board at a regular meeting of the DCBBB, held January 9, 2014.

UNFINISHED BUSINESS

#1 – The Board directed the Board staff to maintain information regarding sureties placed on the “cut-off” list and to provide it to the Board as sureties come before the Board for renewal or otherwise. The information provided would include the time period between the previous renewal and the next renewal application.

#2- The Board reviewed the proposed changes to Local Rule B2 (attorneys) to clarify and amend the rule regarding current runners for attorneys’ employees who have ID cards asked Counsel for a revision and tabled the discussion and action until the revision could be presented at the next regular meeting.

#3- The Board voted to close the investigation of the complaint against attorney Raul Loya from Norma Rocha which the Board authorized to be investigated on November 8, 2012.

NEW BUSINESS

#1 –The Board approved a request to withdraw \$16,000 from the account of Tom Benson, d/b/a “Act Quick Bail Bonds”, account number 830, original license issued April 20, 1997, license number 169.

#2- The Board received a report regarding a citation from the City of Dallas Department of code compliance on the property located at 3815 S. Tyler St. Dallas, Dallas County, Texas, and after a discussion, directed the Board Staff and Investigator,
