DALLAS COUNTY BAIL BOND BOARD LEGAL NOTICE OF OFFICIAL ORDER

Notice is hereby given pursuant to the Texas Occupations Code, Chapter 1704.202 and 1704.305 that the following Official Orders were given by the Dallas County Bail Bond Board at a regular meeting of the DCBBB, held January 8, 2015.

UNFINISHED BUSINESS

#1- None.

NEW BUSINESS

#1 – The Board elected Daniel Simon, Dallas County Sheriff designee, as the Presiding Officer of the Dallas County Bail Bond Board.

#2- The Board approved the withdrawal of \$1,000.00 from attorney James Best, account number 815.

#3- The Board approved the withdrawal of \$3,772.60 from attorney James Belt, account number 773.

#4 – The Board approved the renewal license application for Continental Heritage Insurance Company, Patrick Kinnard, agent, d/b/a “Pat Kinnard Bail Bonds,” original license issued January 31, 2001, license number 185, account number 912 for three years.

#5 – The Board approved the renewal license application for International Fidelity Insurance Company, Lingda Ngo, agent, d/b/a “David’s Bail Bonds III,” original license issued February 14, 2013, license number 231, account number 1112, for two years.

#6 – The Board approved the request from International Fidelity Insurance Company, Lingda Ngo, agent, d/b/a “David’s Bail Bonds III,” to change the assumed name for the bond company from “David’s Bail Bonds III” to “Your Bail Bonds”. The original license was issued February 14, 2013,


and the license number 231, account number 1112, remain the same.
