Notice is hereby given pursuant to the Texas Occupations Code, Sections 1704.202 and 1704.305 that the following Official Orders were given by the Dallas County Bail Bond Board at a regular meeting of the Board, held October 8, 2015.

UNFINISHED BUSINESS

#1- The Board approved the original license application for First Community Insurance Company, Milene Cooper, agent, d/b/a "Ace Bail Bonds."

#2-After a discussion, the Board determined that there was no reasonable cause to proceed with an investigation of a written complaint number C15-009 against Accredited Surety & Casualty Company, Inc.
