UNFINISHED BUSINESS

#1- The Board took no action regarding the transfer of a bail bond license in case of an owner's death.

#2- The Board took no action regarding the transfer, assignment, or inheritance of the bail bond license for Charles O. Monroe, license, d/b/a "Delta Bail Bonds,; and its security. Original license issued February 3, 1989, license number 144, account number 714.


