DALLAS COUNTY BAIL BOND BOARD LEGAL NOTICE OF OFFICIAL ORDER

Notice is hereby given pursuant to the Texas Occupations Code, Sections 1704.202 and 1704.305 that the following Official Orders were given by the Dallas County Bail Bond Board at a regular meeting of the Board, held November 10, 2016.

UNFINISHED BUSINESS

#1- The Board tabled the item of the transfer, assignment, or inheritance of the bail bond license for Charles O. Monroe, license, d/b/a "Delta Bail Bonds, and its security. Original license issued February 3, 1989, license number 144, account number 714, until the next regular meeting.

NEW BUSINESS

- #1- The Board approved the withdrawal of \$50,000.00 for attorney Thomas Cox, account number 953.
- #2-The Board directed that a copy of the Victor Montoya d/b/a "Superior Bail Bonds" bondsman audit report be given to the County Clerk office and District Clerk office so they can discharge the bonds which have dispositions.
- #3- The Board tabled the item regarding a contingent release of property currently pledged with the Board for Eddie Dees, licensee, d/b/a "Fast Action Bonding." Original license issued September 30, 1982, license number 071, account number 576.
- #4 The Board instructed the Presiding Officer to prepare a communication to the licensed sureties and attorneys with bond accounts that the courts and judges of Dallas County have rules and dress codes for their courtrooms and reminding the sureties, attorneys and employees to comply with the rules as established by the judges in their individual courts. The Presiding Officer will submit the communication to the judges on the Board for review and comment before presenting it to the sureties and attorneys.
