Notice is hereby given pursuant to the Texas Occupations Code, Sections 1704.202 and 1704.305 that the following Official Orders were given by the Dallas County Bail Bond Board at a regular meeting of the Board, held February 9, 2017.

UNFINISHED BUSINESS

#1- The Board tabled the item of the transfer, assignment, or inheritance of the bail bond license for Charles O. Monroe, license, d/b/a "Delta Bail Bonds, and its security. Original license issued February 3, 1989, license number 144, account number 714, until the next regular meeting.

#2- The Board removed the item of the contingent release of a portion of property currently pledged with the Board for Eddie Dees, licensee, d/b/a "Fast Action Bonding." Original license issued September 30, 1982, license number 071, account number 576, until further notice.
