LEGAL NOTICE OF OFFICIAL ORDER**

Notice is hereby given pursuant to the Texas Occupations Code, Sections 1704.202 and 1704.305 that the following Official Orders were given by the Dallas County Bail Bond Board at a regular meeting of the Board, held May 10, 2018.

UNFINISHED BUSINESS

#1- The Board ordered that this item regarding Deeds of Trust of tendered properties to the Dallas County Bail Bond Board as security, including, but not limited to all Licensed Bond Companies of Dallas County, be removed from the Agenda as a recurring item until all required paperwork has been processed.

#2- The Board ordered no further action be taken regarding the withdrawal of \$35,000.00 from attorney Edward Spears, account number 871.

NEW BUSINESS

#1- The Board ordered the denial of the withdrawal of \$25,000.00 from attorney Edward Spears, account number 871, for lack of clearance.
