Notice is hereby given pursuant to the Texas Occupations Code, Sections 1704.202 and 1704.305 that the following Official Orders were given by the Dallas County Bail Bond Board at regular meeting of the Board, held March 12, 2020.

UNFINISHED BUSINESS

#1-The Board ordered that there was no reasonable cause to proceed with further investigation of complaint number C19-011 against American Surety Company, Jamal Qaddura, agent, d/b/a “AAA Professional Bail Bonds,” original license issued December 28, 2016, license number 254, account number 1170 and dismissed the complaint.
