DALLAS COUNTY BAIL BOND BOARD LEGAL NOTICE OF OFFICIAL ORDERS

Notice is hereby given pursuant to the Texas Occupations Code, Sections 1704.202 and 1704.305 that the following Official Orders were given by the Dallas County Bail Bond Board at a regular meeting of the Board, held September 14, 2023.


#2- The Board approved the renewal license for Lexington National Insurance, d/b/a "Rebel Bail Bonds," Cory Lee, agent.
