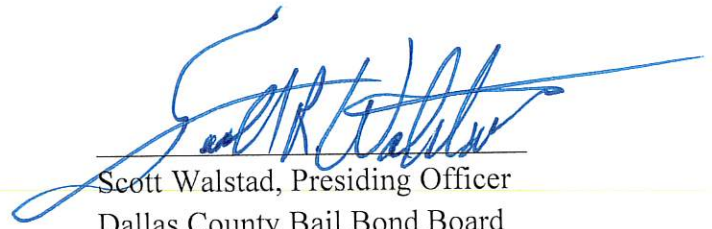
H. EXECUTIVE SESSION
