Radioactive Nuclear Waste Transportation Concerns Dallas County Commissioners

On April 4, 2017 Dallas County Commissioner Theresa Daniel championed a resolution against transporting high-level nuclear waste through our dense, urban areas. "The public health of Dallas County residents must be protected. Just because the railroad goes through the county does not mean that the population of a large urban area should be put in peril," Commissioner Theresa Daniel said.

The resolution passed unanimously. Tom "Smitty" Smith of Public Citizen, Former State Representative Lon Burnam and Jan Sanders with the Sierra Club spoke at this meeting and many others came out in support.

Waste Control Specialists (WCS) had an application

pending to store tons of used fuel from nuclear power plants in Andrews County, Texas and that waste could potentially pass through the Dallas area either by train or by truck.



This pressure from local governments and activists has caused WCS to ask the Nuclear Regulatory Commission to temporarily suspend review of their license application for high-level radioactive waste storage in Andrews County.

UPDATE: Dallas County-City partnership to end and prevent homelessness

As previously reported, a county-wide partnership is being created to address homelessness in the region. The Dallas County Commissioners Court had previously approved the formation of the partnership on February 21, 2017

The Dallas City Council voted on April 12, 2017, and approved the formation of a regional partnership with an 11-member board that would include elected county and city officials and representatives from The Real Estate Council, the North Texas Behavioral Health Authority, the U.S. Department of Veterans Affairs, Parkland Health and Hospital System and the Apartment Association of Greater Dallas.

After much debate, it was also decided to separate the citizen advisory committee structure. The matter will be voted upon again in May by the Dallas County Commissioners Court to consider the changes.

Metro Dallas Homeless Alliance: State of the Homeless Address

On Thursday, March 8, 2017 MDHA board member, Dallas County Commissioner, Dr. Theresa Daniel, and Chair of the MDHA board, Executive Director of the Turtle Creek Recovery Center, John Castaneda opened the annual State of the Homeless Address.

About 350 people joined Metro Dallas Homeless Alliance at Goodwill Industries of Dallas, as Cindy J. Crain, MDHA President and CEO, shared the results of the 2017 Point-in-Time Homeless Count, and the progress of the Homeless Response System.
