



**BE IT REMEMBERED**, at a regular meeting of the Commissioners Court of Dallas County, Texas, held on the 15th day of February 2022 on a motion made by Dr. Theresa M. Daniel, Commissioner of District 1, and seconded by Dr. Elba Garcia, Commissioner District 4, the following Resolution was adopted:

- WHEREAS, Dr. Paula Dobbs-Wiggins, a native of St. Louis, MO, received her bachelor's degree in Biology (cum laude) from Harvard College. She then went on to pursue her medical degree at Harvard Medical School which currently has an acceptance rate of 3.7%; and
- WHEREAS, Dr. Dobbs-Wiggins completed her residency in psychiatry at Timberlawn Psychiatric Hospital in Dallas and is a Board Certified Psychiatrist and Distinguished Fellow of the American Psychiatric Association. She specializes in diagnosing and treating mental illness such as depression, anxiety disorders, substance abuse and schizophrenia; and
- WHEREAS, in November 2013, **Dr. Dobbs-Wiggins** was appointed to serve on the Parkland's Board of Managers as an at-large appointee by the Dallas County Commissioners Court. She was unanimously chosen to serve as Chair in August 2019 and named one of the 2021 recipients of the Kerney Laday, Sr. Trustee Award; and
- WHEREAS, with her unique experience as an ordained minister, **Dr. Dobbs-Wiggins** worked to increase dialogue and collaboration between mental health and religious professionals to promote a greater understanding of mental health conditions and decrease the stigma that often results in people not availing themselves effective treatment; and
- WHEREAS, Dr. Dobbs-Wiggins is a retired Professor of the Practice of Pastoral Care at Perkins School of Theology, Southern Methodist University having served on the faculty from 1999-2019. She also used her professional experience and passion for the good of the community as a long-time member of St. Luke Community UMC where she serves as a Clinical Coordinator of the Mental Health Ministry and Directress of the Angel & Cherub Choir; and
- WHEREAS, with the multiple talents of **Dr. Dobbs-Wiggins** focused on the public good, the patients and staff of Parkland Hospital received a Board of Managers Member who was aware of the needs of the larger community and responded directly to answer the need but also with an understanding of whether it was the better option. The broader approach made her well suited to making decisions for the Parkland, and Dallas County community.

**NOW, THEREFORE, BE IT RESOLVED,** that the Dallas County Commissioners Court does hereby thank and recognize **Dr. Paula Dobbs-Wiggins** for her leadership and service on the Parkland Board of Managers and to all the residents of Dallas County.
