

Combatting Homelessness Through Community Partnerships

Housing/homelessness are one of the core issues Dr. Daniel and her staff works tirelessly to address. Commissioner has been busy within Dallas County checking in with District 1 civic leaders and community partners to gain invaluable insight on the impact of housing and homelessness that their organizations are experiencing. Progress is being made to provide more accessible and affordable housing within Dallas County with several projects underway that are providing more affordable housing units in District 1 and around the county. Dallas County Health and Human Services offers various programs such as the Eviction Prevention Program, the Dallas County Housing Agency, and rental and utility assistance which are available to address other aspects of being housed. Dr. Daniel is involved in the housing/homelessness conversation statewide as well. As a panelist on the University of Texas at Austin 2024 Land Use Conference, Commissioner discussed advancing housing affordability in counties. The County also partners with cities and community organizations to offer more assistance to those who are in need in the housing/homeless arena. These partnerships help to mitigate the effects of the housing deficiency within our community. Dr. Daniels's commitment to addressing these issues epitomizes her two cardinal rules: "1. We don't do anything by ourselves. 2. We're not quite done yet."

Insights of A Generation Z's Election Experience

As the Dallas County Commissioner for District 1, Dr. Daniel has the distinct pleasure of educating the public about the policies and procedures of local government. This also includes educating tomorrows' best and brightest leaders. Each year, Commissioner Daniel invites a Skyline High School senior to intern in her office as part of their practicum class. The intern learns about the office of the Commissioner and the daily processes they are involved in. They also learn about other aspects of local government and how the departments work together to facilitate the daily operation of functioning local government. In doing so, the District 1 intern, Sarahi Velasco, had the opportunity to work for the Dallas County Elections department in the March Primary Elections as a first time student clerk at the Young Men's Leadership Academy at Fred F. Florence Middle School polling site in Dallas. She recounts her experience working her first election.



"There was never a more unique experience than being a student election clerk in an adult election. I was thrilled to have the chance to take part in a significant and worthwhile political process as a high school student. Being involved in an election was a dream come true for me because I had always been interested in politics and the government. I was eager to start my job as a student election clerk, so I got to the polling station early on election day. I was tasked with a variety of duties during the day, such as distributing ballots, checking in voters, and helping with any problems that came up. It was an energetic and fast-paced day, with people constantly pouring in to cast their vote. The arrival of people that only spoke Spanish was a huge part of the day's most noteworthy events. By reading the alternatives aloud and translating their selections for them, I was able to help them complete their ballot. Being able to assist someone in exercising their right to vote, despite any barriers they might encounter, was a humbling experience.

I had the chance to speak with a wide variety of people during the day, each of them has their own distinct priorities and points of view. Hearing their thoughts and perspectives on the topics that were most important to them was intriguing, as was seeing the excitement they showed during the voting process. I also came to understand the significance of free and transparent elections as a clerk. I personally witnessed the painstaking attention to detail and exacting protocols put in place to guarantee the credibility of the voting process. It served as a reminder of the core tenets of democracy and the significance of upholding everyone's right to express themselves.

Overall, being a student election clerk was a valuable and rewarding experience that not only deepened my understanding of the electoral process but also reinforced my belief in the power of democracy. It was an honor to play a small role in facilitating the election and to witness the energy and enthusiasm of the amazing people that showed up as they exercised their right to vote. I will always look back on this experience with fondness and gratitude, knowing that I played a part in making our community a more vibrant and inclusive place."

Jonathan's Place was established over 30 years ago and celebrated it's grand opening in 1994 and it began accepting children into its care in its long term foster care program 1995. Since then, the organization has evolved and are providing services such as emergency shelters, the national safe place program, foster care and adoption programs, and numerous programming for girls aged newborn to 23. They have multiple facilities and are looking to expand their services across the DFW metroplex. They are committed to providing children a safe space to learn, grow, and become
