Dallas County is progressing forward and making moves in District 1 which includes all of Garland and Balch Springs and parts of Dallas (Pleasant Grove, East Dallas, White Rock area) and Mesquite. In collaboration with the City of Garland, Dallas County broke ground on the Rowlett Road Multi-Modal Connection in late May. This project will provide sidewalks, bike lanes, and an expanded roadway on Rowlett Road in Garland. Dallas County is also set to begin construction on the new East Dallas Government Center which will be located at 9731 Lake June Road in Dallas. The new building will feature various Dallas County departments including a passport office and Commissioner Daniel's office. Commissioner and her staff are also ready to offer valuable information to the residents of District 1 in a host of Town Hall meetings that will be held every Wednesday in June in various locations. These locations include Dallas County Road and Bridge 1 Office, Dallas College, and the Balch Springs Civic Center and will feature various Dallas County departments and partners. Commissioner is excited about the growth in District 1 and looks forward to connecting with constituents at the various events.

Commissioner Daniel Swears In Balch Springs City Officials

On May 14th Commissioner Daniel had the honor of swearing in the newly elected Mayor and city council members for the City of Balch Springs. After an election where two of the four candidates were in tight races, including the mayoral race, winners emerged and were sworn into office to serve their duties for their respective places in the city. Commissioner Daniel swore in two incumbent councilmembers, Councilmember Place 6, Paula Garcia, and Councilmember Place 7, Yemi Salau. She also swore in newly elected Councilmember Place 5, Jessie Patino and the newly elected Mayor, Rodney Taylor. The City of Balch Springs has a "Council-Manager" form of government that consists of seven councilmembers, five of whom are elected from single member districts. The other two are elected at large, with one of the at-large members being the Mayor of the City. Four of the members are elected in odd numbered years and three are elected in even numbered years. The 2025 election resulted in two of the four member seats to newcomers to the council body. Commissioner Daniel congratulated all of the elected officials and looks forward to the continued partnership between Dallas County and the City of Balch Springs.

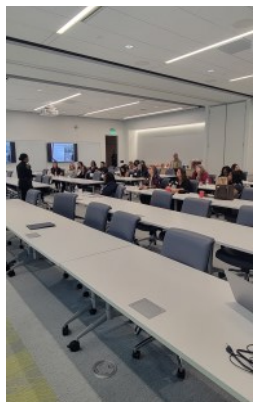

Dallas County Collaboration with Leadership Garland and Mesquite

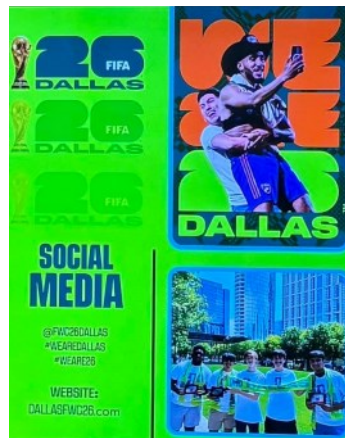
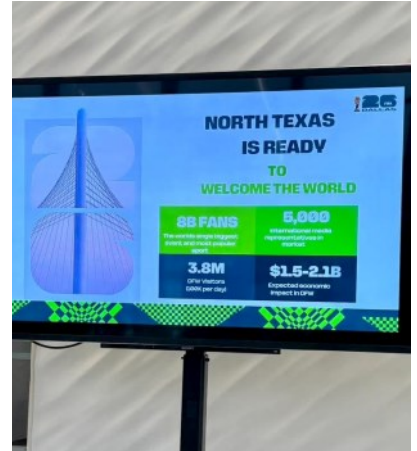
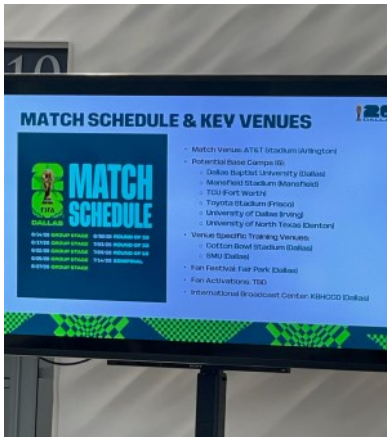

The North Texas FIFA World Cup Organizing Committee hosted an Elected and Appointed Officials briefing at AT&T Stadium in late April. Joint Election*

In Texas, the May Joint Election* is a key opportunity for voters to participate in local governance by selecting officials such as city council members, school board trustees, and other municipal representatives. These elected officials play a crucial role in addressing local needs, from education to public safety and community development.

Key Dates & Deadlines

Apr 3 - Last Day to Register to Vote
Apr 22 - First Day of Early Voting
Apr 22 - Last Day to Apply for a Mail Ballot
Apr 29 - Last Day of Early Voting
May 3 - Election Day
May 3 - Mail ballots postmarked on or before May 3rd by 7 PM can be received no later than May 8th

Dallas County registered voters have the convenience of voting at any Vote Center within Dallas County, whether during Early Voting or on Election Day. Utilize our [Vote Center Location Finder](#) to locate the nearest Vote Center to you, and access information on Vote Center Hours and Wait Times.

View your Sample Ballot

Sample Ballots become available 30 days prior to an Election and allow registered voters to familiarize themselves with the choices they'll make on Election Day.

Required Identification for Voting

Bring any of the below Acceptable ID's to your Nearest Vote Center;

- Texas driver license issued by the Texas Department of Public Safety (DPS)
- Texas Election Identification Certificate issued by DPS
- Texas personal identification card issued by DPS
- Texas handgun license issued by DPS
- United States military identification card containing the person's photograph
- United States citizenship certificate containing the person's photograph or
- Passport

Aside from the U.S. citizenship certificate, all other IDs must be current or have expired within the last four years to be valid for voter qualification at the polling place.
