Election Sites 2024 - New Additions

My staff and I along with the elections department worked diligently to identify and secure alternative voting sites to replace two major sites that withdrew. I also noticed that a few areas in District 2 did not have access to a convenient voting location so I found voting locations for those areas.

Paige Lynne (Legal Analyst), Elva Rodriguez (Deputy Chief of Staff), Quinn Kelly (Research Intern), and Meghna Sharda (Public Outreach Director) have reached out to over 100 places to find voting locations for District 2.

Northway Christian Church

Location: 7202 W. Northwest Hwy

Earlier this year when Our Redeemer decided to withdraw as a voting site, my staff took immediate action to find a new location. Myself and Paige Lynne, worked with Elva Rodriguez, Quinn Kelly and Meghna Sharda to reach out to 46 places within the area of Marsh Lane and N. Central Expy and successfully

secured Northway as a voting site.


Walnut Hill In

Northway Christian Church will provide residents within the area of Hillcrest Rd. and N. Central Expy an accessible voting location in lieu of Our Redeemer.

Ministerios Charisma

Location: 9740 Melrose Dr.

When First Baptist withdrew as a voting location from Dallas County, my staff called 31 places and secured Ministerios Charisma as a new voting location. I am confident that this location will benefit the residents of Richardson who voted at First Baptist, it will save them travel time & costs, and give them the opportunity to connect with Pastor Jean-Louis Mercier, who is keen to have the church be a voting site.



Hamilton Park United Methodist Church

Location: 11881 Schroeder Rd.

Hamilton Park United Methodist Church was selected to provide a convenient voting site to residents between Interstate 635 and Forest Lane because there were no accessible voting locations in that area. Residents from this area would have to travel over Interstate 635 or N. Central Expy, which is not a viable option for some residents. By providing Hamilton Park as voting location, I aim to offer more voting locations for my constituents.



Madinah Masjid of Carrollton

Location: 2180 Old Denton Rd.

The Madinah Masjid of Carrollton was selected to better serve the needs of the Muslim community and to create a more inclusive environment that encourages more members of our community to vote.



Royal Lane Baptist Church

Location: 6706 Royal Ln.



The purpose of offering Royal Lane is to offer an additional voting location option for District 2 resdients as well as encourage participation from individuals who may have not voted in the past due to accessibility issues.



St. Paul's Evangelical and Reformed Church

Location: 6464 E. Lovers Ln.

With Skillman Southwestern Library withdrawing as a voting site, Commissioner Daniel and I noticed that there will be no convenient voting locations for residents living near White Rock Lake. We started to search for a new voting location and Commissioner Daniel, along with her amazing staff found and secured St. Paul's as a new voting location.



St. Paul's was selected to offer an accessible voting location for constituents in proximity to White Rock Lake. I would like to thank Commissioner Daniel and her staff for their hard work and efforts toward obtaining St. Paul's, we could have not acquired a better voting location!

Leadership Management Academy



On May 16th, Commissioner Sommerman spoke to the Leadership Management Academy about his education, work experience and priorities such as CLEAR and Central Magistration. **CLEAR (Compassionate Law** Enforcement Active Response) aims to create a taskforce of officers specialized in managing challenges such as homelessness, mental illness, human trafficking and other 21st century challenges. Central Magistration aims to provide indigent arrestees representation prior to their hearing before a magistrate.




Cypress Waters Trail

The Cypress Waters Trail Project aims to connect the South of Cypress Waters Cotton Belt Station to the existing trail North of Olympus Blvd.

The trail will connect to the silverline DART extension which runs throughout Dallas County and will have a wide shared-use hike and bike trail of 1.24 miles of 14'.

Dallas County Home Loan Counseling Center

UPFRONT COST ASSISTANCE PROGRAM

Assists qualified first-time homebuyers with up to \$15K of down payment and/or closing cost assistance to purchase a home in Dallas County.

ONE-ON-ONE COUNSELING

HUD-certified personalized counseling: Individuals meet with a housing counselor to determine mortgage readiness and establish action plan & budget that will be used to guide them through the home-buying process.

PRE & POST-PURCHASE CLASSES

These classes provide the tools and resources to support homebuyers be successful. Topics include Saving for Retirement, Insurance 101, Taxes and Homeownership, Property Taxes etc.

FINANCIAL LITERACY/BUDGET CLASS

A 1-hour class covering the importance of a household budget, how to maintain a checking & savings account and a mortgage payment.

REVERSE EQUITY MORTGAGE COUNSELING

Assists clients who are 62 years of age or older with receiving a loan against the equity of their home.

FIRST TIME HOMEBUYERS COURSE

A monthly HUD certified homebuyer education course covering the complete homebuying process.

CREDIT REPAIR WORKSHOP

A monthly 1-hour workshop to educate potential homebuyers on how to improve their credit score to qualify for a mortgage loan.

SECTION 8 HOMEOWNERSHIP PROGRAM

Assists clients who are on Dallas County section 8 Rental Assistance Program to purchase a home. Clients must be able to qualify for a mortgage loan.

LOSS MITIGATION FORECLOSURE COUNSELING

Individual counseling for reducing the prospect of a potential foreclosure.
