Texas Law Library Improved Access for Historical Legal Research

The Texas State Law Library recently completed a project to make historical research more efficient.

Vernon's Statutes

Vernon's has been compiling Texas statutes since 1914. People often use these volumes for historical research and practical legal work to:

- find older statutes
- see what the law said at a specific date
- track changes in law over time
- find relevant court decisions, cross-references, and commentary

Though Texas has no official print publisher of its codes, Vernon's has become a quasi-official publication. The Legislative Reference Library describes the evolution of Vernon's in their article Who Is... Vernon? You can find digitized copies of Texas statutes from 1879 through 1984 on our website.

OLD RED COURTHOUSE

The county's "Old Red Courthouse," was erected in 1892 in a Romanesque Revival style. As hailed in the Dallas Morning News in 1892, Old Red was a "fine, modern, fireproof structure" and included "domes, towers and gables and many angles harmonizing to perfection." Decades of modifications and renovations would eventually lead to Old Red's decline. After years of work and research, the building has been restored to its original 1892 appearance both inside and out and stands once again as an impressive Dallas landmark.

Old Red, is scheduled to return to is original civic use. It will become the new home of the Texas Fifth Circuit Court of Appeals. Once again, court proceedings and the work of overseeing justice will fill the rooms of Old Red.
