Texas Court System

Court Structure

Each court in the Texas court system has a specific jurisdiction. Our court system is made up of:

- municipal courts;
- justice courts (justice of the peace);
- county courts;
- probate courts;
- district courts;
- · business court; and
- · courts of appeal.

At the highest level, the Texas Supreme Court hears civil cases and the Texas Court of Criminal Appeals hears criminal cases.

Common Law

Texas uses a common-law system. In a common-law system, decisions from high courts are binding on lower courts. This concept is known as setting a precedent.

Case law is derived from past decisions made by the courts. This type of law is constantly evolving because the courts are always hearing new cases and interpreting the law.

WHO WAS GEORGE L. ALLEN, SR.?

Judge George Allen Sr. (1908-1991) was an active businessman and community leader in Dallas, establishing businesses and acting on city councils. In the 1960s, Allen served on the Committee of 14, to begin the process of desegregating Dallas schools and public spaces. He was the first Black member of a Dallas City board, when he was appointed to the City Plan Commission in 1963. And in 1969, Allen became the first Black Dallas City Council member, and eventually the first Black Mayor Pro-tem. In these positions, he focused on the issues of civil rights and housing discrimination. Allen resigned from his position on Dallas City Council in 1975 to take on the role of Justice of the Peace until his death in 1991.

3 Questions to Avoid Bad Legal Information

Ask these questions to make sure you are getting correct, trustworthy legal help online.



Is the legal info meant for your location?

Make sure it's for your city, county, or state. Or else it could be wrong for you.



Is the info up-to-date?

Laws and paperwork change all the time. Check when the info was last updated, to make sure it still applies.



Is the info from a trustworthy expert?

Or is it from someone with limited legal experience? Or could it be a scam?

Be Careful with AI Tools

like ChatGPT, Copilot or Gemini

Always double-check any legal information an Al tool gives you.

A law librarian or a lawyer can help you double-check.

Or you can do your own legal research, to verify the info.

AI can make up fake laws, cases, legal aid groups, hotlines, forms, and other legal info.

Al tools may seem confident in their answers. But they make many mistakes.
