<b>For initial cases filings (excluding Heirship cases types) that require posting, please add the \$20 Posted Notice Fee (\$20) and Issue Citation fee (\$8).</b>	<b>\$28 when posting is required</b>
<b>Issuance fees are included for Application for Administration and Determination of Heirship and Application to Determine Heirship.</b>	
<b>Applications for Probate of a will: Letters Testamentary, Muniment of Title, Administration with will annexed.</b>	<b>\$360.00</b>
<b>Applications for Administration: Independent Administration, Dependent Administration Community Administration, or No Administration</b>	<b>\$360.00</b>
<b>Combined Application for Administration and Determination of Heirship: You will receive an additional bill from the Daily Commercial Record for publication (for the heirship proceeding) of your citation. This fee must be paid before the citation will be returned to the Clerk. Note: Add a \$500.00 deposit fee suitable for the purpose of (upon court order) disbursement to the court appointed attorney ad litem in the case.</b>	<b>\$461.00</b>
<b>Application To Determine Heirship (You will receive a separate bill from the Daily Commercial Record for the publication of your Citation. The bill must be paid before the citation will be returned.) Note: Add a \$500.00 deposit fee suitable for the purpose of disbursement (upon court order) to the court appointed attorney ad litem in the case.</b>	<b>\$433.00</b>
<b>Application for Letters of Guardianship: If guardianship of the person, add a \$25 Court Investigator's Service fee. If guardian of the person, add a \$100 deposit for Bond fee. Other than the ward's or proposed ward's family member or an attorney: Add \$10 per applicant for access to Criminal History Records. Add an additional \$84 for service upon the proposed ward if being served within Dallas County by a Constable. Add an additional \$4 if proposed ward is being served out of Dallas County by a Constable, Sheriff or by a Private Process Server. A proposed ward 12 years of age or older must be personally served (no exceptions.) Note: Add a \$500.00 deposit fee suitable for the purpose of disbursement (upon court order) to the court appointed attorney ad litem in the case.</b>	<b>\$360.00</b>

A proposed ward 12 years of age or older must be personally served (no exceptions.)
