

AVISO DE ELECCIÓN DE BONOS

A LOS VOTANTES CALIFICADOS RESIDENTES DEL
DISTRITO ESCOLAR INDEPENDIENTE DE DALLAS

SE LES INFORMA que se llevará a cabo una elección en el Distrito Escolar Independiente de Dallas el 2 de mayo de 2026 sobre la emisión de bonos de conformidad con una orden que substancialmente expresa lo siguiente:

UNA ORDEN QUE CONVOCA A UNA ELECCIÓN DE BONOS A CELEBRARSE POR PARTE DEL DISTRITO ESCOLAR INDEPENDIENTE DE DALLAS, HACIENDO LAS PREVISIONES PARA LA REALIZACIÓN DE LA ELECCIÓN Y LA RESOLUCIÓN DE OTROS ASUNTOS RELACIONADOS CON DICHA ELECCIÓN

CONSIDERANDO QUE, la Junta de Síndicos (la *Junta*) del DISTRITO ESCOLAR INDEPENDIENTE DE DALLAS (el *Distrito*), con sede en el Condado de Dallas, Texas (el *Condado*), falla y determina que se debe llevar a cabo una elección especial (la *Elección*) para determinar si se deberá autorizar al Distrito a emitir bonos en la cantidad y para los fines identificados en la presente Orden (la *Orden*); y

CONSIDERANDO QUE, el Distrito celebrará un contrato con el Condado, actuando por y a través de su administrador electoral (el *Administrador*) para llevar a cabo todos los aspectos de la Elección para todos los votantes registrados del Distrito; y

CONSIDERANDO QUE, se podrá celebrar la Elección de forma conjunta con otras subdivisiones políticas (referidas de forma colectiva como las *Participantes*), según lo establecido en las disposiciones de un contrato de elección conjunta o similar de conformidad con el Código Electoral de Texas, según enmendado (el *Código*); y

CONSIDERANDO QUE, la Junta por la presente falla y determina que las mejoras importantes previstas, identificadas en la Medida A y la Propuesta A correspondiente, pueden someterse a las personas con derecho a voto del Distrito como una medida única y la propuesta correspondiente de acuerdo con la Sección 45.003(g) del Código Educativo de Texas, ya que estas mejoras importantes se utilizarán principalmente con fines educativos y administrativos, ninguna de las cuales son del tipo de las instalaciones descritas en la Sección 45.003(g)(1-6) del Código Educativo de Texas; y

CONSIDERANDO QUE, la Junta por la presente falla y determina que las mejoras importantes previstas, identificadas en la Medida B y la Propuesta B correspondiente, deben someterse a las personas con derecho a voto del Distrito como una medida adicional y la propuesta correspondiente ya que estas instalaciones son del tipo de las instalaciones descritas en la Sección 45.003(g)(6) del Código Educativo de Texas; y

CONSIDERANDO QUE, la Junta por la presente falla y determina que el bono de refinanciamiento identificado en la Medida C y la Propuesta C correspondiente se presentó correctamente a los votantes con derecho a voto del Distrito; y

CONSIDERANDO QUE, la Junta por la presente falla y determina que las mejoras importantes previstas, identificadas en la Medida D y la Propuesta D correspondiente, deben someterse a las personas con derecho a voto del Distrito como una medida adicional y la propuesta correspondiente ya que estas instalaciones son del tipo de las instalaciones descritas en la Sección 45.003(g)(2) del Código Educativo de Texas; y

CONSIDERANDO QUE, la Junta por la presente falla y determina que las acciones descritas anteriormente redundan en beneficio de los intereses primordiales de los residentes del Distrito; por lo tanto,

ORDÉNESE POR PARTE DE LA JUNTA DE SÍNDICOS DEL DISTRITO ESCOLAR INDEPENDIENTE DE DALLAS QUE:

SECCIÓN 1. Elección Ordenada; Objetivo; Monto. Se llevará a cabo la Elección en el DISTRITO ESCOLAR INDEPENDIENTE DE DALLAS el día 2 de mayo de 2026 (*Día de la Elección*), que es una fecha uniforme de elección bajo el Código y está a 78 días o más de la fecha de la adopción de esta Orden, con el propósito de someter los siguientes asuntos legales a las personas con derecho a voto del Distrito:

Medida A

¿Deberá la Junta de Síndicos del Distrito Escolar Independiente de Dallas recibir la autorización para emitir y vender bonos del Distrito, en una o más series, por un monto de capital total que no excederá de \$5,928,820,000 con el fin de (1) diseñar, construir, renovar, mejorar, actualizar, modernizar, adquirir y equipar instalaciones escolares (y cualquier remoción necesaria o relacionada de las instalaciones existentes) incluido pero no limitado (a) seguridad y protección, (b) escuelas de reemplazo nuevas, (c) escuelas renovadas, (d) instalaciones de educación física y (e) infraestructura tecnológica en todo el distrito, (2) la compra de los predios necesarios para las instalaciones escolares y (3) la compra de nuevos autobuses escolares, vehículos de transporte estudiantil y dispositivos de seguridad para los autobuses escolares, tales bonos vencerán, devengarán intereses y serán emitidos y vendidos según lo permita la ley; y se autorizará a la Junta de Síndicos del Distrito para imponer y comprometer, y hacer que se calculen y recauden impuestos anuales ad valorem sobre toda propiedad gravable en el Distrito de manera suficiente, sin límite en cuanto a la tasa o cantidad, para pagar el capital y los intereses sobre los bonos?

Medida B

¿Deberá la Junta de Síndicos del Distrito Escolar Independiente de Dallas recibir la autorización para emitir y vender bonos del Distrito, en una o más series, por un monto de capital total que no excederá de \$144,700,000 con el fin de adquirir,

actualizar, mejorar, modernizar e instalar tecnología para estudiantes, profesores y personal (incluidos hardware y software), tales bonos vencerán, devengarán intereses y serán emitidos y vendidos según lo permita la ley; y se autorizará a la Junta de Síndicos del Distrito para imponer y comprometer, y hacer que se calculen y recauden impuestos anuales ad valorem sobre toda propiedad gravable en el Distrito de manera suficiente, sin límite en cuanto a la tasa o cantidad, para pagar el capital y los intereses sobre los bonos?

Medida C

¿Deberá la Junta de Síndicos del Distrito Escolar Independiente de Dallas recibir la autorización para emitir y vender bonos del Distrito, en una o más series, por un monto de capital total que no excederá de \$143,340,000 con el fin de reembolsar la totalidad o una parte del capital, los intereses y la prima de rescate de ciertas obligaciones fiscales para mantenimiento emitidas previamente denominadas "Pagares de Construcción Escolar Calificados con Impuesto para Mantenimiento Limitado Serie Imponible 2013" con fecha del 1º de diciembre de 2013, tales bonos vencerán, devengarán intereses y serán emitidos y vendidos según lo permita la ley; y se autorizará a la Junta de Síndicos del Distrito para imponer y comprometer, y hacer que se calculen y recauden impuestos anuales ad valorem sobre toda propiedad gravable en el Distrito de manera suficiente, sin límite en cuanto a la tasa o cantidad, para pagar el capital y los intereses sobre los bonos?

Medida D

¿Deberá la Junta de Síndicos del Distrito Escolar Independiente de Dallas recibir la autorización para emitir y vender bonos del Distrito, en una o más series, por un monto de capital total que no excederá de \$26,250,000 con el fin de diseñar, construir, renovar, mejorar, modernizar, actualizar, adquirir y equipar instalaciones de piscina existentes e infraestructura relacionada, tales bonos vencerán, devengarán intereses y serán emitidos y vendidos según lo permita la ley; y se autorizará a la Junta de Síndicos del Distrito para imponer y comprometer, y hacer que se calculen y recauden impuestos anuales ad valorem sobre toda propiedad gravable en el Distrito de manera suficiente, sin límite en cuanto a la tasa o cantidad, para pagar el capital y los intereses sobre los bonos?

SECCIÓN 2. Método de Votación; Boletas. La Junta autoriza la votación electrónica, en papel o mediante cualquier combinación de ambos métodos. Los votantes emitirán su voto en las boletas oficiales marcando "A FAVOR" o "EN CONTRA" de las medidas anteriores con el siguiente texto en la boleta:

Propuesta A del Distrito Escolar Independiente de Dallas:

ESTE ES UN AUMENTO DEL IMPUESTO A LA PROPIEDAD; la emisión de bonos por un monto de \$5,928,820,000 para instalaciones , terrenos y autobuses escolares, incluido (a) seguridad y protección, (b) escuelas de reemplazo nuevas, (c) escuelas renovadas, (d) instalaciones de educación física y (e) infraestructura tecnológica

en todo el distrito, y la imposición de impuestos suficientes para pagar el capital y los intereses de los bonos.

Propuesta B del Distrito Escolar Independiente de Dallas:

ESTE ES UN AUMENTO DEL IMPUESTO A LA PROPIEDAD; la emisión de bonos por un monto de \$144,700,000 para actualizaciones tecnológicas para estudiantes, profesores y personal y la imposición de impuestos suficientes para pagar el capital y los intereses de los bonos.

Propuesta C del Distrito Escolar Independiente de Dallas:

ESTE ES UN AUMENTO DEL IMPUESTO A LA PROPIEDAD; la emisión de bonos por un monto de \$143,340,000 para reembolsar la totalidad o una parte del capital, los intereses y la prima de rescate de ciertas obligaciones fiscales para mantenimiento emitidas previamente del distrito, y la imposición de impuestos suficientes para pagar el capital y los intereses de los bonos.

Propuesta D del Distrito Escolar Independiente de Dallas:

ESTE ES UN AUMENTO DEL IMPUESTO A LA PROPIEDAD; la emisión de bonos por un monto de \$26,250,000 para instalaciones de piscina existente y la imposición de impuestos suficientes para pagar el capital y los intereses de los bonos.

SECCIÓN 3: Detalles de la Votación

A. Se establecen uno o más precintos electorales del Distrito para el Día de la Elección de 7:00 a.m. a 7:00 p.m. con uno o más centros de votación correspondientes según se identifica en el Anexo A de esta Orden. Según lo permite el Código, los centros de votación pueden cambiarse sin necesidad de acción adicional por parte de la Junta; cualquier cambio no afectará esta Orden ni el aviso de elección posterior.

B. El Anexo A también incluye los lugares, fechas y horarios para la votación anticipada en persona. Según lo permite el Código, esta información puede cambiarse sin necesidad de acción adicional por parte de la Junta; cualquier cambio no afectará esta Orden ni el aviso de elección posterior. Las solicitudes de votación por correo deberán ser recibidas a más tardar al cierre de operaciones del 20 de abril de 2026. Las solicitudes deben enviarse al Secretario de Votación Anticipada que se indica más adelante. Si una solicitud de boleta por correo se envía por fax o correo electrónico (o si una solicitud de tarjeta postal federal se envía por fax), el solicitante también debe enviar el original por correo.

SECCIÓN 4. Funcionarios Electorales.

A. El Administrador nombrará a los trabajadores electorales de conformidad con los requisitos legales, incluido el acceso a traductores de español y de cualquier otro idioma que sea necesario.

B. El Secretario de Votación Anticipada es Paul Adams; dirección de correo y física: 1520 Round Table Drive, Dallas, Texas 75247; teléfono: (469) 627-8683; fax: (214) 819-6301; y correo electrónico: Paul.Adams@DallasCounty.org. El Secretario de Votación Anticipada designará a los Secretarios de Votación Anticipada Suplentes.

C. El Administrador está autorizado a establecer una Junta Electoral de Votación Anticipada y a designar al Juez Titular de la Junta Electoral de Votación Anticipada, y si fuera necesario, a los miembros del Comité de Verificación de Firmas.

D. El Distrito está autorizado para utilizar una Estación Central de Escrutinio (la *Estación*) según sea necesario. El Administrador o la persona designada por el mismo es designado Gerente de la Estación con autoridad para nombrar al Supervisor de Cómputo, al Programador y a cualquier Secretario.

SECCIÓN 5. Cumplimiento Jurídico. La Elección y el aviso de Elección se realizarán y llevarán a cabo de conformidad con el Código y cualquier otra ley aplicable. En la medida requerida por la ley, los materiales relativos a la Elección serán impresos en inglés, español y en cualquier otro idioma requerido.

SECCIÓN 6. Obligaciones de Deuda. La siguiente información se calcula con base en las condiciones del mercado de bonos a la fecha de adopción de esta Orden; se explica con más detalle en uno o más documentos informativos para los votantes adjuntos a esta Orden como anexos; y no pretende servir como límite u otra restricción en caso de que los bonos sean autorizados en la Elección.

A. El monto total del capital pendiente de la deuda del Distrito ascendió a \$5,423,980,000 (incluida la deuda por impuesto de mantenimiento, si hubiere).

B. El monto total de los intereses adeudados sobre las obligaciones de deuda del Distrito, al vencimiento respectivo, ascendió a \$3,548,208,442.

C. El Distrito impuso una tasa fiscal ad valorem del servicio de deuda para las obligaciones de deuda pendientes de \$0.242035 por cada \$ 100 de valuación tasada gravable.

D. La fecha de vencimiento de los bonos propuestos no excederá el número máximo de años autorizado por la ley.

E. La tasa de interés máxima para cualquier serie de bonos autorizados en la Elección es del 5.00% (expresado como una tasa de interés efectiva neta).

SECCIÓN 7. Autoridad Contratante. La Junta autoriza al Presidente de la Junta del Distrito, al Superintendente de Escuelas, o a las personas designadas, para negociar y celebrar uno o más contratos de elección conjunta, contratos de servicios electorales o contratos similares con el Condado, actuando por y a través del Administrador, y cualquiera de las Participantes, si se desea o si se requiere para cumplir con la legislación aplicable.

SECCIÓN 8. Modificaciones. La Junta reconoce que la información requerida para completar los Anexos de esta Orden puede no estar disponible cuando se ordene la Elección y,

por lo tanto, la Junta autoriza al Superintendente de Escuelas del Distrito, al Presidente de la Junta o a sus designados a corregir, modificar o cambiar los Anexos. Además, la Junta autoriza a estas personas a efectuar las modificaciones técnicas que sean necesarias a esta Orden para cumplir con la ley aplicable o para llevar a cabo el objetivo de la Junta, según se evidencia en la presente Orden.

SECCIÓN 9. Conclusiones. Los considerandos de esta Orden resultan verdaderos.

SECCIÓN 10. Conflictos. Todas las órdenes y resoluciones, o partes de las mismas, que entren en conflicto o sean inconsistentes con cualquier disposición de la presente Orden quedan derogadas por la presente, en la medida de dicho conflicto, y las disposiciones de la presente Orden serán y permanecerán vigentes con respecto a los asuntos ordenados en el presente documento.

SECCIÓN 11. Ley Aplicable. La presente Orden será interpretada y aplicada de acuerdo con las leyes del Estado de Texas y de los Estados Unidos de América.

SECCIÓN 12. Reuniones Abiertas. Se determina que la reunión en la que se adoptó esta Orden estuvo abierta al público y que se proporcionó el aviso público de la hora, lugar y objeto del asunto público a considerarse en la reunión, incluyendo la presente Orden.

SECCIÓN 13. Divisibilidad. Si cualquier disposición de la presente Orden o su aplicación a cualquier persona o circunstancia se considera inválida, entonces el resto de la misma permanece en vigor.

SECCIÓN 14. Fecha de Entrada en Vigor. La presente Orden entra en vigor inmediatamente después de su aprobación.
