The Criminal Justice Department (CJD) is actively working with our IT team and other stakeholders to restore the functionality of our Detention Early Warning Report (DEWR) tool, which provides an important internal snapshot of our jail population. The DEWR bucket mechanics were disrupted after the implementation of Odyssey 05/2023, manual research is currently required to gather bucket data.
