The above-entitled and numbered cause is *Holmes, et al. v. Varsity EmergencHealth Holdings, LLC, et al.*, No. 25-BC01A-0010. This is a case filed by Plaintiffs Ted Holmes, Renaye Jenkins, and Ken Stackhouse (“Plaintiffs”) against Defendants EH Holdings, EHMC, Jeffrey Link, Harold Bolnick, and Matthew Mitchell (“Defendants”). Plaintiffs allege that Defendants promised Plaintiffs ownership interests in a joint venture, EmergencHealth, LLC, that were never granted. On March 6, 2026, the Court granted summary judgment in favor of Defendants. The documents subject to EH Holdings and EHMC’s motion to seal are proprietary strategic and financial records that were produced by Plaintiffs and Defendants in response to discovery requests.
