Dallas County Reports 876 New Positive 2019 Novel Coronavirus (COVID-19) Cases Including 222 Probable Cases

DALLAS -- As of 6:00 pm November 7, 2020, Dallas County Health and Human Services is reporting 876 additional positive cases of 2019 novel coronavirus (COVID-19) in Dallas County, 654 confirmed cases and 222 probable cases. There is a cumulative total of 101,282 cases (PCR test), including 1,130 confirmed deaths. There is a cumulative total of 8,225 probable cases (antigen test), including 18 probable deaths.

The additional deaths being reported today includes the following:

- A man in his 60's who was a resident of the City of Dallas. He had been critically ill in an area hospital, and had underlying high risk health conditions.

The provisional seven-day average of daily new confirmed and probable cases (by date of test collection) for CDC week 44 still remains high at **740**. The percentage of respiratory specimens testing positive for SARS-CoV-2 also still remains high at **14.9%** of symptomatic patients presenting to area hospitals testing positive in week 44 (week ending 10/31/20). A provisional total of 577 confirmed and probable COVID-19 cases were diagnosed in school-aged children (5 to 17 years) during CDC week 44.


Of all confirmed cases requiring hospitalization to date, more than two-thirds have been under 65 years of age. Diabetes has been an underlying high-risk health condition reported in about a third of all hospitalized patients with COVID-19. Of the total confirmed deaths reported to date, about 24% have been associated with long-term care facilities. New cases are being reported as a daily aggregate, with a more detailed summary report updated Tuesdays and Fridays. Friday's report is attached.


Local health experts use hospitalizations, ICU admissions, and ER visits as three of the key indicators as part of determining the COVID-19 Risk Level (color-coded risk) and corresponding guidelines for activities during our COVID-19 response. There were 501 COVID-19 patients in acute care in Dallas County for the period ending on Friday, November 6. The number of emergency room visits for COVID-19 like symptoms in Dallas County was 500 for the same time period, which represents around 20 percent of all emergency department visits in the county according to information reported to the North Central Texas Trauma Regional Advisory Council. The Centers for Disease Control and Prevention (CDC) recommends taking everyday preventive actions to help prevent the spread of respiratory diseases, including:

- Avoid close contact outside your home: Put 6 feet of distance between yourself and people who don't live in your household.
- Cover your mouth and nose with a cloth face cover when around others and continue to keep about 6 feet between yourself and others. The cloth face cover is not a substitute for social distancing.
- Stay home when you are sick, except to seek medical care
- Wash your hands often and with soap and water for at least 20 seconds and help young children to do the same. If soap and water are not available, use an alcohol-base hand sanitizer with at least 60% alcohol.
- Avoid touching your eyes, nose, and mouth with unwashed hands.
- Avoid close contact with people who are sick.
- Clean and disinfect frequently touched objects and surfaces daily using a regular household cleaning spray or wipes.
- Cover your cough or sneeze with a tissue, then throw the tissue in the trash. If you do not have a tissue, use your sleeve, not your hands. Immediately wash your hands.
- Monitor your health daily. Be alert for symptoms. Take your temperature and follow CDC guidance if symptoms develop.
