Dallas County Reports 309 New Positive 2019 Novel Coronavirus (COVID-19) Cases and 3 Deaths, Including 90 Probable Cases

DALLAS -- As of 3:00 pm June 29, 2021 Dallas County Health and Human Services is reporting 309 additional positive cases of 2019 novel coronavirus (COVID-19) in Dallas County, 219 confirmed cases and 90 probable cases. There is a cumulative total of 262,929 confirmed cases (PCR test). There is a cumulative total of 43,488 probable cases (antigen test). A total of 4,125 Dallas County residents have lost their lives due to COVID-19 illness. Due to the new cadence for reporting, today's release includes the numbers of new cases from Saturday, Sunday and Monday.

Dallas County Health and Human Services (DCHHS) is providing initial vaccinations to those most at risk of exposure to COVID-19 and over 495,000 total doses of COVID-19 vaccine have been administered at the Fair Park mega-vaccine clinic, which started operations on Monday, January 11. The additional deaths being reported today include the following:

- A man in his 70's who was a resident of the City of Mesquite. He had been critically ill in an area hospital and had underlying high risk health conditions.
- A woman in her 70's who was a resident of the City of Irving. She had had been critically ill in an area hospital and had underlying high risk health conditions.
- A woman in her 80's who was a resident of the City of Irving. She had been hospitalized and did not have underlying high risk health conditions.

To date, a total of 148 cases with SARS-CoV-2 variants of concern have been identified in residents of Dallas County, including: 113 cases of variant B.1.1.7 (Alpha); two B.1.351 (Beta) variants; nine B.1.617.2 (Delta) variants; nine B.1.429 (Epsilon) variants; and fifteen P.1 (Gamma) variants. Sixteen have been hospitalized and three have died. One fully vaccinated patient subsequently became ill from B.1.1.7 infection and died. The provisional seven-day average of daily new confirmed and probable cases (by date of test collection) for CDC week 24 (week ending 6/19/21), was **78**, which is a rate of **3.0** daily new cases per 100,000 residents. Over the past 2 weeks, rates of new COVID-19 diagnoses in the cities of Addison, Lancaster, Sachse and Seagoville have been about 50% higher than county-wide case rates. Rates of new COVID-19 diagnoses in the city of Cedar Hill, Garland and Rowlett have been about 30% higher than county-wide case rates.

As of the week ending 6/19/2021, about 57% of Dallas County residents age 12 years and older have received at least one dose of COVID-19 vaccine, including: 83% of residents age 65 years and older; 63% of residents between 40-64 years of age; 49% of residents 25-39 years of age; 38% of residents 18-24 years of age; and 23% of residents 12-17 years of age. In the cities of Coppell and Sunnyvale, greater than 85% of residents 18 years of age and older have received at least one dose of COVID-19 vaccine. In the cities of Addison and Highland Park, about 75% of residents 18 years of age and older have received at least one dose of COVID-19 vaccine (*See below*). About 91% of COVID-19 cases diagnosed in June were in Dallas County residents who were not fully vaccinated. In Dallas County, 830 cases of COVID-19 breakthrough COVID-19 infections in fully

vaccinated individuals have been confirmed to date, of which 82 (10%) were hospitalized due to COVID-19 and 12 have died.

During the months of April, May and June, 20% of all COVID-19 cases diagnosed in Dallas County were in children under the age of 18 years. To date, 67 children have been hospitalized with diagnoses of multisystem inflammatory syndrome (MIS-C), a rare but serious complication associated with COVID-19 infection. Of symptomatic patients presenting to area hospitals in week 24 (week ending 6/19/21), **4.7%** of respiratory specimens tested positive SARS-CoV-2. For week 24, area hospital labs have continued to report elevated numbers and proportions of respiratory specimens that are positive for other respiratory viruses by molecular tests: parainfluenza (16%), rhinovirus/enterovirus (24%) and **RSV (21%)**.

There are currently 8 active long-term care facility outbreaks. A cumulative total of 4,403 residents and 2,479 healthcare workers in long-term facilities in Dallas have been diagnosed with COVID-19. Of these, 1,124 have been hospitalized and 802 have died. About 20% of all deaths reported to date have been associated with long-term care facilities. One outbreak of COVID-19 in a congregate-living facility (e.g. homeless shelters, group homes, and halfway homes) has been reported in the past 30 days. A cumulative total of 639 residents and 225 staff members in congregate-living facilities in Dallas have been diagnosed with COVID-19. Local health experts use hospitalizations, ICU admissions, and ER visits as three of the key indicators as part of determining the COVID-19 Risk Level (color-coded risk) and corresponding guidelines for activities during our COVID-19 response. The most recent COVID-19 hospitalization data for Dallas County, as reported to the North Central Texas Trauma Regional Advisory Council, can be found at www.dallascounty.org/covid-19 under “Monitoring Data,” and is updated regularly. This data includes information on the total available ICU beds, suspected and confirmed COVID-19 ER visits in the last 24 hours, confirmed COVID-19 inpatients, and COVID-19 deaths by actual date of death. 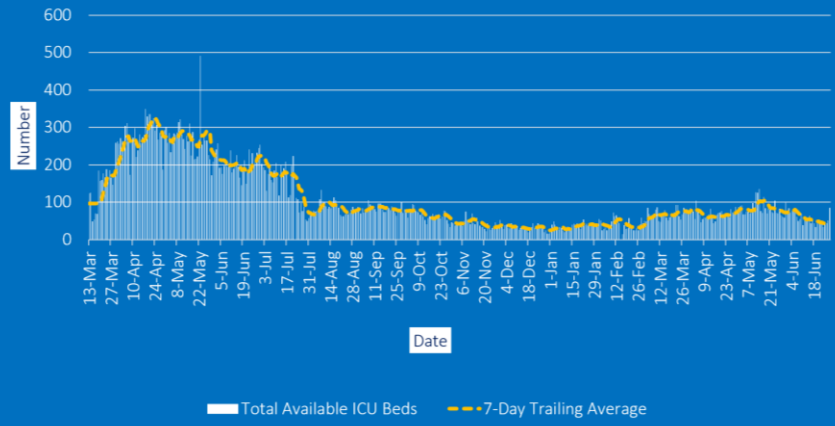

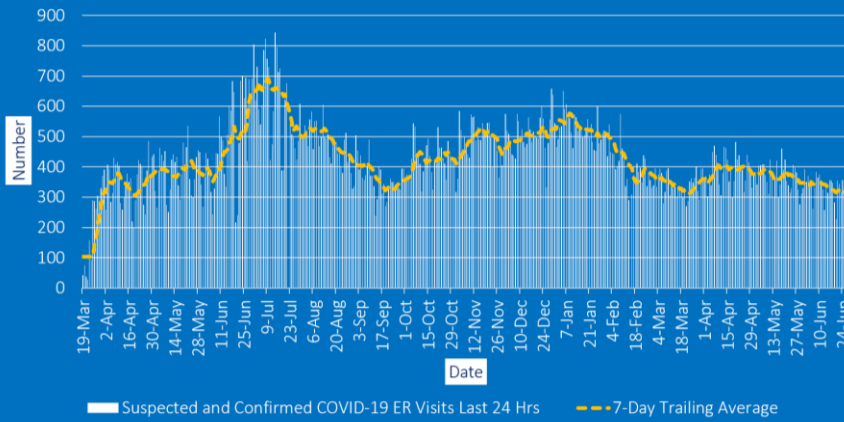

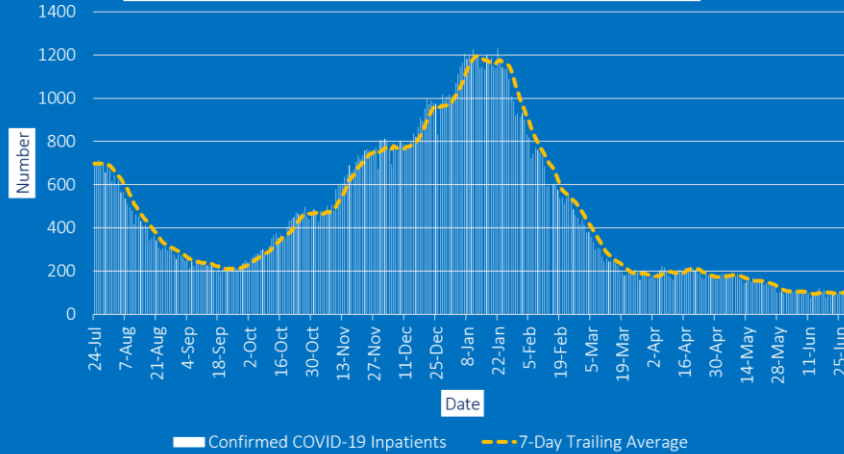
Trend for Total Available ICU Beds in Dallas County, June 28, 2021



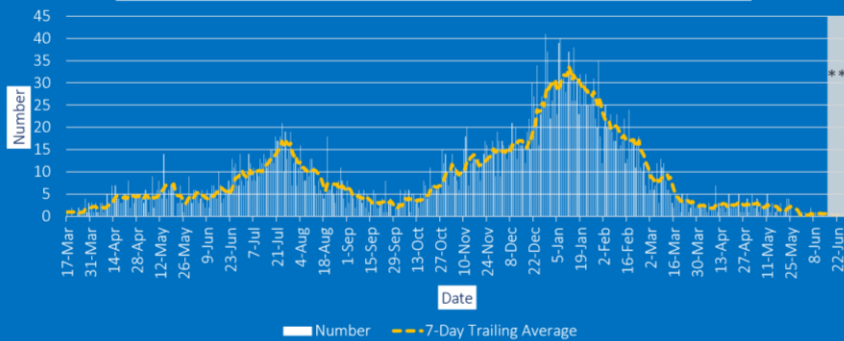
Trend for Suspected and Confirmed COVID-19 ER Visits in the Last 24 Hours in Dallas County, June 28, 2021

The Centers for Disease Control and Prevention (CDC) recommends taking everyday preventive actions to help prevent the spread of respiratory diseases, including:

- If you’re unvaccinated, avoid close contact outside your home and put 6 feet of distance between yourself and people who don’t live in your household.
- Cover your mouth and nose with a cloth face cover when around others and continue to keep about 6 feet between yourself and others. The cloth face cover is not a substitute for social distancing.
- Stay home when you are sick, except to seek medical care
- Wash your hands often and with soap and water for at least 20 seconds and help young children to do the same. If soap and water are not available, use an alcohol-base hand sanitizer with at least 60% alcohol.
- Avoid touching your eyes, nose, and mouth with unwashed hands.
- Avoid close contact with people who are sick.
- Clean and disinfect frequently touched objects and surfaces daily using a regular household cleaning spray or wipes.
- Cover your cough or sneeze with a tissue, then throw the tissue in the trash. If you do not have a tissue, use your sleeve, not your hands. Immediately wash your hands.
- Monitor your health daily. Be alert for symptoms. Take your temperature and follow CDC guidance if symptoms develop.
