**Dallas County Reports Total of 1,147 New Positive 2019 Novel Coronavirus (COVID-19) Cases and 22 Deaths, Including 206 Probable Cases**

**DALLAS** -- As of 1:00 pm September 24, 2021 Dallas County Health and Human Services is reporting 1,147 additional positive cases of 2019 novel coronavirus (COVID-19) in Dallas County, 941 confirmed cases and 206 probable cases. There is a cumulative total of 326,299 confirmed cases (PCR test). There is a cumulative total of 56,878 probable cases (antigen test). A total of 4,604 Dallas County residents have lost their lives due to COVID-19 illness.

Dallas County Health and Human Services (DCHHS) provided more than 500,000 total doses of COVID-19 vaccine at the Fair Park mega-vaccine clinic, which operated January 11 through July 17. A pop-up vaccination clinic took place at Fair Park through September 18. DCHHS will make the vaccine available every day the State Fair is open, from 10am-6pm, at a clinic located behind Big Tex between the Tower and Grand buildings.

To date, a total of 205 cases with SARS-CoV-2 variants of concern have been identified in residents of Dallas County, including: 146 cases of B.1.1.7 (Alpha) variants; three B.1.351 (Beta) variants; thirty-six B.1.617.2 (Delta) variants; and twenty P.1 (Gamma) variants. Twenty-three have been hospitalized and four have died. One fully vaccinated patient subsequently became ill from B.1.1.7 infection and died. The provisional seven-day average of daily new confirmed and probable cases (by date of test collection) for CDC week 37 (week ending 9/18/21) was **934**, which is a rate of **35.4** daily new cases per 100,000 residents.

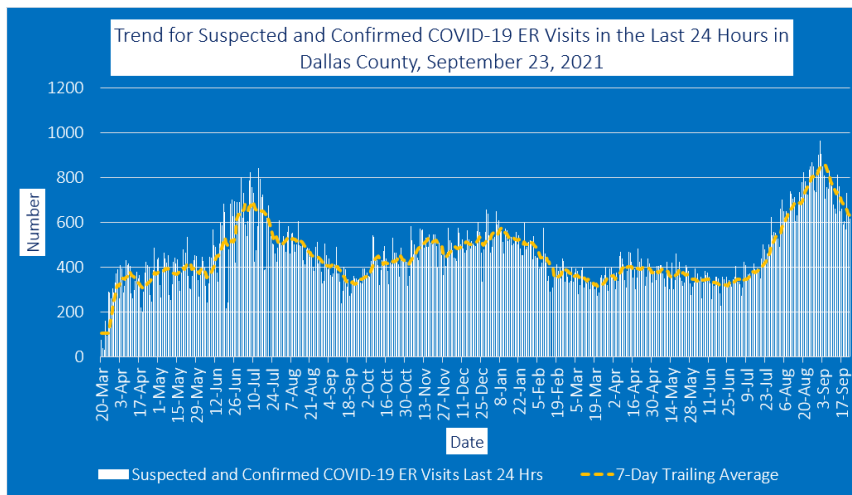
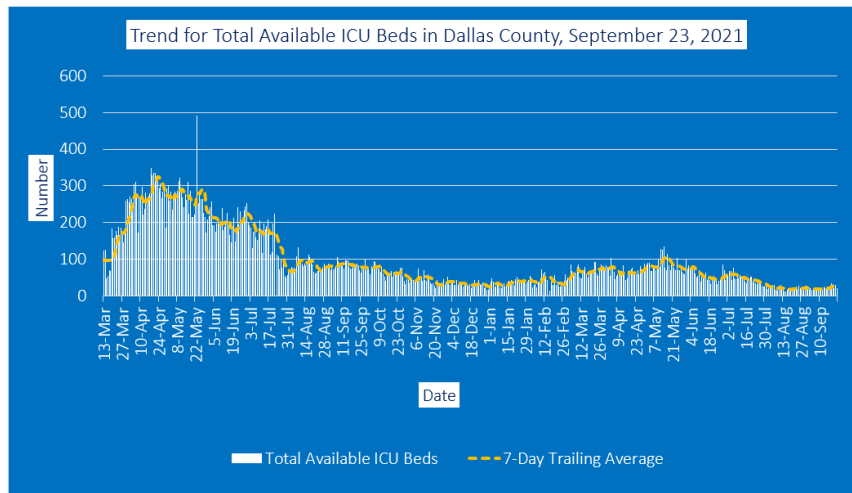
As of the week ending 9/18/2021, about 69% of Dallas County residents age 12 years and older have received at least one dose of COVID-19 vaccine, including: 89% of residents age 65 years and older; 76% of residents between 40-64 years of age; 65% of residents 25-39 years of age; 55% of residents 18-24 years of age; and 51% of residents 12-17 years of age. In the cities of Addison, Coppell, and Sunnyvale, greater than 90% of residents 18 years of age and older have received at least one dose of COVID-19 vaccine. In the cities of Highland Park and Irving, greater than 80% of residents 18 years of age and older have received at least one dose of COVID-19 vaccine. (See below). About 83% of COVID-19 cases diagnosed in Week 37 were Dallas County residents who were not fully vaccinated. In Dallas County, 8,946 cases of COVID-19 breakthrough COVID-19 infections in fully vaccinated individuals have been confirmed to date, of which 403 (4.5%) were hospitalized and 73 have died due to COVID-19.

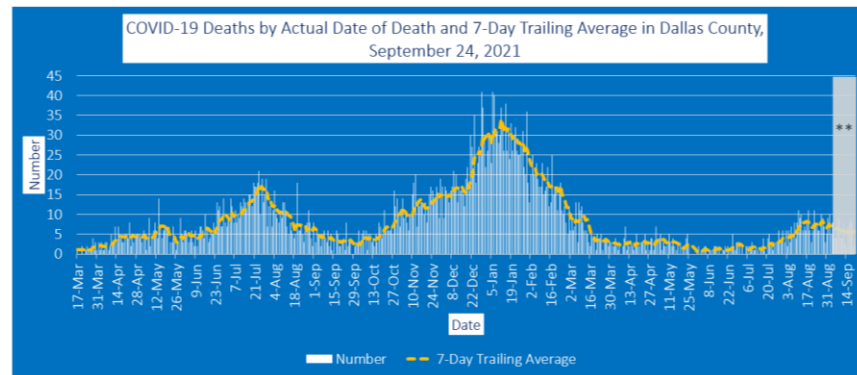
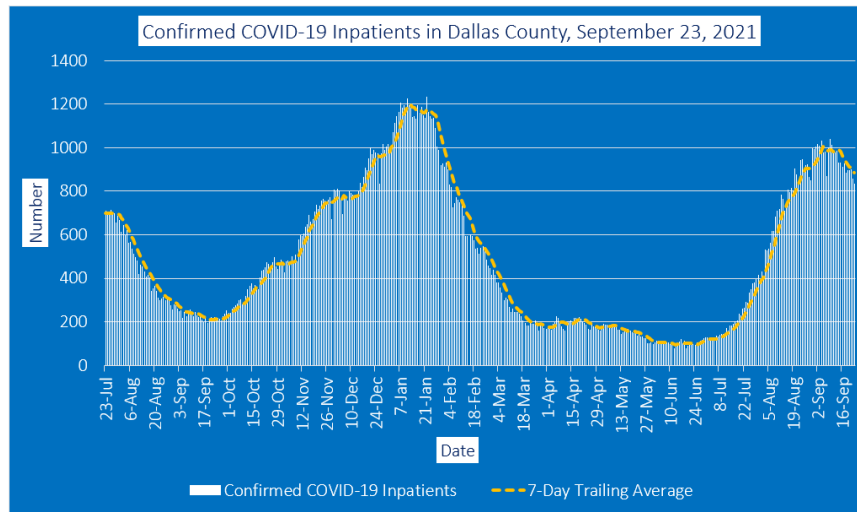
Of all Dallas County residents tested for COVID-19 by PCR during the week ending 9/18/2021 (CDC week 37), **13.5%** of respiratory specimens tested positive for SARS-CoV-2. For week 37, area hospital labs have continued to report elevated numbers and proportions of respiratory specimens that are positive for other respiratory viruses by molecular tests: parainfluenza (1.9%), rhinovirus/enterovirus (33%) and RSV (10%). There are currently 68 active long-term care facility outbreaks. A cumulative total of 4,647 residents and 2,750 healthcare workers in long-term facilities in Dallas have been diagnosed with COVID-19. Of these, 1,159 have been hospitalized and 830 have died. About 18% of all deaths reported to date have been associated with long-term care facilities.

There have been 15 outbreaks of COVID-19 in a congregate-living facility (e.g. homeless shelters, group homes, and halfway homes) reported within the past 30 days. A cumulative total of 728 residents and 244 staff members in congregate-living facilities in Dallas have been diagnosed with COVID-19. New cases are being

Local health experts use hospitalizations, ICU admissions, and ER visits as three of the key indicators as part of determining the COVID-19 Risk Level (color-coded risk) and corresponding guidelines for activities during our COVID-19 response. “Although we are beginning to trend slightly down in hospitalizations, our death numbers remain high and we are still in a time of high community spread. Please continue to wear your mask when distancing is not possible in crowds, and any time you’re in an indoor space outside your own home. If you’ve not been vaccinated, please do so as soon as possible. For those of you who are eligible for a booster shot, there should be ample supply at pharmacies and other providers near you. We will continue to have Pfizer booster shots available at all our Dallas County Health and Human Services clinics. If you still need your first or second dose, or are in search of a booster shot, please visit [vaccines.gov](https://www.vaccines.gov) to find the vaccination location nearest to you. I hope everyone has a safe and peaceful weekend,” said Dallas County Judge Clay Jenkins.

The Centers for Disease Control and Prevention (CDC) recommends taking everyday preventive actions to help prevent the spread of respiratory diseases, including:

- If you're unvaccinated, avoid close contact outside your home and put 6 feet of distance between yourself and people who don't live in your household.
- Cover your mouth and nose with a cloth face cover when around others and continue to keep about 6 feet between yourself and others. The cloth face cover is not a substitute for social distancing.
- Stay home when you are sick, except to seek medical care
- Wash your hands often and with soap and water for at least 20 seconds and help young children to do the same. If soap and water are not available, use an alcohol-base hand sanitizer with at least 60% alcohol.
- Avoid touching your eyes, nose, and mouth with unwashed hands.
- Avoid close contact with people who are sick.
- Clean and disinfect frequently touched objects and surfaces daily using a regular household cleaning spray or wipes.
- Cover your cough or sneeze with a tissue, then throw the tissue in the trash. If you do not have a tissue, use your sleeve, not your hands. Immediately wash your hands.
- Monitor your health daily. Be alert for symptoms. Take your temperature and follow CDC guidance if symptoms develop.
- CDC recommends that anyone with any signs or symptoms of COVID-19 get tested, regardless of vaccination status or prior infection.
- If you get tested because you have symptoms or were potentially exposed to the virus, you should stay away from others pending test results and follow the advice of your health care provider or a public health professional.
