# Dallas County Reports a Three-Day Total of 896 New Positive 2019 Novel Coronavirus (COVID-19) Cases and 17 Deaths, Including 177 Probable Cases

**DALLAS** -- As of 12:00 pm December 14, 2021 Dallas County Health and Human Services is reporting 896 additional positive cases of 2019 novel coronavirus (COVID-19) in Dallas County, 719 confirmed cases and 177 probable cases. There is a cumulative total of 353,389 confirmed cases (PCR test). There is a cumulative total of 65,551 probable cases (antigen test). A total of 5,371 Dallas County residents have lost their lives due to COVID-19 illness.

Dallas County Health and Human Services (DCHHS) provided more than 500,000 total doses of COVID-19 vaccine at the Fair Park mega-vaccine clinic, which operated January 11 through July 17. A vaccination clinic is open at the Dallas College Eastfield Campus Location on Tuesdays – Saturdays from 9am-6pm. A weekly popup vaccination clinic will take place at Fair Park on Sundays, from 10am – 4pm, starting November 21<sup>st</sup>, 2021.

- A man in his 60's who was a resident of the City of Dallas. He had been critically ill in an area hospital and had underlying high risk health conditions.

- A man in his 60's who was a resident of the City of Richardson. He was found deceased and had underlying high risk health conditions.

- A man in his 60's who was a resident of the City of Irving. He had been hospitalized and had underlying high risk health conditions.
- A man in his 70's who was a resident of the City of Dallas. He was found deceased at home and had underlying high risk health conditions.

- A woman in her 70's who was a resident of the City of Dallas. She expired in an area hospital ED and had underlying high risk health conditions.
- A woman in her 80's who was a resident of a long-term care facility in the City of Mesquite. She had been critically ill in an area hospital and had underlying high risk health conditions.
- A man in his 80's who was a resident of the City of Duncanville. He was found deceased at home and had underlying high risk health conditions.
- A woman in her 90's who was a resident of the City of Mesquite. She had been hospitalized and had underlying high risk health conditions.
- A woman in her 90's who was a resident of the City of Dallas. She expired in an area hospital ED and had underlying high risk health conditions.

To date, a total of 419 cases with SARS-CoV-2 variants have been identified in residents of Dallas County, including: 138 cases of B.1.1.7 (Alpha); 3 cases of B.1.351 (Beta); 237 cases of B.1.617.2 (Delta); 10 cases of B.1.427 (Epsilon); 19 cases of P.1 (Gamma); 9 cases of B.1.526 (Iota); 1 case of C.37 (Lambda); 1 case of B.1.621 (Mu); and 1 case of P.2 (Zeta). Eighty-six cases have been hospitalized and 8 have died. Seven COVID-19 variant cases were reinfections. Eight-five people were considered fully vaccinated before infection with a COVID-19 variant. As of 12/10/2021, a total of **2,165** confirmed and probable cases were reported in CDC week 48 (week ending 12/4/21), which is a weekly rate of **82.1** new cases per 100,000 residents.


As of the week ending 12/4/2021, about 76% of Dallas County residents age 12 years and older have received at least one dose of COVID-19 vaccine, including: 95% of residents age 65 years and older; 81% of residents between 40-64 years of age; 72% of residents 25-39 years of age; 61% of residents 18-24 years of age; and 57% of residents 12-17 years of age. In the cities of Addison, Coppell, Highland Park, Irving, and Sunnyvale, greater than 90% of residents 18 years of age and older have received at least one dose of COVID-19 vaccine. In the cities of Desoto, Farmers Branch, and Garland, greater than 80% of residents 18 years of age and older have received at least one dose of COVID-19 vaccine. (See below).


About 71.6% of COVID-19 cases diagnosed in Week 48 were Dallas County residents who were not fully vaccinated. In Dallas County, 20,552 cases of COVID-19 breakthrough COVID-19 infections in fully vaccinated individuals have been confirmed to date, of which 747 (3.6%) were hospitalized and 187 have died due to COVID-19. Of all Dallas County residents tested for COVID-19 by PCR during the week ending 12/4/2021 (CDC week 48), **6.6%** of respiratory specimens tested positive for SARS-CoV-2. For week 48, area hospital labs have continued to report elevated numbers and proportions of respiratory specimens that are positive for other respiratory viruses by molecular tests: parainfluenza (7.0%), rhinovirus/enterovirus (27.0%) and RSV (5.0%).


There are currently 22 active long-term care facility outbreaks. A cumulative total of 4,878 residents and 2,891 healthcare workers in long-term facilities in Dallas have been diagnosed with COVID-19. Of these, 1,198 have been hospitalized and 848 have died. About 16% of all deaths reported to date have been associated with long-term care facilities. There have been 4 outbreaks of COVID-19 in a congregate-living facility (e.g. homeless shelters, group homes, and halfway homes) reported within the past 30 days. A cumulative total of 756 residents and 259 staff members in congregate-living facilities in Dallas have been diagnosed with COVID-19.

Local health experts use hospitalizations, ICU admissions, and ER visits as three of the key indicators as part of determining the COVID-19 Risk Level (color-coded risk) and corresponding guidelines for activities during our COVID-19 response. "Hospitalizations, ICU admissions, and deaths from COVID, all rise and fall with the number of cases; keeping cases low helps reduce the number of people getting severely ill. Cases are up the last week and we are showing signs of being in a growth period of the pandemic during the last 7-10 days. Allowing this growth to go unchecked, especially into the holidays and with the highly contagious Omicron variant looming, could have substantial consequences in the coming weeks and months if we don't take steps to curb spread. With the holidays upon us, now is the time to renew our efforts to ensure that 2022 is a better year for a healthy you, a healthy community and a healthy economy. Get your booster as soon as you can. It will provide you better protection against the new variant of COVID. Continue to wear your mask indoors when outside your home and at crowded outdoor venues where spacing is not possible. Stay home if you feel sick and get tested, wash your

hands frequently, and maintain a six foot distance from others. Consider masking at or testing before private gatherings, especially if larger. Increasing ventilation can also help reduce spread. These tried and true recommendation from virtually every doctor in the United States are how we best protect ourselves, our community, and our economy from COVID, so that we all can have our very best holidays this year," said Dallas County Judge Clay Jenkins.

The Centers for Disease Control and Prevention (CDC) recommends taking everyday preventive actions to help prevent the spread of respiratory diseases, including:

- If you're unvaccinated, avoid close contact outside your home and put 6 feet of distance between yourself and people who don't live in your household.
- Cover your mouth and nose with a cloth face cover when around others and continue to keep about 6 feet between yourself and others. The cloth face cover is not a substitute for social distancing.
- Stay home when you are sick, except to seek medical care
- Wash your hands often and with soap and water for at least 20 seconds and help young children to do the same. If soap and water are not available, use an alcohol-base hand sanitizer with at least 60% alcohol.
- Avoid touching your eyes, nose, and mouth with unwashed hands.
- Avoid close contact with people who are sick.
- Clean and disinfect frequently touched objects and surfaces daily using a regular household cleaning spray or wipes.
- Cover your cough or sneeze with a tissue, then throw the tissue in the trash. If you do not have a tissue, use your sleeve, not your hands. Immediately wash your hands.
- Monitor your health daily. Be alert for symptoms. Take your temperature and follow CDC guidance if symptoms develop.
- CDC recommends that anyone with any signs or symptoms of COVID-19 get tested, regardless of vaccination status or prior infection.
- If you get tested because you have symptoms or were potentially exposed to the virus, you should stay away from others pending test results and follow the advice of your health care provider or a public health professional.
