# Dallas County Reports a Total of 1,288 New Positive 2019 Novel Coronavirus (COVID-19) Cases and 15 Deaths, Including 300 Probable Cases

**DALLAS** -- As of 12:00 pm February 09, 2022 Dallas County Health and Human Services is reporting 1,288 additional positive cases of 2019 novel coronavirus (COVID-19) in Dallas County, 988 confirmed cases and 300 probable cases. There is a cumulative total of 459,395 confirmed cases (PCR test). There is a cumulative total of 96,691 probable cases (antigen test). A total of 5,841 Dallas County residents have lost their lives due to COVID-19 illness.

Dallas County Health and Human Services (DCHHS) provided more than 500,000 total doses of COVID-19 vaccine at the Fair Park mega-vaccine clinic, which operated January 11 through July 17. A vaccination clinic is open at the Dallas College Eastfield Campus Location on Thursdays – Saturdays from 9am-6pm, and on Sundays from 10am – 4pm. A weekly pop-up vaccination clinic will also take place at Fair Park on Sundays, from 10am – 4pm, starting November 21<sup>st</sup>, 2021.

- A woman in her 90's who was a resident of the City of Dallas. She had been critically ill in an area hospital and had underlying high risk health conditions.
- A man in his 90's who was a resident of the City of Dallas. He had been critically ill in an area hospital and had underlying high risk health conditions.

To date, a total of 1,196 cases with SARS-CoV-2 variants have been identified and investigated in residents of Dallas County, including: 162 cases of B.1.1.7 (Alpha); 4 cases of B.1.351 (Beta); 964 cases of B.1.617.2 (Delta); 14 cases of B.1.427 (Epsilon); 20 cases of P.1 (Gamma); 9 cases of B.1.526 (Iota); 4 case of C.37 (Lambda); 2 cases of B.1.621 (Mu); 16 cases of B.1.1.529 (Omicron); and 1 case of P.2 (Zeta). Two hundred and thirty-four cases have been hospitalized and 38 have died. Nineteen COVID-19 variant cases were reinfections. Two hundred and ninety-five people were considered fully vaccinated before infection with a COVID-19 variant.

As of 2/4/2022, a total of **12,360** confirmed and probable cases were reported in CDC week 4 (week ending 1/29/22), which is a weekly rate of **469.0** new cases per 100,000 residents.

As of the week ending 1/22/2022, about 79% of Dallas County residents age 12 years and older have received at least one dose of COVID-19 vaccine, including: 97% of residents age 65 years and older; 85% of residents between 40-64 years of age; 76% of residents 25-39 years of age; 65% of residents 18-24 years of age; and 60% of residents 12-17 years of age. In the cities of Addison, Coppell, Highland Park, Irving, and Sunnyvale, greater than 90% of residents 18 years of age and older have received at least one dose of COVID-19 vaccine. In the cities of Cedar Hill, Desoto, Farmers Branch, Garland, Lancaster, and University Park, greater than 80% of residents 18 years of age and older have received at least one dose of COVID-19 vaccine. 
About 60.7% of COVID-19 cases diagnosed in Week 4 were Dallas County residents who were not fully vaccinated. In Dallas County, 29,615 cases of COVID-19 breakthrough COVID-19 infections in fully vaccinated individuals have been confirmed to date, of which 2,689 (9.1%) were hospitalized and 429 have died due to COVID-19.


Of all Dallas County residents tested for COVID-19 by PCR during the week ending 1/29/2022 (CDC week 4), **29.6%** of respiratory specimens tested positive for SARS-CoV-2. For week 4, area hospital labs have continued to report elevated numbers and proportions of respiratory specimens that are positive for other respiratory viruses by molecular tests: parainfluenza (2.61%), rhinovirus/enterovirus (20.64%) and RSV (1.98%).


There are currently 91 active long-term care facility outbreaks. A cumulative total of 6,007 residents and 4,072 healthcare workers in long-term facilities in Dallas have been diagnosed with COVID-19. Of these, 1,258 have been hospitalized and 868 have died. About 16% of all deaths reported to date have been associated with long-term care facilities.

There have been 12 outbreaks of COVID-19 in a congregate-living facility (e.g. homeless shelters, group homes, and halfway homes) reported within the past 30 days. A cumulative total of 844 residents and 295 staff members in congregate-living facilities in Dallas have been diagnosed with COVID-19. "We're seeing some good trends with our COVID numbers in the general population of Dallas County. Our week over week numbers of positive cases has decreased by 47.4%. The youth numbers have decreased by 55.1%. And our hospitalizations at Parkland hospital have decreased by 64% week over week. The numbers across the region have not decreased that to that degree, but they have decreased in all hospitals by 28.3%. The R factor, which determines how many people are likely to be infected with each new infection was as high as two in January, so that there were two new infections for every one infection. The number is now around 0.5, meaning there is only one infection for every two infected people. This should keep our numbers going down. The decisions we make this week and next will determine how low our numbers go and how long they stay low. Please continue to wear your mask, get your booster if you've not already and get vaccinated if you've not already. Go to vaccines gov to find a vaccine near you," said Dallas County Judge Clay Jenkins.

The Centers for Disease Control and Prevention (CDC) recommends taking everyday preventive actions to help prevent the spread of respiratory diseases, including:

- If you're unvaccinated, avoid close contact outside your home and put 6 feet of distance between yourself and people who don't live in your household.
- Cover your mouth and nose with a cloth face cover when around others and continue to keep about 6 feet between yourself and others. The cloth face cover is not a substitute for social distancing.
- Stay home when you are sick, except to seek medical care
- Wash your hands often and with soap and water for at least 20 seconds and help young children to do the same. If soap and water are not available, use an alcohol-base hand sanitizer with at least 60% alcohol.
- Avoid touching your eyes, nose, and mouth with unwashed hands.
- Avoid close contact with people who are sick.
- Clean and disinfect frequently touched objects and surfaces daily using a regular household cleaning spray or wipes.
- Cover your cough or sneeze with a tissue, then throw the tissue in the trash. If you do not have a tissue, use your sleeve, not your hands. Immediately wash your hands.
- Monitor your health daily. Be alert for symptoms. Take your temperature and follow CDC guidance if symptoms develop.
- CDC recommends that anyone with any signs or symptoms of COVID-19 get tested, regardless of vaccination status or prior infection.
- If you get tested because you have symptoms or were potentially exposed to the virus, you should stay away from others pending test results and follow the advice of your health care provider or a public health professional.
