Review/Approval of Minutes

Deborah Hill called the meeting to order at 9:03 am. Deborah asked for a motion to approve the minutes. Julie Turnbull made a motion to approve the minutes. Audrey Garnett seconded the motion and the group accepted the minutes.

530 Fund Balance and Update

Deborah Hill provided an update of the 530 Fund Balance. Funding is located in two accounts, an escrow account and General Fund 120. Some funds are still being collected under the drug and intoxication fee structure; those funds are applied to the escrow account. Currently, the balance for the Felony account (4020) is \$127,640.30, the Misdemeanor account (4031) is \$20,697.45 for a total of \$135,509.85. The general fund (120) is for fees assessed on all offenses. Fund 120 has a total of \$124,587.04.

Drug Testing

Deborah Hill provided an update of the 530 specialized drug testing utilization total for FY21. Deborah reported a continued decrease in 530 drug test utilization which is attributed to CSCD's pilot program. Total invoiced under the drug testing line item is \$8,794.80, which leaves a balance of \$16,205.20.

Transitional Housing

A report was provided in the meeting packet. Transitional Housing Balance is \$28,700.00. May invoices is still pending. The update will be available in the next 530 meeting packet. There are three specialty court participants in Salvation Army transitional housing. The breakdown is one male participant and two female participants.

Request for Funding

No request for funding. The previous request was submitted for processing.

Texas State Office of Governor Update

Keta Dickerson did not provide the update due to a scheduling conflict.

Training

Deborah reported the possibility of postponement on voting of the Urban 101 Training full day vs half day training to allow time for everyone to review an email she sent out May 12, 2021 containing a more detailed description and agenda of the Urban 101 training. She also stated that Mr. McGraw expressed the agenda can be tweaked to accommodate the 530 committee's preferences. Deborah opened the floor for questions and comments. Charlene inquired when a decision needed to be made for training. Deborah reported she was unsure if the September deadline was for the approval for the training or the actual training dates. She would have to get with Mr. McGraw to clarify. She did specify that a decision for full day or half day training is required by September. Julie Turnbull requested the Deborah resend the email previously emailed May 12th for review.

Specialty Court Video Production

The goal is to complete the Specialty Court Video project before the end of FY2021. Options are open for recording to begin. Please reach out to Deborah regarding video recording availability to coordinate a schedule and begin recording. She did reach out to IT for assistance regarding the difficulty of viewing the videos. Judge Rocky Jones will be reaching out to the Mr. Owen with the production company to troubleshoot the issue as well.
