**CALL TO ORDER**: The minutes were approved without changes.

#### **GOVERNANCE**

### Dallas Area Partnership to End and Prevent Homelessness:

The Dallas Area Partnership met on August 5, 2021. All activities are in process and there was nothing new to report currently.

### Dallas County Homeless Advisory Committee: Erin Moore, Commissioner Daniel Office

The Dallas County Homeless Advisory Committee is scheduled to meet September 20. Updates from the meeting will be provided at the next Housing Work Group Meeting.

### Federal and State Legislative Update: Janie Metzinger, NTBHA

Ms. Janie Metzinger provided a legislative report on the 87<sup>th</sup> Texas Legislature that was included in the meeting packet. Ms. Metzinger reported that the overall funding for behavioral health was \$8.1 billion dollars across all articles and the supplemental House Bill 2 was a total of \$175.9 million. The total funding was \$8.4 billion for behavioral health. The new state hospitals were included in the supplemental bill, which is significant for Dallas County. The bill Includes \$44,750,000 to begin the planning stages of building a state hospital in Dallas County. In later plans there is a bed for bed replacement for Terrell State Hospital. Ms. Metzinger included an extensive review on House Bill 1925 in the legislative report which includes copies of both the senate and the house hearings. Ms Metzinger is now working on what is happening in congress and will provide a report at a later meeting date.

Presentation – DCHHS Eviction Diversion Program, Ganesh Shivaramaiyer, Asst. Director, Finance, Budget & Contracts Ganesh Shivaramaiyer provided information on the DCHHS Eviction Diversion Program (EDP). EDP is a special program/court process that allows courts to place eviction lawsuits on hold and avoid eviction proceedings. Under the EDP, payments are provided to landlords for rental arrears in exchange for allowing tenants to remain in their homes and forgiving late fees. Eligibility for the program includes being a resident of Dallas County outside of the City of Dallas, low income, non-receipt of housing assistance from any other entity/program for the same period, and being financially impacted by COVID-19. The program is unable to aid any residents with units that do not pass lead-based inspection.

The landlord will be given a 30-day window to remediate any lead-based issues. If the landlord is unable to remediate the issues the resident will be assisted in moving. City of Dallas residents are not eligible for assistance through the Dallas County eviction diversion program but will be directed to City of Dallas resources through the housing navigators. Checks written to assist with evictions will have a 3-day accelerated turnaround time to get to the landlords.

NTBHA: Eric McCarty

Eric McCarty provided a written report since he was not available to attend the meeting. Contracts are still awaiting approval and the hope is that the contracts will be in place and a new notice of funding availability will be received around Oct. 1, 2021.

**Housing Navigator**: Kimberly Rawls, Dallas County

Kimberly Rawls reported that staff is working to fill one vacancy at St. Jude Forest Lane. Lynette Gidden started as the new Senior Manager of Housing and Homelessness at the St. Jude Center on Monday July 26, 2021. The FUSE project data is in the packet with full details. Ms. Rawls reported that from July 2020 to July 2021 they screened 2,830 individuals with the goal being 3,000 individuals the first year. The goal was created when funding was originally available for two jail navigators to begin the initial set up of the program. The second housing navigator Maria Herrera began on March 29<sup>th</sup>, almost 8 months after the beginning of the program. The second position is funded through the Justice Assistance Grant (JAG) grant from the Office of the Governor. The jail navigators are currently on track to screen over 3,000 individuals for year two of the program. The program has housed 36 individuals and the goal was to house 75 individuals, but it is still commendable to meet half of the goal through the pandemic. There are 157 individuals currently enrolled and participating in the FUSE program.

Two boarding homes reapplied for the Hillcrest grant in July 2021. Kimberly will continue to research other grant opportunities.

The Connector Project provided 18 individuals rides through the FUSE program.

Housing Authority Report-Thomas Lewis, Dallas County Housing Authority.

Thomas Lewis reported that the emergency vouchers memorandum of understanding (MOU) has been signed and they are working with MDHA and Clutch Consulting. They have decided to do the briefings onsite to ensure that clients can get the Request for Tenancy Approval packet and a voucher the same day. The sooner the clients get the voucher, the sooner they can get started looking for housing, and thus get into housing. They should be getting the first set of participants the week of August 30th.

### **PROJECTS AND INDUSTRY UPDATES**

### CARES Act/ARP Funds: Hector Faulk, Dallas County

Hector Faulk reported that there is not a lot new to report because CARES is starting to wind down as they are ramping up the ARP efforts. A lot of the things they are doing in the interim surround the efforts of the housing navigator program through DCHHS. They are working on providing DCHHS staff what they need relative to boosting up that program. They are currently transitioning from CARES to ARP as they complete town hall meetings and finalize public input regarding use of the funds.

Coordinated Access System: MDHA

Report unavailable

Homeless Jail Dashboard: Kimberly Rawls, Dallas County

The data for the homeless jail dashboard is in the packet in full details. The overall jail bookins increased by 48 individuals over the past month. The overall suspected mental health bookins decreased by 25 individuals. Both the homeless and homeless with suspected mental health bookins decreased. The average length of stay for homeless bookins decreased slightly and the offense categories stayed the same.

### CitySquare: Madeline Reedy, CitySquare

Madeline Reedy reported on behalf of Edd Eason. Ms. Reedy stated that Edd wanted the group to know that they are very pleased with what the FUSE program did in the first year although the outcomes were a little lower then expected due to COVID. They are looking forward to taking what they learned this first year and continue the program for those high-end users that need navigation services in housing. The detailed report is in the packet provided.

<u>Dallas Connector:</u> Daniel Roby, Austin Street Report unavailable

### Pretrial Diversion and Mental Health Screening: Laura Edmonds, Dallas County

Laura Edmonds reported that the mental health pretrial process continues to go well. They are working to get individuals released and connected to mental health services. NTBHA continues to be a good partner.

### Homeward Bound: Doug Denton, Homeward Bound

Doug Denton reported that the detox unit had a COVID quarantine and had to close for 8 days. It was reopened 8/24/2021 with 8 beds available. They are expecting the beds to continue to be full. The health department recommended restricting the upper floors from engagement on the lower floors. That restricted a lot of activities that they normally have, and they spent a lot of time getting individuals tested to ensure there was not a spread. Crisis residential space continues to be full throughout the closing of the detox unit. The newly opened respite program in Corsicana is robust and moving forward. The Deflection Center has a lot of construction, infrastructure, electrical, and plumbing taking place right now. Doug is hoping to be able to share pictures at the next meeting if possible.

<u>Metro Dallas Youth Committee:</u> Mayra Fierro; Metro Dallas Youth Committee Report unavailable

Family Housing: Ellen Magnis, Family Gateway

Ellen Magnis was unavailable but has provided her report in the packet.

### Mattingly Report: Jim Mattingly

Mr. Mattingly reported that North Texas multifamily occupancies are running 94% full and that includes all new construction projects. When they look at what is available to lease in the North Texas market it is less than 2.5% which is historically a very low number. Last week Luma Residential had 2% of their apartments available to rent looking out for the next 60 days. That is a challenging number for those who are looking for homes.

Commissioner Daniel discussed that the City of Dallas is now voting on the Dallas Real Time Rapid Rehousing and Dallas County will be voting on it on September 7, 2021 at Commissioners Court.

Commissioner also announced that there will be a Town Hall meeting on the ARP funding at her Road and Bridge office in Garland as well as virtually on August 26, 2021 @ 6pm. A flyer will be emailed to the group.





Project Update: This project has completed its 3-year agreement to funders to provide housing and on-site mental health services for those who are chronically homeless, with co-existing mental health and substance use disorders and with at least two jail book-ins in the past two years and no income. The project has started using the MDHA Housing Priority List as its official waiting list with the following allocations: 33.3% chronically homeless with co-existing mental health and substance use disorders and at least 2 jail book-ins in the past 2 years, no income required; 33.3% chronically homeless, some/limited criminal history, enough income to qualify for PBV per DHA standards; 33.3% chronically homeless, no criminal history, enough income to qualify for Project Based Vouchers per DHA standards. CitySquare staff is currently working on a report that will summarize the impact the Cottages have had on the cost of frequent utilizers to the homeless response system. This report has been delayed by COVID-19. CitySquare plans to have a final report ready in the third quarter of 2021. This report will be sent to the City of Dallas, Dallas County/BHLT and Communities Foundation of Texas.

Our goal starting in January 2021 is to place a minimum of one resident per month until all units are full. The program has 1-2 exits per month (i.e., exit to permanent housing, homelessness, resident deceased). If a resident is incarcerated, hospitalized, etc., we hold the unit up to 90 days.

## **Dallas Frequent User System Enhancement (FUSE) Project**

**Project Summary:** Annually FUSE navigators embedded at the Dallas County Jail, Austin Street Center, Bridge Homeless Recovery Center, Salvation Army and CitySquare Street Outreach will screen 3,000 individuals experiencing homelessness to identify at least 300 frequent users (homeless with mental health and/or substance use disorders plus at 2 jail book-ins in the past two years) and place at least 75 individuals into housing with supportive services.

**Funding:** United Way of Greater Dallas serving as fiscal agent providing \$ 100,000 annually. Additionally, the project received a one-time gift of \$ 300,000 from the Texas Instruments Foundation. Project budget is \$ 244,842 annually. The

remaining funds have been raised by United Way of Greater Dallas. Contracts have been issued by for Years 2 and 3. Funding for Year 2 has been sent to the FUSE partners.

Note: The Dallas FUSE Project has faced many challenges due to the social distancing guidelines in response the COVID 19. FUSE did not officially begin until 7/1/2020. New intakes were limited due to procedures at the Dallas County Jail being affected by COVID-19. Yolanda Williams has been named as the new project director by CitySquare. Inquiries should be sent to her (<a href="mailto:ywilliams@citysquare.org">ywilliams@citysquare.org</a>). FUSE partners reported to United Way of Greater Dallas that \$95,000 in Year 1 funds had not yet been expended and were available to be used for Year 2. UWGD is working on distributing Year 2 funding to all partners. United Way recently raised an additional \$168,000 from the Addy Foundation. This amount plus the unexpended funds from Year 1 are enough the fund the project for Years 2 and 3 and add two navigators, one at Parkland Hospital and one at the Homeward Bound Deflection Center. FUSE leaders are currently working with Parkland and Homeward Bound add these navigators to the Year 2 and 3 budgets. These additional navigators will increase the number of persons enrolled and housed by at least 25% annually.

## A Way Home Housing (City of Dallas - Landlord Subsidized Leasing Program)

For 2020 - 2021 CitySquare was awarded \$ 1.3M in funding from the City of Dallas for a subsidized landlord leasing program. From October 2019 to September 2020 in partnership with Family Gateway and through additional private funding CitySquare placed 75 homeless households into housing in high opportunity neighborhoods. For 2020 – 2021 the goal is to move at least 35 households to self-sufficiency and place 35 new homeless households into housing. Below is the status of this RRH program. The City of Dallas approved \$1.3M in renewal funding for Oct. 1, 2020 – Sep. 30, 2021. COD and CitySquare executed a contract in March 2021. CitySquare started billing the grant for past and present expenses starting in April 2021.

### **Destination Home**

Destination Home is a permanent supportive housing program of CitySquare made possible by a \$ 3,878,337 annual grant from HUD through the Dallas-Irving Continuum of Care. CitySquare must match with \$ 236,000 annually. For the past 5 years an average of 260 individuals, who were chronically homeless, have been served annually. Of those served, an average (since 2012) of 95% annually never return to homeless again.

## **Healthy Community Collaborative**

The Dallas HCC provides emergency services and bridge housing for over 1,000 homeless individuals annually. Three organizations (Austin Street Center, Bridge Homeless Recovery Center and CitySquare) collaborate to provide services for homeless individuals with mental health and/or substance use disorders. Funding is provided by the City of Dallas through a grant from the Department of State Health Services. Of the total amount awarded annually (approximately \$ 1.2M) CitySquare receives \$ 450,000 to provide street outreach, RRH (bridge housing) and supportive services for 40-45 chronically homeless individuals annually. CitySquare must match with \$ 450,000 annually.

### **TRAC Housing**

CitySquare's Transitional Resource Action Center provides 50 units of transitional, rapid rehousing and permanent housing to at least 65 homeless youth (18-24 years of age) annually. Funding is provided through a series of grants from HUD through the Dallas-Irving Continuums of Care totally \$ 440,893. CitySquare must match with \$ 308,625 annually. Over the past five years of those served less than 12% return to homelessness annually.

## Health to Home - Medical Respite for Homeless

In October 2020 CitySquare, in partnership with Texas Health Resources (Texas Health Dallas) and Austin Street Center, launched a 9-bed medical respite plot program for those experiencing homelessness exited from Parkland and Presbyterian- Dallas hospitals. As of April 2021, the three project partners have raised a total of \$ 870,00 for the \$1.2M pilot project (October 1, 2020 – April 30, 2022). Eligible individuals must be homeless adults, able to maintain their daily

needs (ADLs) and have a medical diagnosis that can be treated in the medical respite unit at Austin Street Center. Individuals typically stay in respite care for 30 days before exiting to transitional or permanent supportive housing.

## **COVID-19 Update - CitySquare Emergency Rental Assistance**

CitySquare has received private and public funding for emergence assistance (rent and utility assistance). Our struggle continues to be getting all the required documentation from clients and getting landlords and employers to verify information reported. Since March 2021, as funding started to run out, we focused on helping households we had helped previously. The average amount of rental assistance needed by each household is \$4,000. We currently have the application process closed to get caught up on applications from July and are planning on opening them up again next month. We have still been taking on eviction cases from LAW as they ramp up due to the moratorium ending. # Family Gateway - Access Point Report Aug 2021

Family Gateway is the MDHA-designated Access Point for families with children experiencing or near homelessness for the Continuum of Care. This report contains:


**Call Center Volume** – We operate a 24 x 7 call center for families in crisis to answer the MDHA Homeless Crisis Helpline (1-888-411-6802 - option 3 for families with children). This is staffed by our team from 7 AM – 7 PM, with answering service providing pre-screening and triage to shelter (and activation of crisis team and shelter security for incoming) from 7 PM – 7 AM.

Pre-Screening Results – Every caller/walk-in/website inquirer receives the same pre-screening questions to help us determine the urgency of need so that the appropriate intervention can be matched. Non-urgent callers receive a Resource Packet to connect them to community resources. Those not residing in Dallas or Collin County are directed to 211 for services. Urgent families needing same day care are directed (or brought by Uber at our expense) to the Family Gateway Resource Center for a deeper assessment that includes a Diversion conversation. Diversion in this context means diverting a family from shelter by connecting them to a less intensive and less-expensive intervention, such as landlord mediation for payment plans and removal of late fees for eviction prevention, connection to eviction prevention resources (our own and those of partners), transportation (bus or train) to confirmed placement with extended family willing to take the family in, deposit + short term rental assistance, etc. If a family requires emergency shelter, we triage them to the appropriate family shelter in our community after confirming placement, to include:


- Salvation Army Single mothers with children; no boys over 17; may enter without IDs and birth certificates. This will change in mid-Sept. 2021 in an integrated service model pilot project with Family Gateway, to expand to 80 beds/20 families (currently 12 beds).
- Union Gospel Mission Center of Hope Single mothers with children; no boys over 12; no prior
  history of domestic violence or mental illness; requires IDs for all adults and birth certificates for
  all children (or proof that these have been applied for). Recently re-opened for intake for new
  families with negative COVID-19 test within 48 hours of entry but requiring vaccination and
  proof that any prescribed medications have been taken consistently for 2 weeks prior to entry.
- Dallas Life Single parents or married couples with kids (if marriage can be proven); requires IDs
  for all adults and birth certificates for all children (or proof that these have been applied for),
  immunization records for all children and proof that medications have been taken consistently
  for 2 weeks prior to entry. Closed to new intakes since March 2020. Require vaccine for entry.
- Family Gateway All types of families with children, including unmarried and married couples (opposite or same sex) with children, single parents with children, tri-generational or skipped generation families (such as grandparents raising grandkids), etc. No age restrictions on boys. At least one child needs to be under 18. Exceptions: medically or developmentally dependent children over the age of 18. Will accept pregnant women with no other children if maternity shelter cannot be secured. May enter without IDs and birth certificates.

**Hotel overflow** – When all family shelters are full or when there is a mismatch of family type to an open shelter room, we overflow into a hotel setting.

**Call Center Volume** — Note call suppression while stimulus/extra unemployment and extra 2021 is lower than normal as eviction bans are extended and new stimulus and unemployment trunking is in place; we saw call volume shift in May 2021 as benefits expire and eviction bans lift. Aug 3000+ calls due to announcement of PHA availability of Emergency Housing Vouchers.

As of Sept 20, we have 53 families at the former Candlewood Suites and 35 families at the downtown shelter which we staff with 24 x 7 security and case management from 7 AM – 11 PM. In addition, we currently have 60+ additional families in a second hotel space awaiting entry into our downtown emergency shelter or into the former Candlewood due to the recent surge of need for emergency shelter for families with children. This week, we will work with Salvation Army to open up 20 new shelter rooms for families and will begin migrating some of these overflow families into that space.

In May, after searching for alternative solutions for families in crisis, 32 new families required shelter; in June 60, July 67 and August 66. We are beginning to see the effects of spending down of stimulus money and loss of extra unemployment benefits. Because we are not seeing an increase in families <u>during</u> the eviction process (but only after they are in hotels and cars), we would like to partner with those closer to helping with evictions to see if we can intervene earlier.
