Dr. Daniel opened the meeting and introduced all first-time attendees.

CALL TO ORDER: The minutes were approved without changes.

GOVERNANCE

Dallas Area Partnership to End and Prevent Homelessness:

The Dallas Area Partnership meeting was held September 1, 2022, which was a review of what is in process. There is a large piece of property off I-20 near JJ Lemon that was purchased to build a combination of tiny homes, townhomes, and single-family lease to own. This area consists of both cities of Dallas and Lancaster with schools nearby and a bus route. All other projects are in various stages of development and continue to move forward. We will continue to report on the efforts of their progress to build more affordable housing in Dallas County.

Dallas County Homeless Advisory Committee:

There was discussion in the last meeting on setting up a project for an evaluation to determine what it cost to support homelessness in Dallas County. The evaluation for this project will include but is not limited to jail, housing, service providers, medical care, etc. Reports of this project will be updated as new developments become available.

Federal and State Legislative Update: Janie Metzinger, NTBHA

The report was provided to the group in the meeting packet. Janie Metzinger noted a hearing held with the public health committee on the effects of fentanyl. Some of the testimony in terms of recommendations put forward were for voluntary certification of recovery housing also known as a sober home. This has been mentioned before in previous legislation, so efforts continue to move this proposal forward. There was also another proposal to allow Medicaid reimbursement for peer services, ages 18-21 with a focus on those transitioning out of foster care.

Housing Initiatives: Ikenna Mogbo, Metrocare

Ikenna Mogbo, Metrocare reported no new updates at this time.

RESOURCES

Shelter Discussions: Sarah Masih, Salvation Army

The report will be available at the next meeting. However, there was mention of Austin Street Shelter which has opened a new 300 bed facility that houses 100 women and 200 men. The facility is located across from the old building and is currently full with no beds available at this time.

NTBHA: Eric McCarty

Eric McCarty provided a report that was given by Janie Metzinger, NTBHA. Funding for TANF is available until September 30, 2022; \$1,230,500 has been provided to assist qualified individuals with rental and utility assistance through this contract. COVID funds have been distributed with \$1,305,400 provided and funds will be available through the end of March 2023. TBRA funds for Dallas County have provided \$400,337 with an open contract with \$3,374.66 available. TBRA general has an open contract with \$6.9 million available for Ellis, Hunt, Kaufman, Navarro and Rockwall Counties. Housing funds are available to assist in helping qualified individuals totaling approximately \$2,536,475. Further information can be found on their website: NTBHA.org; click services tab.

Housing Navigator: Kimberly Rawls, Dallas County

The report was provided to the group in the meeting packet. However, Laura Edmonds, Dallas County, highlighted that they are working to fill 3 vacancies at the St. Jude's project on Forest Lane.

Homeless Jail Dashboard: Kimberly Rawls, Dallas County

The report was provided to the group in the meeting packet.

Housing Authority Report: Thomas Lewis, Dallas County HHS

The report was provided to the group in the meeting packet. Mr. Lewis mentioned that of vouchers allocated, there were 83 homeless participants in receipt of lease funds, 8 vouchers open, and 33 searching. Mr. Lewis acknowledged MDHA for case management in assisting with help for client's success in obtaining suitable housing.

CARES Act/ARPA Funds: Hector Faulk, Dallas County

The report was provided to the group in the meeting packet.

PROJECTS AND INDUSTRY UPDATES

Meadows Mental Health Policy Institute: Ron Stretcher

The report will be available at the next meeting.

Coordinated Access System: Sarah Craig, MDHA

Sarah Craig, MDHA, reported the rapid rehousing program, which is focused on chronically unhoused individuals, has been managing with help to provide basic needs for housing. These essentials include moving kits, furniture, wrap around services, and any other support needed to help an individual become more successful with housing. MDHA continues their efforts to bring additional funding into their system that will assist in their plan to reduce homelessness. They are also advocating funding for youth specifically as housing needs aimed at these individuals increase. Additionally, MDHA has started planning with partners for inclement weather in preparation for those unhoused as well as preparing for the PIT count next February.

Pretrial Diversion and Mental Health Screening: Laura Edmonds, Dallas County

Laura Edmonds, Dallas County reported one of their objectives for the next fiscal year is refining data, gathering and reporting. There are no new updates and processes continue to go well.

CitySquare: Madeline Reedy, CitySquare Staff

The report will be available at the next meeting.

Dallas Connector: Daniel Roby, Austin Street

The report will be available at the next meeting.

Homeward Bound: Doug Denton, Homeward Bound

Doug Denton reported the crisis residential unit currently has 18 beds available. The Dallas County Deflection Center has developed a new report of referrals which was provided to the group in the meeting packet. DART Police has started making referrals and training continues with area partners for awareness of direct referrals to the Deflection Center.

Dave Hogan made note of an upcoming training with Balch Springs and Sunnyvale. Mr. Hogan mentioned he received an inquiry from Highland Park highlighting their issues that was confirmed by their Chief of Police. He also received a call from Dallas Assistant Police Chief who wanted to further discuss how they can help with referrals of criminal trespassing.

Family Housing: Ellen Magnis, Family Gateway


Housing Services for Homeless Criminal Justice-Involved Clients (HSH-CJC) Grant



REBRAND TO HOUSING FORWARD

OCTOBER 2022

Metro Dallas Homeless Alliance (MDHA) has completed a total rebrand. MDHA is now known as Housing Forward and our Continuum of Care will no longer be The Homeless Collaborative of Dallas and Collin Counties but will be known as the All Neighbors Coalition.

At the heart of this rebrand was an effort to find a new name to better represent all the people and communities we serve. Removing any reference to a location in our name allows us to better represent every person and community in our service area.

SYSTEM PERFORMANCE METRICS



REHOUSING SYSTEM SUMMARY

We are housing more people than ever. As a system we have housed 35% more people in Q3 of 2022 than in Q3 of 2021. While we are working more efficiently as a system providers feel increased pressure. More low-income households are seeking assistance as rents in the North Texas Region are up significantly.

The solution for increased pressure on the system is diversion. Diversion helps people avoid entering shelters or the homeless response system by resolving their immediate housing crisis through creative housing-focused problem-solving, connection to natural supports or community resources, and at times financial assistance. Diversion is a less expensive alternative to shelter. All Neighbors Coalition is actively working to scale diversion across our system.

RACIAL EQUITY

Black households are overrepresented in the unhoused population due to systemic inequities. Black households are enrolled and housed at higher rates than other groups. Black households comprise 76% of those housed but 54% of the homeless population.

We are working to close the gap on length of time homeless:

- Disparities in housing search time continue, but the gap between Black households and the overall population is narrowing
- Black households are in housing search for 96 days, compared to 94 days for overall population, 87 days for White households



DALLAS R.E.A.L. TIME RAPID REHOUSING

The Dallas R.E.A.L. Time Rapid Rehousing Initiative, or DRTRR, aims to rehouse over 2,700 individuals experiencing homelessness by the end of 2023. Housing Forward is administering and leading the strategy for the DRTRR program. Rapid Rehousing is designed to obtain housing for our neighbors, connect them with needed services, like supportive case management and job training, increase their self-sufficiency and help them stay housed.

As we celebrate the one year mark of Dallas R.E.A.L. Time Rapid Rehousing initiative we are excited to share that we have housed over 1,220 neighbors in our community!



HELP US BRING MORE NEIGHBORS HOME!

We have the ability to bring our unhoused neighbors into homes of their own, but we need additional apartments or housing units that are available to rent. Do you know a landlord or owner of a multi-family complex interested in providing our neighbors with safe, affordable housing units? Benefits designed to encourage landlord participation includes:

- \$1,000 Landlord Bonus to accelerate the lease up process and remove barriers to lease signing
- Neighbors receive robust case management and wrap-around services while landlords enjoy quaranteed rent for a 12-month lease term
- Leaning on professional support staff dedicated to landlords participating in the Landlord Engagement Program to ensure our neighbors and landlords have a successful lease experience.

EFFECTIVELY END VETERAN HOMELESSNESS

- House all chronically homeless Veterans and long stayers
- Continue prioritizing Veterans for all community housing resources
- Prepare for Federal community declaration for ending Veteran homelessness with the United States Interagency Council on Homelessness

SIGNIFICANTLY REDUCE FAMILY & YOUTH HOMELESSNESS

- Define thresholds for reducing homelessness among youth and among families
- Co-design system enhancements to crisis response and rehousing system
- Secure necessary resources to expand services for youth and family populations

Project Overview

Cottages at Hickory Crossing

Project Summary: In 2016 CitySquare and CitySquare Housing entered into agreements with Dallas County Criminal Justice System, Metrocare, CitySquare Housing (formerly Central Dallas Community Development Corporation) and UT Southwestern to provide 50 units of permanent supportive housing with onsite mental health and medical services for individuals referred by the Dallas County Jail Diversion Program. Since opening in the Fall of 2016 the Cottages at Hickory Crossing, has provided housing and intensive supportive services to over 200 high-utilizers of jail, hospital, and emergency services. The total cost of development and construction was \$7.4M. In 2021, after the 3-year initial pilot ended, CitySquare began utilizing the MDHA Housing Priority List as its official waiting list with the following allocations: 33.3% chronically homeless with co-existing mental health and substance use disorders and at least 2 jail book-ins in the past 2 years, no income required; 33.3% chronically homeless, some/limited criminal history, enough income to qualify for PBV per DHA standards; 33.3% chronically homeless, no criminal history, enough income to qualify for Project Based Vouchers per DHA standards.



Community Life at CityWalk@Akard

Project Summary: In 2009 CitySquare Housing acquired a 15-story building at 511 N. Akard Street. Using a combination of low-income housing tax credits, historic tax credits, new market tax credits and private funds CitySquare Housing redeveloped the property to provide 200 units supported through project-based and housing choice vouchers from the Dallas Housing Authority and six market rate apartments. The total cost of redevelopment and renovations for CityWalk@Akard was \$9.5M. The CitySquare Community Life Team uses a Housing-First approach to the individuals and families who live at CityWalk, while simultaneously providing services that meet requirements for the Land Use Restriction Agreement (LURA) contract.

A Way Home Housing

Project Summary: CitySquare was awarded \$ 1.3M by the City of Dallas in 2019 for the A Way Home program (Landlord Subsidized Leasing Program). From January 1 to June 30, 2020 CitySquare, in partnership with Family Gateway, placed 76 households into housing (50 homeless females and 26 families). The City's contract for this program has continued to be successfully renewed. In 2022, CitySquare will work with Family Gateway to take over full provision of this contract and with the Office of Homeless Solutions to mitigate entry barriers.

Destination Home

Project Summary: Destination Home is a permanent supportive housing program of CitySquare made possible by a \$ 3,540,620 annual grant from HUD through the Dallas-Irving Continuum of Care. CitySquare must match with \$ 225,000 annually. For the past 5 years an average of 245 individuals who were chronically homeless have been served annually. Of those served an average of 92% annually never returned to homeless. In 2022, CitySquare will increase our occupancy by 20 beds, which will make a significant difference to ending chronic homelessness.

Dallas Real Time

Project Summary: The Dallas R.E.A.L. Time Rapid Rehousing Initiative, or DRTRR, aims to rehouse over 2,700 individuals experiencing homelessness. CitySquare is one of the providers through the Metro Dallas Homeless Alliance. CitySquare provides Housing Navigation services as well as Case Management through the Emergency Housing Voucher program to eligible recipients.

Homeless Outreach Team

Project Summary: The CitySquare Homeless Outreach team includes funding from a variety of sources, including the Healthy Community Collaborative, Dallas FUSE and Dallas Real-Time Rapid Rehousing Housing Navigators, to act as the Access Point for the unsheltered in our community. This team focuses on those experiencing homelessness living on the streets, in their cars, or in other places that are not habitable. They have been tapped in 2022 to assist the Metro Dallas Homeless Alliance and the City of Dallas Office of Homeless Solutions to coordinate the housing of those impacted by the encampment decommissioning underway, in partnership with several other organizations, including Bridge Homeless Recovery Center, Catholic Charities of Dallas, Metro Relief, and the Stewpot.



TRAC Housing

Project Summary: CitySquare's Transition Resource Action Center provides 50 units of transitional, rapid rehousing and permanent housing to at least 65 homeless youth (18-24 years of age) annually. Funding is provided through a series of grants from HUD through the Dallas-Irving Continuums of Care totally \$ 440,893. CitySquare must match with \$ 308,625 annually. Over the past five years of those served less than 12% return to homelessness annually. Additionally, TRAC provides street outreach and crisis intervention services targeted at youth (18-24 years of age) through a grant from the Office of the Governor Victims of Crime Act funding as well as the City of Dallas Youth Homelessness and Housing Services. TRAC serves all of the Department of Family and Protective Services Region 3, a 19-county service area in North Texas. We have tried to limit the report figures to Dallas County, but there might be some overlap as youth often cross county lines.

Data Report

To streamline the report, the above programs key program indicators were combined to provide a comprehensive overview of CitySquare Supportive Housing Programs. The aim is to allow external stakeholders a glimpse of our impact in housing and homeless services for the Dallas County service area. Data includes:

- # Housed, including placements in other housing programs
- % Housing Stability
- % Positive Exits
- # Outreach Services Provided

Timeframe: 1/1/2022 – 9/30/2022

Important Findings:


- CitySquare housed an additional 59 neighbors experiencing homelessness through our housing options.
- Across our permanent housing solutions, we showed an average of 96.2% housing retention.
- We saw a 44% increase in the number of youth and a 75% increase in the number of adults needing outreach services.
- Our team continues to grieve as we have lost 8 neighbors in the past year, including several who were long-standing participants in our services.
- CitySquare continues to be an active collaborator for the decommissioning ensuring that those in encampments find permanent housing.


