Welcome and Call to Order

Commissioner John Wiley Price called the Behavioral Health Leadership Team (BHLT) meeting to order at 9:30AM, noting that legal notices had been posted, and a quorum of the Commissioners Court was present. Those being Commissioners Price, Dr. Daniel, and Koch; therefore, Commissioner John Wiley Price entertained a motion for opening the meeting.

A motion was made by Commissioner Dr. Theresa Daniel for the opening of the meeting and was then seconded by Commissioner J.J. Koch. The motion was unanimously passed by the committee members accepting the request to open the Behavioral Health Leadership Team meeting.

Commissioner Price announced that the meeting was being recorded and those who continued in attendance were consenting to being recorded.

Review/Approval of Minutes

The minutes of the BHLT meeting held on Thursday, November 11, 2021 were included in the meeting packet. Commissioner Price offered an opportunity for the minutes to be approved. A motion was made by Commissioner Dr. Theresa Daniel for the November 11, 2021 minutes to stand approved as posted and was then seconded by Commissioner J.J. Koch. The minutes stood as submitted.

Introductions

Commissioner Price welcomed everyone to the meeting and asked first-time attendees to introduce themselves. Akua Cosby, new to Dallas County works with the Pre-trial Smart Justice Department. Dr. Phillip Taft represented his mental health practice which runs from Dallas County to San Antonio, with mental health practitioners, forensic psychologist, and counselors.

North Texas Behavioral Health Authority (NTBHA) Update

Presentation: Narcan Training by Tim Jackson, Certified Narcan Trainer and Team Lead with NTBHA Outpatient Screening Assessment and Referral Services.

Carol Lucky provided the NTBHA update stating that about 25,000 adults and about 8,900 children were served during the past month. The COVID 19 support line continues to receive calls, with 104 calls the past four weeks.

Tenant Based Rental Assistance Program

Ms. Lucky stated that the TBRA funded \$1.3 million statewide the first week in November and NTBHA has already claimed \$682 thousand of that amount. They also claimed \$252 thousand of the existing funds.

Dr. Walter Taylor updated that the trainings with Dr. Morrow had been completed for this year and preparations were being made for trainings for the 2022 year.

Dallas County Behavioral Health Housing Workgroup

Commissioner Dr. Daniel provided the update stating that the Dallas County Deflection Centers construction project was progressing at a good pace with expected completion in January 2022. The Parkland contract was approved on Tuesday, and other contracts were being worked on. There were two housing properties being considered for special needs such as quarantining, homelessness, or for other special populations with support services. She further stated that ground had been broken for the housing project at Beckley, which the county is in partnership with. St. Jude's options were continuing at Forest. Park Central had been renovated and was being used for housing the homeless, and a new location was underway. Dr. Daniel believed that their efforts are headed in the right direction.

Presentation: "Dallas R.E.A.L Time Rapid Rehousing"

Presenter: Joli Robinson, President and CEO of Metro Dallas Housing Alliance presented on the current status of the Dallas R.E.A.L. Time Rapid Rehousing program, which is a collaborative model involving multiple governmental entities, continuum of care service providers, American Rescue Plan Act, and philanthropy, providing \$72 million in cash and housing vouchers. This effort has provided rehousing and wrap around services to 2762+ individuals/families over the past two years with other phases in process.

Meadows Mental Health Policy Institute (MMHPI)

Mr. Ron Stretcher provided the update stating that it might be closer to February before the Deflection Center opens. He stated that Dave Hogan has a promising partnership with UNT Dallas for help from Interns. A Housing FUSE Navigator will now be stationed at UNT Dallas. Mr. Stretcher further mentioned that NTBHA had received a grant award for housing that will help at the Deflection Center. He will provide an update presentation in January on the progress of the Deflection Center. The planning for the UT Southwest Hospital had begun and he was hopeful of getting time during future BHLT meetings to give updates on the progress of UTSW.

1115 Waiver Crisis Services Project Update

Laura Edwards, Criminal Justice Department Assistant Director, provided the update. She stated Crisis Service Project is on track with its metrics with December 31, 2021 being the end of the current performance year. She further stated that there had not been any official word as to whether DSRIP would be extended for an additional year. HHSC was still reviewing amendments for final approval but they were moving forward, preparing for the extension. Mrs. Edwards stated that they were continuing to make progress with the 16.22 Code of Criminal Procedure expansion. The Advisory Committee will resume meeting in January 2022 to work on implementation.

Legislative Update

Janie Metzinger, Legislative Coordinator at NTBHA, provided the update, stating that the flow chart of where the legislation was and the summary of some of the bills that were already passed and signed into public law by the President were in the packet. Ms. Metzinger stated that the time period just before Christmas was when a lot of legislation would be passed, so she would be watching and preparing for both NTBHA and BHLT. When the Texas interim charges are available, she will share them with the group.

Funding Opportunities

•The Cottages Update

Charlene Randolph, Director of Dallas County Criminal Justice Department provided the update, stating the month of December started with 38 residents and had 39 as of December 9, 2021. Of the 50 units, there were five units that could not be occupied, leaving six units to fill with eight people on the waiting list. Management at the Cottages continued to work with Dallas Housing Authority for the inspections.

•SAMHSA Residential Treatment Grant Update

Sheena Oriabure with the Criminal Justice Department provided the update, stating the report was on page 74 in the packet. She stated that the grant was in year four and they were working on the programmatic annual report to submit to SAMHSA the year three findings in February or March of 2022. There had been people admitted into treatment already in year four and they were working on doing the continuation report for the fifth year of the grant.

•Community Courts Grant Update-Public Defender's Office (PD)

Chief Lynn Richardson with the Dallas County Public Defender's office provided the update stating that the contract with the City of Dallas, Dallas County, and the Public Defender's Office, for South Dallas Drug Court had been signed.

Restorative Justice Division-District Attorney's Office (RJD)

Julie Turnbull provided the update stating that the stats were on pages 80 and 81.

December 15, 2021 Minutes**

Mission Statement: The Dallas County BH Housing Work Group, with diverse representation, will formulate recommendations on the creation of housing and housing related support services designed to safely divert members of special populations in crisis away from frequent utilization of expensive and sometimes unnecessary inpatient stays, emergency department visits and incarceration.

Success will be measured in placement of consumers in housing and the decreased utilization of higher levels of care (hospitals and emergency care visits) and reduced incarceration in the Dallas County Jail. The Dallas County BH Housing Work Group is committed to a data driven decision-making process with a focus on data supported outcomes.

CALL TO ORDER: The minutes were approved without changes.

GOVERNANCE

Dallas Area Partnership to End and Prevent Homelessness:

Dallas Area Partnership meeting was held November 18, 2021. All activities are in process and efforts continue such as increasing number of units. Also, partnership with Catholic Housing Initiative has St. Jude-Forest staying full at 120 units and St. Jude-Park Central which initially focused on quarantine but once that need was no longer, renovations were made, and rooms are now full at 150-180 units. Additional efforts remain working on other properties that continue modeling after Communities First. Information will be passed along as updates are made available.

Dallas County Homeless Advisory Committee: Erin Moore, Commissioner Daniel's Office

The Dallas County Homeless Advisory Committee was held on November 22, 2021. Dr. Philip Huang Director of Dallas County Health and Human Services discussed general Covid updates as well as Hepatitis A/C and preliminary plans for inclement weather and safety in the shelters.

RESOURCES

Shelter Discussions: Brooke Etie, DHA

While not serving on this committee, Ms. Etie provided information that DHA, Dallas County, and several other housing authorities have been working with MDHA, including the Bridge and other shelters and service providers in issuing the emergency housing vouchers, specifically targeting some of the encampments. There was a landlord leasing event held last week where several people came with vouchers from different housing agencies in which paperwork was expedited allowing many to be housed on the spot, others within a week's period. Processes continue for better coordination.

Dave Hogan with Homeward Bound raised a question about what case management efforts were being made to follow-up on individuals being housed. Ms. Etie answered a combination of funding is being provided from sources to include HUD, the City, and other agencies who are partnering with different community organizations for long-term services through case management once an individual has been placed in housing.

Traswell Livingston with AIDS Services of Dallas commented he is glad to hear funding is being provided for long-term case management services in order to continue the connection as individuals transition from encampment into housing.

Thomas Lewis with Dallas County HHS commented on the importance of compensation for case managers in order for them to continue providing long-term services and the success of the landlord leasing event held.

NTBHA: Eric McCarty

Eric McCarty reported that Tenant Based Rental Assistance (TBRA) began accepting applications on October 25, 2021 with a new line of funding servicing individuals within Dallas County with disabilities. There has been 1.2 million dollars reserved in funding to this date for those households. Currently there are twenty individuals with disabilities and ten of those have been approved. Funding is also in place within Kaufman, Navarro, Rockwall and Ellis County, servicing Waxahachie area where five individuals were approved. The biggest struggle now is finding property owners and landlords who will accept this type of assistance with their contract which is for twenty-four months. There have been 10-15 additional applicants submitted which will probably be approved in the next week or so. They have ninety days upon approval to find a unit and complete inspection. They will usually receive a thirty-day notification if an individual hasn't been leased up because approval expires after ninety days. Although they market their program to the general public, most applicants have come from the mentally impaired providers such as Nexus, APA, and other agencies. Property owner and landlord forms were provided inside the packet.

Housing Navigator: Kimberly Rawls, Dallas County

Kimberly Rawls reported that 12 county beds are occupied at St. Jude Forest Lane and they are working to fill 1 vacancy that just recently became available. The Frequent Users System Enhancement (FUSE) project data is in the packet with full details. Ms. Rawls reported they are continuing to screen individuals into the program and are working on scheduling releases to enter the program. The Dallas Connector Project provided 12 individuals rides through the FUSE program.

Homeless Jail Dashboard: Kimberly Rawls, Dallas County

The data for the homeless jail dashboard is in the packet in full details. Pages one and two reflect the overall jail population bookins. The overall jail bookins decreased by 298 individuals over the past 30 days. The overall homeless population decreased by 23 individuals during the same time period, and, the average length of stay for homeless bookins slightly decreased. The offense categories stayed the same except for decreases to the burglaries, drug and alcohol, evading, robbery, and theft categories and increases to the holds, resist, and other offenses categories.

Housing Authority Report: Thomas Lewis / Brooke Etie

Thomas Lewis, Dallas County Housing Agency reported no further updates at this time.

Laura Edmonds reported that the mental health pretrial process continues to go well. They continue to partner with the community and community services on getting individuals released from jail as quickly as possible.

CitySquare: Madeline Reedy, CitySquare

Ed Eason retirement announced with well wishes. Madeline Reedy will be the contact person at CitySquare effective January 22, 2022. Madeline Reedy reported Mr. Eason will be greatly missed, and she looks forward to working closer with everyone. The CitySquare final quarterly report will be available at next meeting.

Dallas Connector: Daniel Roby, Austin Street

Report will be available at the next meeting.

Homeward Bound: Dave Hogan / Doug Denson, Homeward Bound

Doug Denson reported their crisis residential program has remained full with 18 beds which was reconfigured for 22 beds including isolation for anyone testing positive for Covid. With screening made available in the hospital, they haven't experienced anyone positive for Covid at this time. They have a rescue program in Corsicana-Navarro County partnering with NTBHA and are able to take some individuals from Dallas County and house them there until the next level of services become available. Dave Hogan reported progress with construction for Dallas Deflection Center. Unfortunately, due to labor shortages and supply chain issues, opening date continues to be moved back. However, he is looking to moving forward. Commissioner raised a question of what the new expected opening date is. Mr. Hogan answered March 2022.

Metro Dallas Youth Committee: Mayra Fierro; Metro Dallas Youth Committee

Family Housing: Ellen Magnis, Family Gateway

Report was provided to the group in the meeting packet.

Mattingly Report: Jim Mattingly

Jim Mattingly reported the housing demand continues to outpace new delivery of multi-family housing. Over the last year in the DFW area, there were 26,851 units delivered and 47,354 absorbed. Rental rates have an average increase of 18% in the DFW area over the last twelve months. The top five submarkets where occupancy has increased the most include Central Ft. Worth at 13.7%, Carrollton-South at 13.2%, Southwest Dallas-Oak Cliff-Sunset at 10.7%, North Ft. Worth at 10.6%, Downtown-Cedars-Deep Ellum at 10.4%. Largest rent increases continue to be in the cities north of the region. McKinney-Allen-Fairview at 25.9 %, Lewisville-Coppell at 25.2%, Frisco-The Colony at 25%, West Plano at 24.8%, Los Colinas-Valley Ranch at 22.4%.

There are about 36,000 new units under construction in the top five submarkets. However, over the next four quarters, there will be a decline in the number of apartments entering the leasing phase. The expectation for the fourth quarter of this year is that fewer than 9,000 apartments will become available for lease and the first quarter of next year dropping with fewer than 7,000 apartments, and the next two quarters dropping with fewer than 4,000 apartments showing a strong continuous demand.

Updates

Sandy Rollins spoke to the number of increased calls received for the eviction prevention program. People continue to be priced out of the market causing a huge concern.

Traswell Livingston with AIDS Services of Dallas announced they are excited to have begun developing brand new affordable housing units in the Bishop Arts area with hopes of construction being completed by October 2022.

Commissioner Daniels thanked everyone for attending both in-person and virtual. The meeting was adjourned.

HOUSE BILLS

[HR 1319](#)—Yarmuth (D-KY)—American Rescue Plan.

Title II, Subtitle H—Mental Health and Substance Use Disorder authorizes:

- \$1.5 billion for block grants for community mental health services.
- \$1.5 billion for block grants for prevention and treatment of substance use disorder.
- \$80 million for behavioral health training for health care professionals, para-professionals and public safety officers.
- \$20 million for an education and awareness campaign on healthy working conditions and use of mental health and substance use disorder (SUD) services by health care professionals.
- \$40 million for grants to health care providers to promote mental health among the professional workforce, with special provisions for rural and underserved communities.
- \$30 million for community-based SUD services.
- \$50 million to address local behavioral health needs worsened by the COVID-19 public health emergency.
- \$10 million for the National Child Traumatic Stress Network.
- \$30 million for Project Aware to advance wellness and resiliency in education.
- \$20 million for youth suicide prevention.
- \$100 million for behavioral health workforce education and training.
- \$80 million for pediatric mental health care access.
- \$420 million for expansion grants for Certified Community Behavioral Health Clinics (CCBHCs).

Title III, Subtitle B—Housing Provisions

- \$21.55 billion for emergency rental assistance through September 30, 2027.
- \$30 million for administration and technical assistance.
- \$3 million for oversight by the Inspector General.
- \$2.5 billion to high-need grantees.
- \$100 million for rural housing emergency assistance.
- \$100 million for housing counseling.
- \$5 billion for homeless assistance and supportive services programs including Tenant-Based Rental Assistance (TBRA).
- \$ 50 million for the HOME program.
- \$9.9 billion for Homeowner Assistance Fund.

Title IX, Subtitle J—Medicaid Provisions

- Extends Medicaid coverage for pregnant and postpartum women for twelve months after the pregnancy ends.
- \$15 million for planning grants for community-based mobile crisis intervention services.
- Temporary increase in FMAP in certain circumstances.
- Additional support for Medicaid Home and Community-based Services (HCBS).

Became Public Law 117-7.

[HR 1448](#)-Stivers (R-OH) PAWS for Veteran Therapy Act. Companion: S 613-Tillis (R-NC). Establishes a pilot program for dog training therapy and to provide service dogs to veterans with mental illness as a complementary and integrative health program.

- Pilot program must begin by early March, 2022 and is authorized for five years.
- Must be carried out in at least five VA Medical Centers.
- Contracted nongovernmental entities must be accredited service dog training agencies, instructors and supervisors.
- Training must address or alleviate symptoms of PTSD.
- Must allow the veteran to adopt the dog that the veteran trained in the pilot program if health care provider certifies it is in the best interest of the veteran.
- Veteran must be provided with follow-up veteran training support for the life of the dog.
- VA must provide additional medical and treatment for PTSD.
- VA must develop metrics related to the number of veterans participating, veteran satisfaction, health benefits, health improvements and other measures.
- Requires report within one year after the end of the pilot advising Congress on extending or the pilot permanent, and the feasibility of addressing additional mental health conditions.
- Provides commercially available veterinary insurance for each dog.

Became Public Law 117-37.

[HR 1899](#)-Griffith (R-VA) Ensuring Compliance Against Drug Diversion Act. Companion: S 1286-Cornyn (R-TX). Amends Controlled Substances Act.

- Specifies conditions that terminate a registration to manufacture, distribute, or dispense controlled substances or List I chemicals when the registrant dies, ceases legal existence, discontinues business or professional practice, or surrenders the registration.
- Requires prompt notification of Attorney General.

Became Public Law 117-53.

[HR 2441](#)-Axne (D-IA). Sergeant Ketcham Rural Veterans Mental Health Act.

- Appropriates \$1.2 million per fiscal year for FY 2022-24 to establish three new centers for the Veteran Administration's (VA's) Rural Access Network for Growth Enhancement (RANGE) Program.
- Authorizes General Accounting Office (GAO) to assess access to mental health care by rural veterans. Report due December 2022.

Became Public Law 117-21.

[HR 2630](#)-Pappas (D-NH). Extending Temporary Emergency Scheduling of Fentanyl Analogues Act. Extends the Temporary Reauthorization and Study of the Emergency Scheduling of Fentanyl Analogues Act passed by the 116th Congress (PL 116-114) from May 6, 2021 to October 22, 2021. Became Public Law 117-12.

[HR 3684](#)-DeFazio (D-OR). Infrastructure, Investment and Jobs Act.

- Division F, Title I provides grants for broadband deployment.
- Division F, Title IV provides for middle mile broadband infrastructure.
- Division F, Title V relates to broadband affordability.
- Division F, Title IX, Subtitle C requires long-term contracts for domestically manufactured personal protective equipment (PPE) to be no shorter than three years in duration.

Became Public Law 117-58.

[HR 5305](#)-DeLauro (D-CT). Extending Government Funding and Delivering Emergency Assistance Act. Division D, Title I, Section 3104 extended temporary orders regarding fentanyl analogues in HR 2630 (PL 117-12) to January 28, 2022. Became Public Law 117-43.

[HR 6119](#)-DeLauro (D-CT). Further Extending Government Funding Act. Division C, Title I, Section 2103 extended temporary orders regarding fentanyl analogues in HR 5305 (PL 117-43) to February 18, 2022. Became Public Law 117-70.

SENATE BILLS

[S 796](#)-Duckworth (D-IL) Protecting Moms Who Serve Act. Companion: HR 958-Underwood.

- Establishes maternity care coordination programs for pregnant and postpartum veterans, including services for mental and behavioral health.
- Appropriates \$15 million for FY 2022. Requires report after two years.

Became Public Law 117-69.

[S 1502](#)-Cortez-Masto (D-NV). COPS Counseling Act. Companion: HR 3070-Trone (D-MD).

- Provides for confidential peer support for federal law enforcement officers.
- Defines peer support specialist as a law enforcement officer who has received training in peer support counseling, emotional and moral support for officers who have been involved in emotionally traumatic experiences in the course of employment.
- Requires that the Attorney General and Health and Human Services to collaborate on a report on best practices and professional standards for peer support counseling programs for first responder agencies.
- “It is the sense of Congress that Federal, State, local and Tribal police officers, sheriffs and other law enforcement officers across the United States who serve with valor, dignity and integrity deserve the gratitude and respect of Congress.”

Became Public Law 117-60.

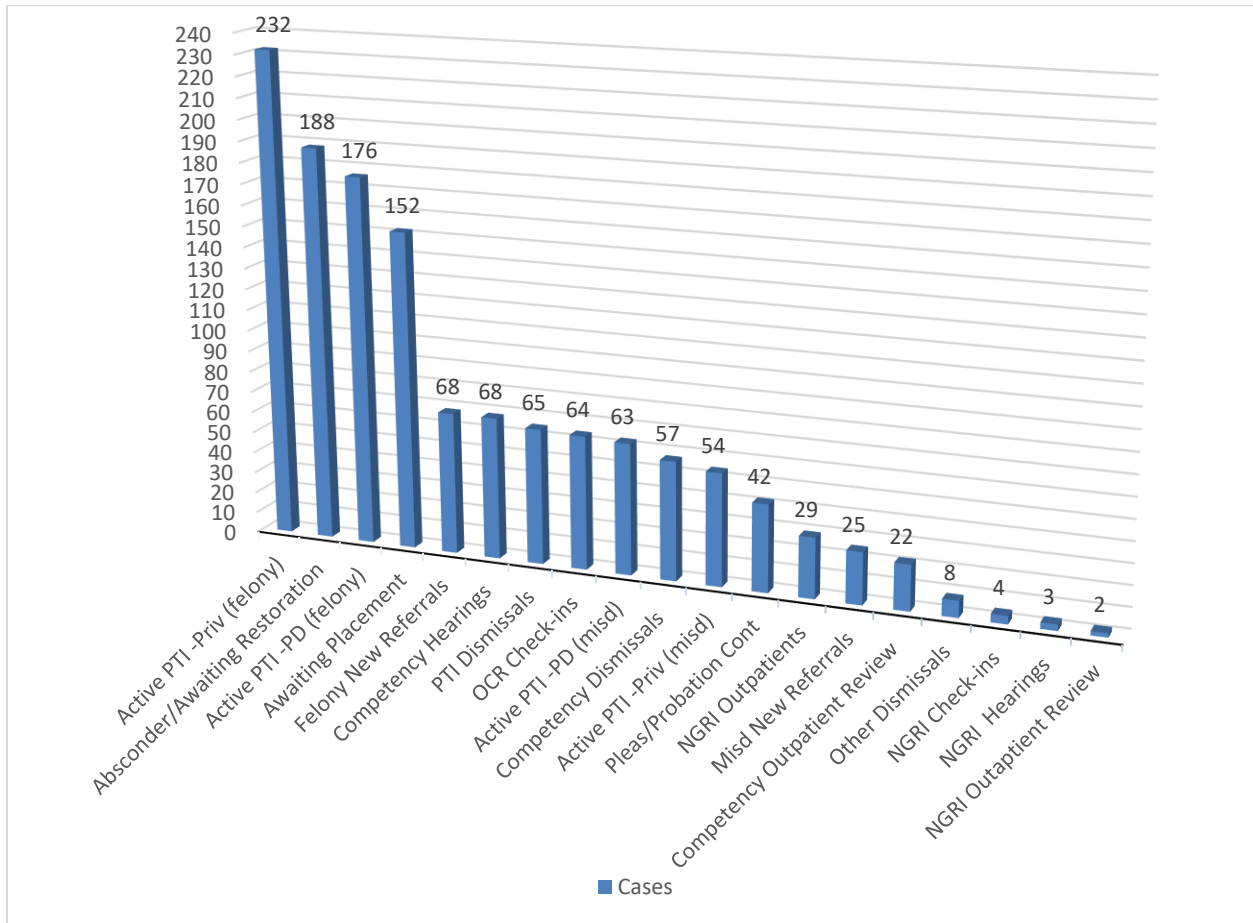

Overall Summary:

- APAA is a leading peer driven recovery community support program that encourages and supports personal recovery by offering peer to peer support assistance with resources that support recovery, reduce relapse, and promote high level wellness in individuals, their families and community. This program is by and for the recovery community.
- APAA's mission is to spread recovery. APAA will educate all segments of the community about the nature of addiction/mental health recovery, and provide recovery support services to individual, families and the recovery community.
- APAA is an independent, nonprofit organization led and governed by representatives of local communities of recovery that does any, one, or combination of the following activities:
 - Organize recovery focused policy and advocacy activities
 - Increase recovery workforce capacity and expertise through trainings and education and collaboration
 - Carry out recovery-focused outreach programs to engage people seeking recovery, in recovery or in need of recovery –focused support services or events to educate and raise public awareness
 - Provide peer recovery support services (PRSS)
 - When someone with lived experiences gives encouragement and assistance to help/support someone with a mental health conditions or a substance use disorder to achieve health, wellness and long-term recovery.
 - Inspire HOPE
 - Honors and celebrates all Paths of Recovery

- Listens and do not offer advice
 - Share their stories/experience, strength and hope
 - Connect to resources, learning, and training opportunities
 - Educate about the effects of Trauma informed care
 - Facilitate movement toward my goals
- Support the development of recovery support intuitions (e.g., collegiate recovery programs, recovery community centers, recovery cafes, recovery ministries, recovery- focused employment programs, recovery- focused prison reentry programs, etc.)
- Host local, regional, or national recovery celebration events
- Collaborate on the integration of recovery –focused activities within local prevention, harm reduction, early intervention, and treatment initiatives.
- Meadows Mental Health Policy Institute (MMPHI) used MCO supplied data to estimate the effectiveness of peer support services in reducing inpatient hospitalizations
 - Data tracked 1103 individuals receiving APAA peer-support services between October 2015- January 2016
 - Inpatient hospitalizations were tracked for this group during a three- month period before and three-month period after receipt of services
 - The analysis performed simple before and after tests to measure the change in inpatient hospitalizations admissions, and the change in inpatient day before and after the receipt of services
 - Each client experienced an average of 1.5 fewer inpatient hospitalizations after receipt of services, as compared to an equivalent period prior to receipt of services.
 - There were 1948 total inpatient hospitalization admission during the three month pre services period.
 - There were 698 total inpatient hospitalization admission during the during three month post service period.
- Emerging research indicates that peer recovery coaching holds promise for supporting recovery from substance use disorders. Taken as a whole, the current body of research suggests that people receiving peer recovery support experience:
 - Decreased criminal justice involvement
 - Decreased emergency services utilizations
 - Reduced relapse rates
 - Reduced re-hospitalization rates
 - Reduced substances use
 - Decreased costs to hospitals and mental health systems
 - Increased sense of hope and inspiration
 - Increased empathy and acceptance
 - Increased engagements in self-care and wellness
 - Increased social support and social functioning
