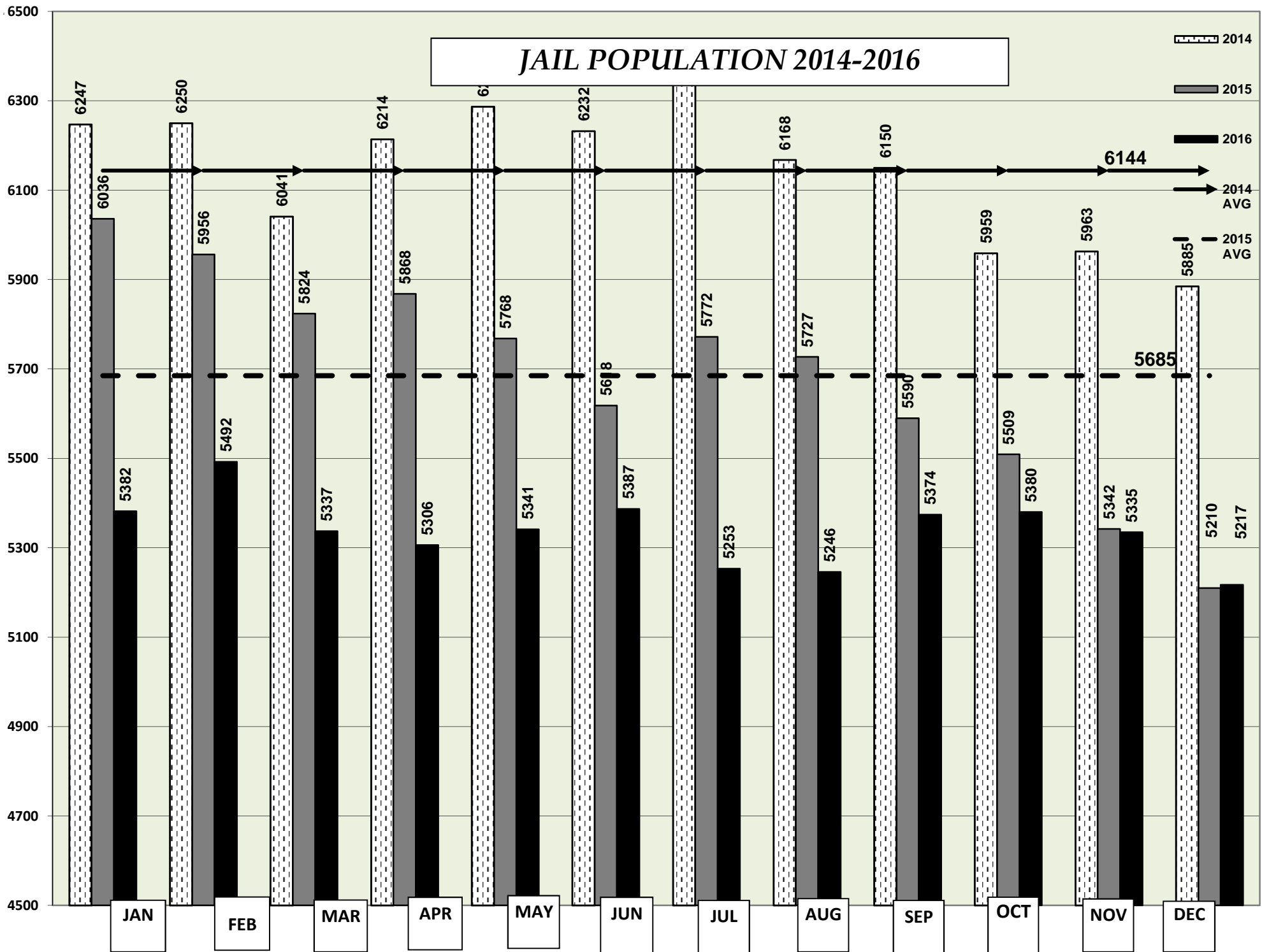

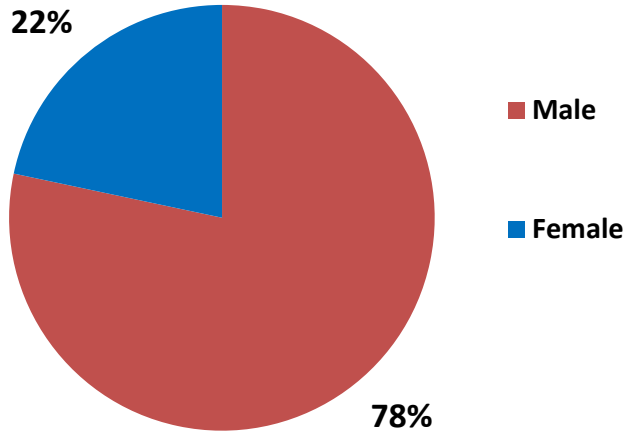

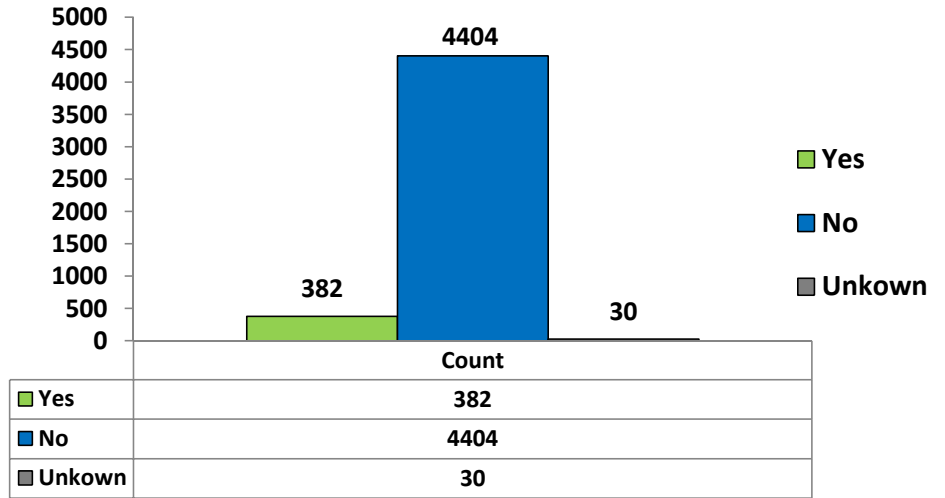


DECEMBER 2016 BOOK-INS SNAPSHOT

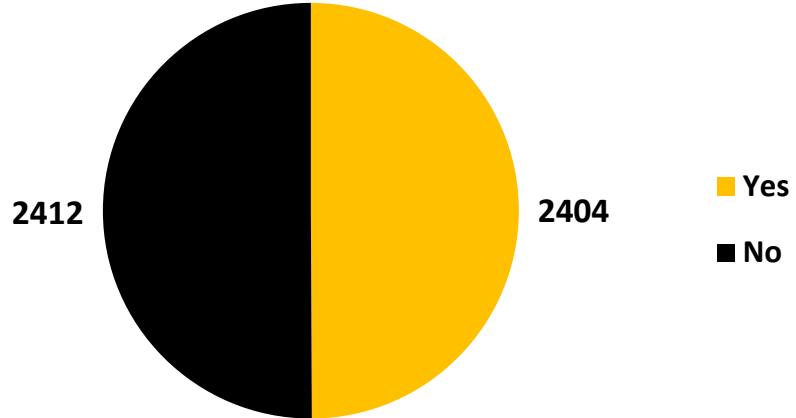
December 2016 BookIn Gender

December 2016 BookIn MH Flagged

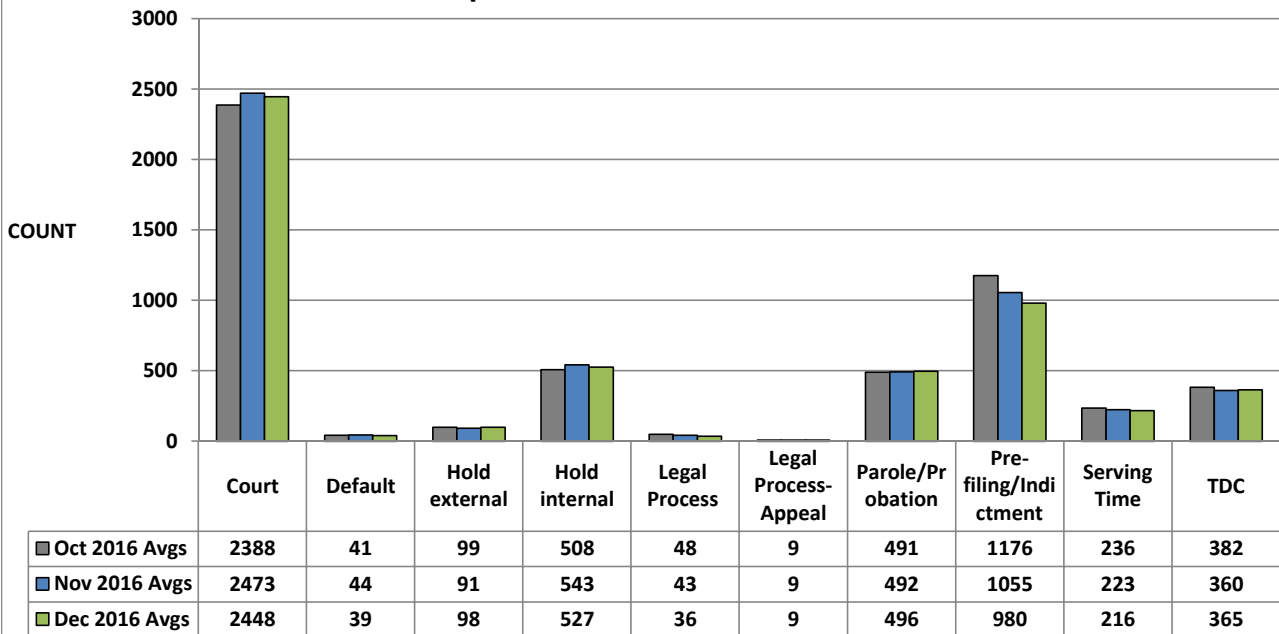

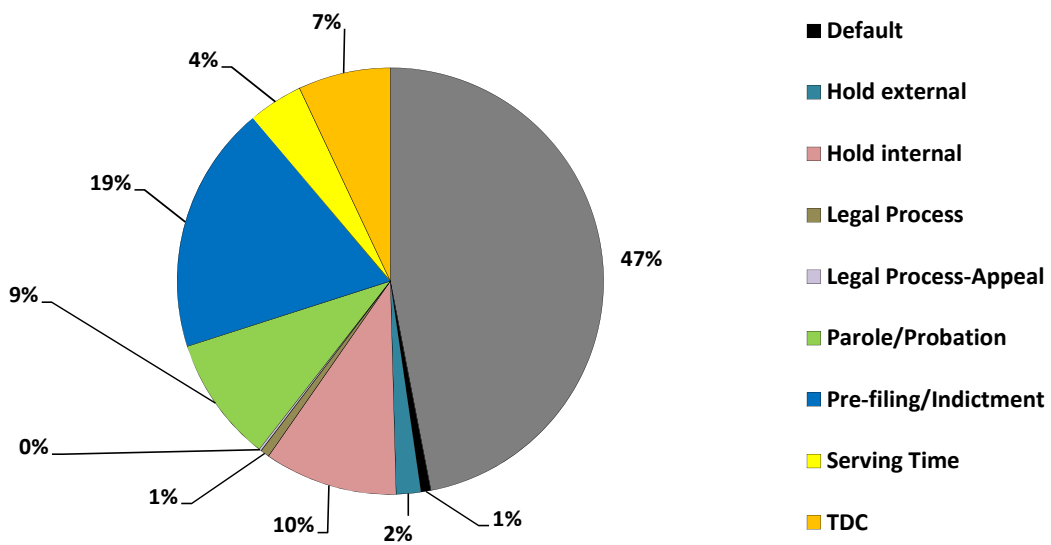

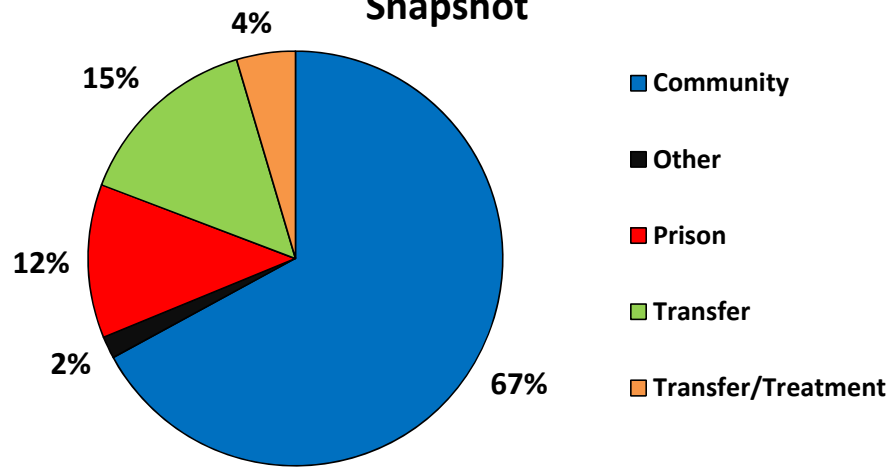

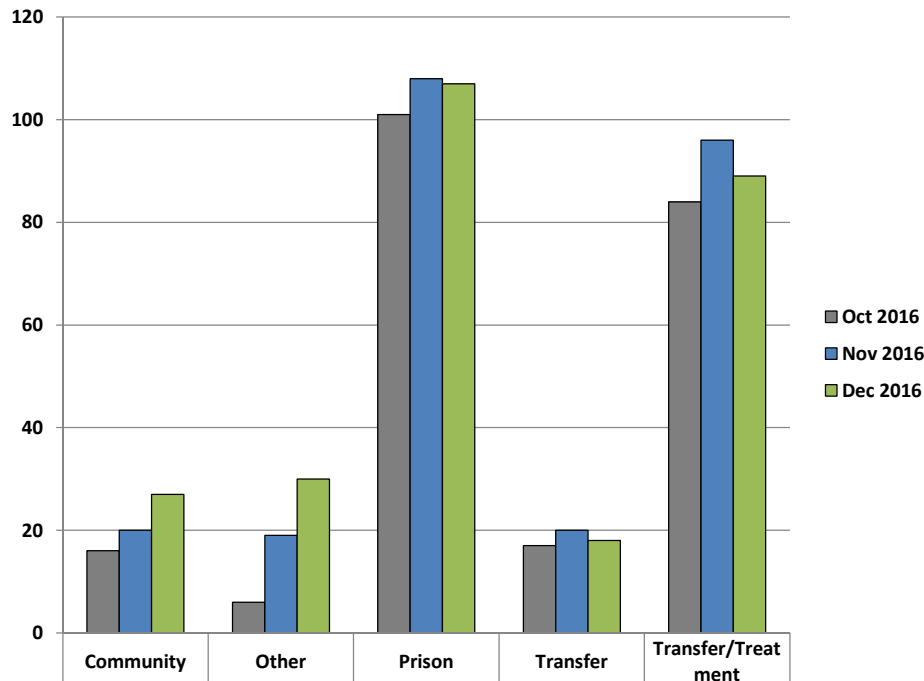
