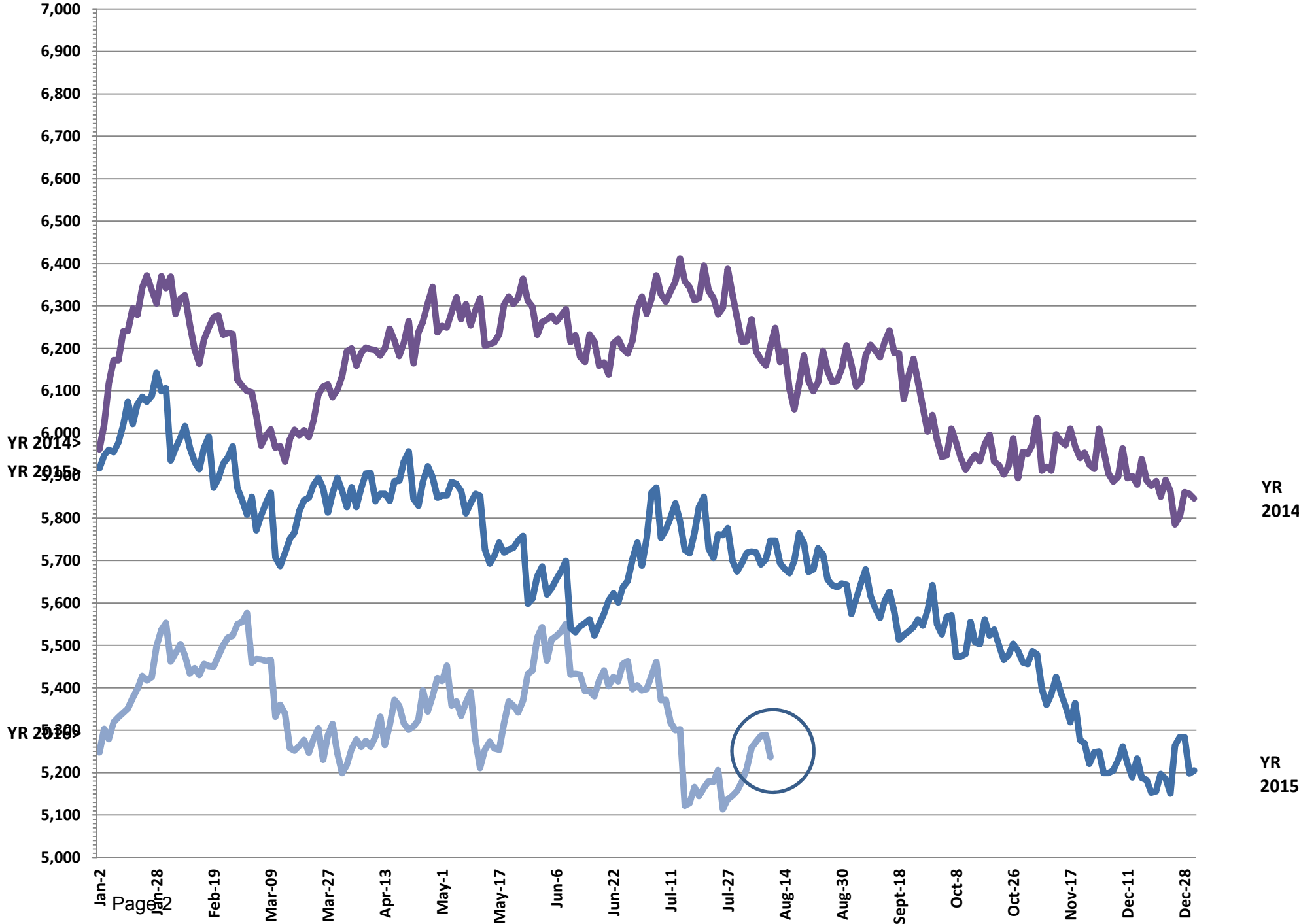

Dallas County Jail Population 2014 - 2016



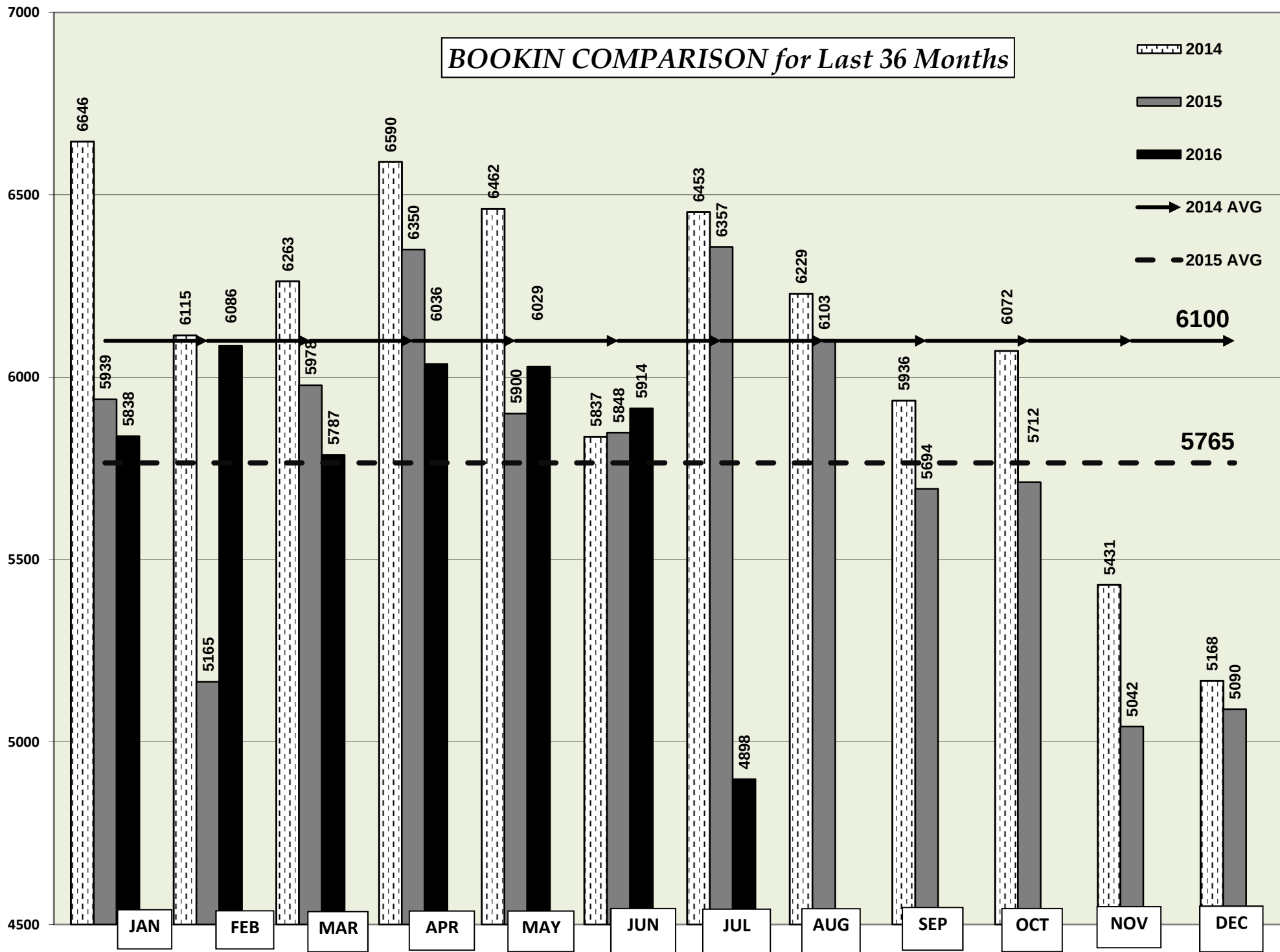

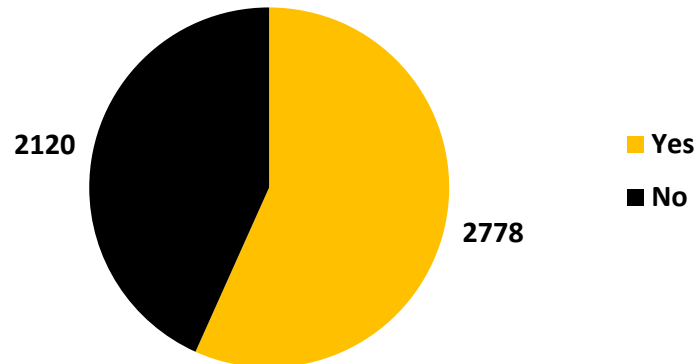
July 2016 BookIn Gender



July 2016 BookIn Homelessness



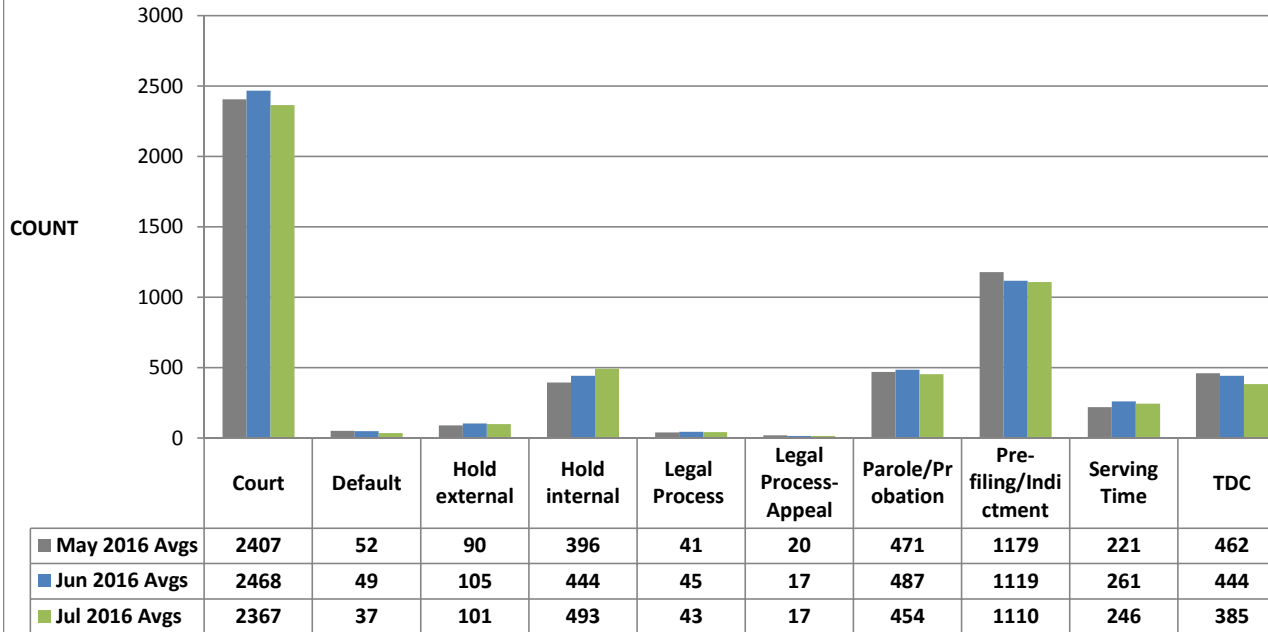

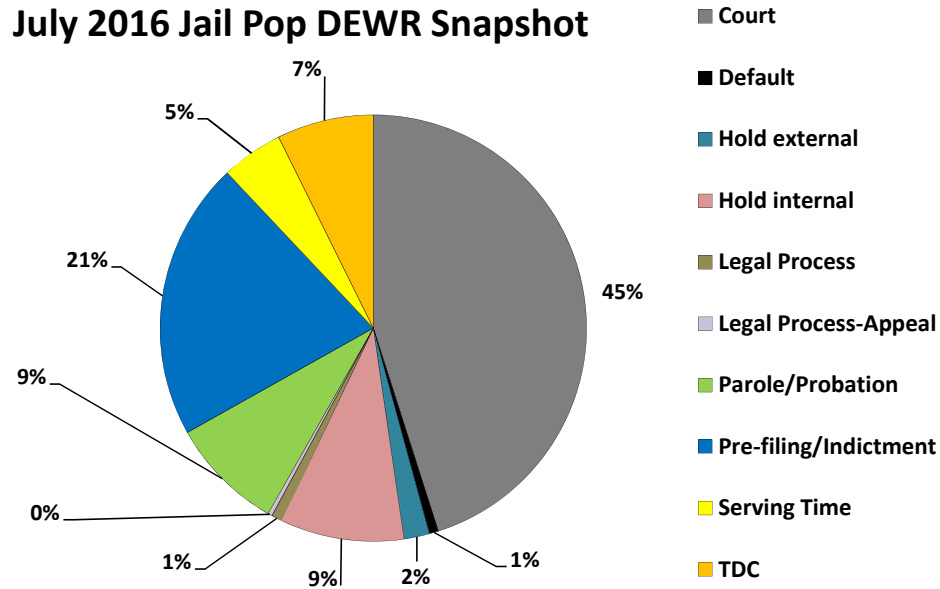

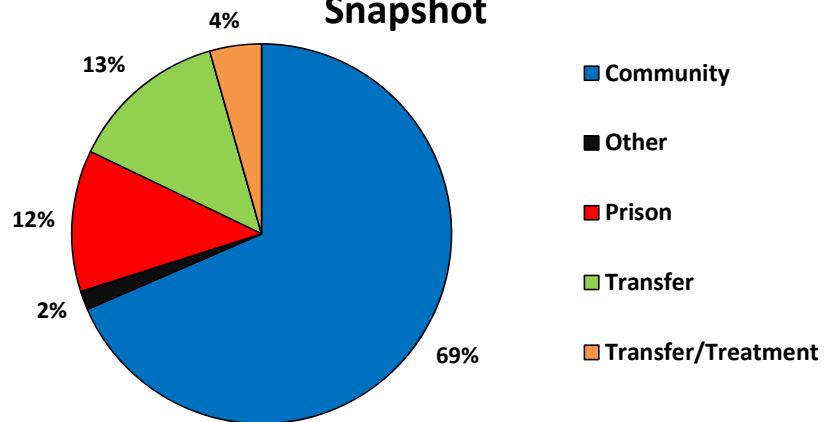

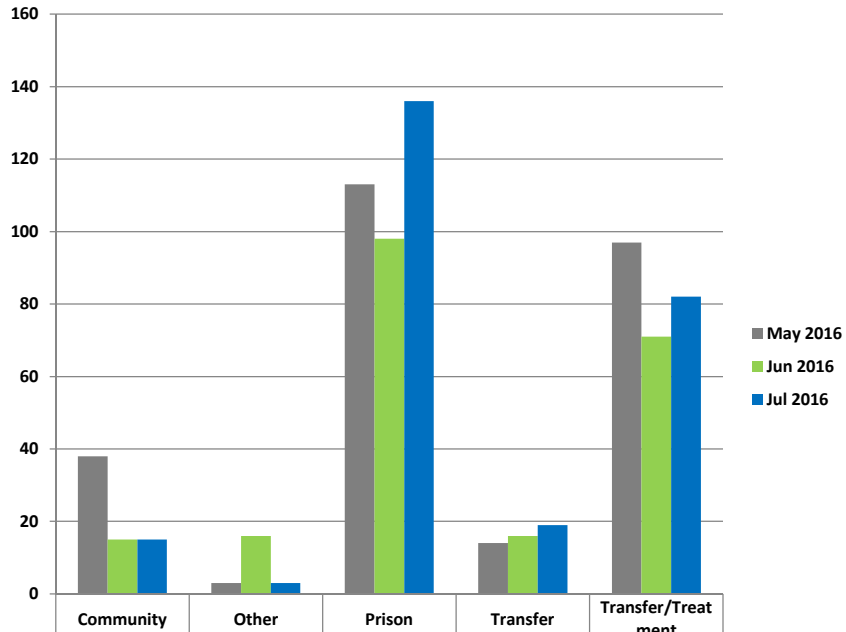
